**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Phil Long Dealerships, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Phil Long Dealerships, Inc., T-Dad Toad LLC, Trinidad Commercial Construction LLC, Trinidad Hotel Management LLC DBA Hilton Garden Inn Trinidad Downtown, Kip Hampden LLLP, MT Carmel Health Wellness Community Center, and MT Carmel Veterans Service Center who have completed three months of service and are age 18 or older. Individuals that are classified by the Plan as independent contractors, seasonal employees, nonresident aliens, and those that are members of a collective bargaining unit whose union contract does not provide for participation are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

A participant shall not have the right to receive benefits until termination of service, attainment of normal retirement age, meeting the requirements for a hardship distribution, disability, or death. A participant is eligible for normal retirement when the participant reaches age 65.

Contributions: Participants can contribute 1% to a maximum of 100% in 1% increments of their gross wages during the Plan year subject to certain limitations. Roth contributions are allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees, upon meeting eligibility requirements, are automatically enrolled at a deferral rate of 5% unless they elect to change this amount or decline entry electronically via the member services line or the member website. All participants who had an automatic deferral or whose deferral is greater than 1% or less than 10% will be subject to an automatic increase of 1% each year until they reach 10% unless they elect to change this amount. The Company may make discretionary employer matching contributions equal to a specified percentage of a participant's deferral. The Company may also make profit-sharing contributions at the discretion of the Board of Directors. To be eligible for the Company discretionary contributions, participants must be employed on the last day of the Plan year; however, this eligibility requirement is waived for employer matching contributions made during the Plan year. The Company made a \$700,644 discretionary contribution to the Plan in 2024, which was allocated based on a percentage of deferrals for those who qualified. There was no profit-sharing contribution in 2024.

Retirement, Death, Disability: A participant is entitled to 100% of his or her vested account balance upon retirement, death, or disability.

Payment of Benefits: Upon termination of service, a participant may elect to receive either a lump-sum, installments or direct rollover amount equal to the vested account balance. Active participants may also take distributions from the Plan upon attainment of age 59½. If the participant's vested account balance is \$5,000 or less, the benefit will be paid in a lump-sum payment. Distributions of a participant's vested account balance of less than \$5,000, but in excess of \$1,000, will be deposited into an Individual Retirement Account ("IRA") for the participant's benefit.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, and (b) Plan earnings, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Forfeitures: The non-vested portions of terminated participants' accounts are forfeitures. Forfeitures stay under the Plan and are used to offset future employer contributions and plan expenses. During 2024, forfeited balances were used to reduce employer contributions and were used to pay plan expenses totaling \$30,403. The remaining balance of forfeitures available to offset future matching contributions and administrative expenses as of December 31, 2024 and 2023 was \$137,670 and \$113,133, respectively.

Vesting: Under the Plan, participants acquire a vested and nonforfeitable interest in a percentage of their account attributable to the Company's contributions and actual earnings thereon as determined from the following table. Participants are vested 100% in their contributions and actual earnings thereon at all times.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks, as well as risks associated with global events such as the ongoing Coronavirus pandemic. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trust Fund:* The fair values of participation units held in the stable value collective trust fund are based on the net asset value as reported by the fund manager. The fund provides for daily redemptions by the Plan at reported net asset values per share, provided that redemptions by participating plans comply with the required one-year notice provision.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service has issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The plan has been amended since receiving the latest opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. The Plan holds mutual funds with and pays recordkeeping fees to Fidelity Investments Institutional, an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company, as Plan trustee, qualifies as a party-in-interest. Crowe LLP provided auditing services to the Plan, Morgan Stanley Smith Barney LLC and Strategic Advisors, Inc. provide advisory services to the Plan, therefore, these qualify as parties-in-interest. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.
