Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Kenect Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following brief description of the Kenect (the “Company”) Retirement Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan. All employees who have attained the age of 18 and have completed one month of service are eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Management is responsible for oversight of the Plan.

Contributions. Each year, participants may contribute per-tax up to 100% of annual compensation, as defined by the Plan. Participants may elect to change their deferral amount at any time. The Company may, at its sole discretion, make a matching contribution, a profit-sharing contribution, or both, to the Plan. Participants in the Plan must have been employed on the last day of the Plan year and have worked at least 1,000 hours in that year to be eligible to receive a profit-sharing contribution. During 2024, the Company did not match any employee contributions nor did the Company elect to make any profit-sharing contribution. All contributions are subject to certain IRS limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of Plan earnings and charged with an allocation of administrative expenses related to recordkeeping. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are fully vested at all times in their own contributions and actual earnings thereon. Company contributions and earnings thereon are subject to a graded vesting schedule based on years of service and are fully vested after six years of service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at a rate of interest equal to 1% above the prime rate. All loans are secured by the participant’s account and, regardless of term, become due and payable upon termination of the participant’s employment.

Payments of Benefits. Distributions and withdrawals are generally payable upon termination, financial hardship, total disability, death, or the attainment of the normal retirement age of 65. Distributions are allowed in partial withdrawals or made in a lump-sum payment. Participants are eligible to begin receiving distributions of all vested account balances when reaching 59½ years of age.

1. Description of Plan (continued)

For the years ended December 31, 2024 and 2023 the Plan reported \$707,766 and \$516,968, respectively, of plan assets that were allocated to participants that had withdrawn from the Plan, but for which disbursement of funds from the Plan had not yet been made.

Forfeitures Accounts. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$10,656 and \$5,788, respectively. These accounts will be used to reduce future employer contributions. During 2024, no forfeited non-vested accounts were used to offset Plan expenses nor to offset Company matching contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, consistent with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are netted against investment income.

Subsequent events

The Plan has evaluated subsequent events through September 1, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Transamerica Life Insurance Company, Inc. ("TLIC") certifies that the information furnished to the plan administrator pursuant to 29 CFR 2520.103-5(c) of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure, including the information provided on the Annual Report, any Schedules thereto, the Employer Plan Statement with respect to its general asset account and assets of the plan held by Transamerica Life Insurance Company in any separate account, as applicable, is complete and accurate to the best of its knowledge and belief for the Plan years ending December 31, 2024 and 2023. Transamerica Retirement Solutions is an authorized agent for such purposes.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

5. Investments at Contract Value

At December 31, 2024, investment options in the Plan included the Transamerica Stable Value Core Option, which is a deposit liability of Transamerica with no underlying assets. The assets as listed are based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica’s insurance ratings. FASB indicates the assets are fairly valued at contract value. This type of investment is considered a deposit liability with no defined maturity and in accordance with FAS 107 and SP 94-4-1, the contract value listed by Transamerica is also the fair market value as of the measurement date. Since contract value is fair value, the average yield earned by the Stable Value Fund is equal to the average yield earned, adjusted to reflect the actual interest rate credited to plan participants.

At December 31, 2024 and 2023, the average annual yields were 1.65% and 1.25%, respectively. At December 31, 2024 and 2023, the average annual yields adjusted to reflect the actual interest rate credited to plan participants were 1.58% and 1.17%, respectively.

6. Party-in-Interest Transactions

Certain plan investments are shares of funds managed by Transamerica Life Insurance Company, the Plan Trustee; therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

In an opinion letter dated June 30, 2020, the Internal Revenue Service ruled that the Plan Volume Submitter Document qualifies under Section 401(k) of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor ("DOL"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risks, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
