### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AOI Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**Other Matter – Supplementary Information Required by ERISA**

The supplementary information as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplementary information, other than the information in the supplementary information that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplementary information related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### 1. Plan Description

---

The following brief description of the AOI Corporation 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of AOI Corporation (the Company).

Employees are eligible to make pre-tax and designated after-tax Roth salary deferral contributions after attaining age 18 and completing two consecutive months of service during which time the employee completes at least 250 hours of service. Eligible employees may become participants on the first day of the month coinciding with or next following the date requirements are satisfied. Participants are eligible to receive discretionary matching contributions when they become eligible to participate in the Plan. Employees are also eligible for discretionary profit-sharing contributions if they were employed on the last day of the Plan year and have worked at least 250 hours during the Plan year.

#### *Contributions*

Participants may make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 100% of their eligible annual compensation as defined by the Plan, up to the maximum dollar limits allowable by law. Employees are automatically enrolled in the Plan with an initial pre-tax salary deferral of 3% of eligible compensation, which is increased by one percentage point at the beginning of each Plan year, until it reaches a total of 6% of their eligible compensation. At any time, a participant may elect not to contribute or may change their deferral rate as allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make discretionary matching contributions and discretionary profit-sharing contributions. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of a) the Company's discretionary matching contributions, b) the Company's discretionary profit-sharing contributions and c) Plan earnings and losses. The Company's discretionary matching contributions are allocated among participants based upon participants' elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Effective July 1, 2024, investments are maintained in individual member accounts managed by Matrix Trust Company (Matrix). Prior to July 1, 2024, investments were maintained in individual member accounts managed by United of Omaha Life Insurance Company (United of Omaha).

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and the Company's discretionary profit-sharing contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until participant is 100% vested after six years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are issued on a non-discriminatory basis and are secured by the participant's account. Interest rates are established at current market rates at the time of issuance. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive lump sum or partial payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may also receive in-service and hardship distributions, as defined by the Plan document. Benefits are recorded when paid.

### ***Deposits with Insurance Company***

The guaranteed interest accounts, which were part of the investment contract with United of Omaha through July 1, 2024, credited interest daily. The crediting interest rates for the contracts during the six month period ended July 1, 2024 and the year ended December 31, 2023 ranged from 0.12% to 4.75%. The crediting interest rates were reset upon the maturity of the contracts.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company's contributions not then vested shall be forfeited. Forfeitures may be used to reduce future Company discretionary matching contributions and Company discretionary profit-sharing contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2 and \$4,237, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$16,481 and \$27,532, respectively, were used to reduce Company contributions.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments, except for fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 4 for further discussion on fair value measurements.

Fully benefit-responsive investment contracts (the Plan no longer holds as of July 1, 2024) were reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invested in investment contracts through guaranteed interest accounts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Other***

Certain Plan expenses are paid by the Company and excluded from these financial statements. Fees related to the administration of payment of benefits and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 9, 2025, noting no items requiring disclosure.

### **3. Information Certified by Matrix and United of Omaha**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Matrix and United of Omaha, the custodians of the Plan, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund, Funds held by the Plan are open-end funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Collective trust funds are valued at NAV based on the market value of their underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trust funds meet those requirements. Participants can redeem the trust funds at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. The NAV is the basis for current transactions and the trust funds can be redeemed at NAV as of the measurement date.

*Pooled Separate Accounts:* Pooled separate accounts are valued at NAV based on the market value of their underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. The NAV is the basis for current transactions and the accounts can be redeemed at NAV as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Investment Contract with Insurance Company

---

The Plan had entered into an investment contract with United of Omaha (through July 1, 2024), which maintained contributions in pooled separate accounts and guaranteed interest accounts. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by United of Omaha.

The pooled separate accounts, as reported to the Plan by United of Omaha, were included in the financial statements at fair value (which represented contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

As the guaranteed interest accounts were fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest accounts. Contract value, as reported to the Plan by United of Omaha, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

### 8. Related-Party Transactions

---

Certain Plan investments as of December 31, 2023 include guaranteed interest accounts managed by United of Omaha. United of Omaha is the former custodian of the Plan and therefore these transactions qualify as party-in-interest transactions.

### 9. Custodian Change

---

Effective July 1, 2024, Matrix was appointed as the new custodian of the Plan. Plan assets transferred to Matrix were transferred into funds comparable, where available, to those offered by United of Omaha. The conversion initiated a "blackout" period beginning June 27, 2024 and continued through July 1, 2024. During this period, funds could not be applied to the employee selected funds with Matrix or withdrawn from the Plan until Matrix had time to accurately complete the conversion. During the period, employee contributions continued to be made through payroll deductions, and the contributions were wired to Matrix and held in a trust account until the completion of the blackout period, at which time these funds were invested in funds comparable to those offered by United of Omaha.
