### **Report on the Financial Statements**

We have audited the accompanying financial statements of BINKLEY & BARFIELD, INC. PROFIT SHARING PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – liquidation basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – liquidation basis for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the statements of net assets available for benefits – liquidation basis of BINKLEY & BARFIELD, INC. As discussed in Note 1 to the financial statements, the governing body of BINKLEY & BARFIELD, INC. PROFIT SHARING PLAN approved a plan of liquidation on August 6, 2021, and management determined liquidation is imminent. As result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis. Our opinion is not modified with respect to that matter.

### **Management's Responsibility for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibility**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of BINKLEY & BARFIELD, INC. PROFIT SHARING PLAN's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental information as identified in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

General

The Binkley & Barfield, Inc. Profit Sharing Plan (the "Plan"), formerly the Binkley & Barfield, Inc. Employee Stock Ownership Plan was established January 1, 2010 and operates as a defined contribution plan covering all eligible employees of Binkley & Barfield, Inc. (the "Company", or "Plan Sponsor"). The Plan operated as an employee stock ownership plan ("ESOP"), designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As a result of the termination of the ESOP described below, the Plan converted to a profit sharing plan under Code Section 401(a) of ERISA on August 6, 2021. The following description provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

Termination of Plan

On August 6, 2021, the Plan Sponsor was acquired by DCCM, LLC ("DCCM"). DCCM purchased 100% of the Plan Sponsor's stock and subsequently the ESOP was terminated. As a result of plan termination, all participant balances became fully vested. Additionally, the plan did not allow additional employees to become eligible to enter the Plan and no further employer contributions were made into the Plan.

During the year ending December 31, 2024, the Plan received \$107,488 in proceeds from the release of the remaining escrow proceeds, relating to a final purchase settlement.

Eligibility

Prior to Plan termination, employees of the Company were generally eligible to participate in the Plan on the first day of the plan year following twelve consecutive months of service, provided the employee was at least twenty-one years of age. Participants who did not have at least 1,000 hours of service during a plan year, or were not employed on the last working day of a plan year, were generally not eligible for an allocation of Company contributions for such year.

Employer Contributions

The Company, at the discretion of the Board of Directors, made contributions to the Plan in cash and/or in shares of Company Stock to the Board of Trustees (the "Trustee") for each plan year in amounts to be determined by the Board of Directors. Contributions are allocated to individual participant's accounts on a pro-rata basis according to their earnings for the year. No participant shall be required or permitted to make contributions to the Plan.

NOTE 1: DESCRIPTION OF THE PLAN *(Continued)*

Participant Accounts

The plan is a defined contribution plan under which a separate individual account is established for each participant.

Each participant's account is credited its pro-rata share of discretionary contributions, investment income or loss (including the net change in unrealized appreciation/depreciation on investments held at year end) and forfeitures during the year.

Vesting and Payment of Benefits

As a result of the ESOP termination, all participant accounts are 100% vested.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value as of the anniversary date immediately preceding the beginning of each put option period. The Company may pay for the purchase with interest in a lump sum or in substantially equal, annual installments over a period not exceeding five years. Partial exercise of a put option is not permitted. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting. Under this basis all assets of the Plan have been measured at the amount of the expected cash proceeds from liquidation as of the measurement date and any costs of liquidation are accrued. The change in accounting policy did not have a material effect on the financial statements of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(Continued)*

Other Fees and Expenses

The Plan does not compensate the Plan sponsor for its internal costs related to the administration of the Plan. As of December 31, 2024 the Plan recorded \$84,832 in other fees and expenses, respectively.

Distributions to Participants

Distributions from the Plan are recorded when a participant notifies the Plan of their intent to redeem their balance. As of December 31, 2024 the Plan did not record any accrued distributions.

NOTE 3: TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated May 14, 2015, that the Plan is qualified and therefore tax exempt under the appropriate sections of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist of Company common shares and contributions receivable, are held by the Trustees of the Plan. As of December 31, 2024 and 2023, the Plan assets consisted of cash. Company contributions are held and managed by the Trustees, who invest cash received and make distributions to participants. Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. The Plan does not compensate the Plan sponsor for its internal costs related to the administration of the Plan.

NOTE 5: RELATED PARTY TRANSACTIONS

Parties-in-interest are defined by IRS Section 4785(e)(2) and ERISA Section 3(14)(c) to include, among others, any entity that provides services to the Plan.

As the Company is the Plan sponsor, transactions involving Binkley & Barfield, Inc. common stock qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held no shares of Binkley & Barfield, Inc. common stock.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. The Plan also invests in various investment securities which are exposed to the same risks. Due to the level of risk associated with the common stock and investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participants' account balances reported in the statement of net assets available for benefits.

There were no investments held as of December 31, 2024 and 2023.

NOTE 7: PLAN TERMINATION

The Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested. In August 2021, the Company voted to terminate the Plan. See Note 1 for further discussion.

NOTE 8: INCOME TAXES

The Plan did not have unrecognized tax benefits as of December 31, 2024 and 2023, and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 9: RECONCILIATION TO FORM 5500
