Scope and Nature of the *ERISA* Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Aero-Flite 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by *ERISA* Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Aero-Flite 401(k) Plan's financial statements performed in accordance with *ERISA* Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA*. As permitted by *ERISA* Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA* (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the *ERISA* Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Aero-Flite 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering substantially all employees of the participating company who have completed a year of service defined by the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

Eligibility. Employees of the Company are eligible to participate in the Plan and receive any employer paid matching contributions upon reaching 21 years of age and after completing two months of service. Employees initially hired as independent contractors are eligible to participate in the Plan on the day of being hired as an Aero-Flite, Inc. employee, assuming all other requirements have been met.

Contributions. Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined by the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1 percent, up to a maximum auto-deferral of 6 percent.

Employer safe harbor match – The Company makes safe harbor contributions equal to 100 percent of employee contributions up to 1 percent of eligible compensation deferred to the Plan; and 50 percent of employee contributions over 1 percent, but not to exceed 6 percent of eligible compensation deferred to the Plan. The employer safe harbor contribution for the year ended December 31, 2024, was \$880,509 of which \$29,943 was funded from forfeitures.

Employer match and profit-sharing contributions – The Company may elect to make discretionary matching and profit-sharing contributions to the Plan. The profit-sharing contribution for the year ended December 31, 2024, was \$986,823.

Participant Accounts. Each participant's account is credited each pay period with the participant's contribution and the Company's matching contribution. Plan investment income and unrealized gains or losses are allocated to participant accounts daily. Company contributions are allocated based upon participant contributions. Earnings are allocated based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits. Upon retirement or termination of service, the balance of the participant's account will be distributed as an annuity or as a single lump-sum cash payment. The participant can elect the form of payment at any time before retirement. However, if a participant's vested benefit in the Plan does not exceed \$5,000, the vested balance of the participant's account may only be distributed in a single lump-sum payment.

The Plan administrator may begin making required minimum distributions when the participant reaches age 72, or upon termination of employment, whichever is later, at which point the participant may elect to receive a lump-sum, installments, or a continuous right of withdrawal where the participant may withdraw such amounts at such times as the participant chooses.

Normal retirement age is 65; however, participants are allowed in-service withdrawals at age 59 years and 6 months. Hardship withdrawals are allowed from a participant's deferral contributions and rollover accounts.

Vesting. Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the employer safe-harbor and Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested in employer safe harbor match contributions after two years of credited service. For employer discretionary match and profit-sharing contributions, participants vest based on the following schedule:

The Plan has allocated \$1,854,747 to participants who have terminated participation in the Plan as of December 31, 2024.

Forfeitures. Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan, must be used during the Plan year in which the forfeiture occurred, and will first be used to pay Plan administrative expenses, with any remaining amount used to reduce future employer contributions.

Forfeited nonvested accounts totaled \$1,830 as of December 31, 2024 (\$1,190 for 2023). Forfeitures of \$1,830 were used to reduce employer contributions in the current year.

1. DESCRIPTION OF PLAN (CONTINUED)

Income Tax Status. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believes that the Plan is qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the authorities; however, there are currently no audits for any tax periods in progress.

Administrative Expenses. The Plan will pay some or all Plan-related administrative expenses out of the forfeiture account or paid by the Company. Investment management and distribution fees are paid by the Plan participants.

Plan Termination. Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the *ERISA*. In the event of Plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting. The financial statements of the Aero-Flite 401(k) Plan are prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are valued at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the U.S. requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits. Benefits are recorded when paid.

3. GUARANTEED INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY

In 2017, the Plan entered into a fully benefit-responsive investment contract (FBRIC) with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is created with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on an annual basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is depended on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA*; or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Level 2 Fair Value Measurements

The fair value of pooled separate accounts is valued using the net asset value (NAV), per share practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

6. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN
