NOTE 1 - DESCRIPTION OF PLAN AND PLAN BENEFITS

The following description of the Microbac Laboratories, Inc. (the Company) Retirement Income Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution cash or deferred retirement income savings plan with a profit sharing provision covering all employees of the Company who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum amount permitted by law of their annual compensation, as defined by the Plan. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into a variety of investment options offered by the Plan. The Plan currently offers various mutual funds and other investments as investment options for participants. The Company may elect annually to make a matching contribution to each participant based on a percentage of his or her elective deferrals. Beginning in 2017, the Company established a matching provision of 1/2% on each 2% of participants' deferrals up to 6% of compensation. The Company may also make qualified non-elective and discretionary contributions in amounts as determined in the sole judgment of the Company. The Company did not make any discretionary contributions for 2024. If eligibility requirements are met, a participant will be automatically enrolled in this plan with a contribution rate of 3% for the 401(k) portion of the Plan unless the Company is notified otherwise.

Participant Accounts

Each participant's account is credited with the amount of the participant's contributions, allocations of Company contributions and Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, and earnings thereon. Participants become fully vested in the remainder of their accounts after completing five years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the plan administrator at time of application. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service a participant may receive, as soon as administratively possible, the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

Forfeitures

At December 31, 2024, forfeited non-vested accounts totaled \$63,512. These accounts will be used to offset Plan expenses and reduce employer contributions. During 2024 and 2023, \$67,957 and \$9,682, respectively, of forfeited non-vested accounts were used to offset Plan expenses and reduce employer contributions.

Expenses

Trustee administrative fees and investment expenses are paid by the Plan. Certain other plan costs are paid by the Plan sponsor.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment Valuation

The Plan's investments in Mutual Funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

Management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Inputs to level 2 measurements include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If this asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024.

Mutual funds (shares of registered investment companies): Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

For the Common Collective Trusts, Transamerica uses unit values to perform daily account valuations. Transamerica calculates its account valuations based on the closing stock market price of each of the funds included in the Common Collective Trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (STABLE VALUE FUND)

Beginning in 2017, the Plan entered into a fully benefit-responsive investment contract with Transamerica Life Insurance Company. Transamerica maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses.

Because the investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract.

The Stable Value Option investment choice is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another without the consent of Transamerica. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, for example, a significant decline in creditworthiness of Transamerica, the Stable Value Option investment choice may no longer be considered fully benefit-responsive. The terms of Transamerica's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to investment choices within the plan. Since the Stable Value Option investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable. The Stable Value Option investment choice allows a participant reasonable access to their assets.

The average yield earned equals the credited rate, which was 2.05% for 2024 for the Stable Value Focus Option.

NOTE 5 - RELATED PARTIES

The Plan's investments are managed by Transamerica/Reliance Trust, the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Transamerica for investment management services amounted to \$77,366 for the year ended December 31, 2024.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Microbac Laboratories, Inc. 401(k) Retirement Income Savings Plan is a tax qualified prototype retirement plan and trust. The Plan Sponsor (Transamerica) is responsible for ensuring that the Plan meets the requirements of the Internal Revenue Code to maintain its qualified status. The Internal Revenue Service has determined and informed the Plan sponsor as a volume submitter that the prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan sponsor and administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in a combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of the risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for plan benefits.
