Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of The Williamson Eye Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 - Description of Plan -

The following brief description of The Williamson Eye Center 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

Description of Plan

The Plan is a defined contribution plan covering eligible employees of Williamson Eye Center, AMPC and other adopting employers within the controlled group including Williamson Management, Williamson Cosmetic Center, and Ophthalmic Outpatient Surgery (the Companies). Employees are eligible to participate if they are 21 years of age and completed 6 months of service.

Contributions

Participants may elect to defer up to 90% of their eligible salaries not to exceed the maximum allowed under Section 401(k) of the Internal Revenue Code. In addition, participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with limitations under the Internal Revenue Code. Participants are also eligible to make after-tax Roth contributions.

For the plan years ended December 31, 2024 and 2023, the Companies made discretionary matching contributions equal to 25% of employee elective deferrals not exceeding 6% of compensation.

Participant Accounts

Each participant's account is charged or credited with the participant’s contribution, the Companies' contribution, the Plan’s investment earnings or losses, and certain plan administration costs not covered by the Plan sponsor. Allocations are based upon participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination, participants or their beneficiaries are entitled to receive the value of their vested account balance. In-service distributions are permitted after attaining the age 59 ½. Participants may also receive hardship distributions, as defined in the Plan, from their deferral and rollover contribution account.

Vesting

Participants become fully vested upon attainment of early retirement date (60), death, and disability. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting in the remainder of their accounts is based on years of continuous service as follows:

Forfeited Accounts

Forfeited non-vested accounts are used to reduce future employer contributions and/or to pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,527 and \$14,254, respectively. For the year ended December 31, 2024 forfeitures totaling \$27,777 were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to specified limits. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of Accounting Policies -

Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting, and investments are valued at current fair value as quoted by the custodian of the Plan. All assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

Administrative Expenses

The Companies, at their sole discretion, may pay the administrative expenses (i.e., custodian fees, fund fees, loan fees, record keeping fees, and other similar expenses) of the Plan. If such expenses are not paid by the Companies, they are paid out of plan assets. Certain administrative expenses of the Plan were paid by the Companies for the year ended December 31, 2024. Investment related expenses are included in investment income (loss).

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan custodian. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes the Plan's gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents. Deemed distributions for the year ended December 31, 2024 totaled \$48,380 and are included in Benefits Paid to Participants in these financial statements.

Risks and Uncertainties

The Plan provides for various investment options in pooled separate accounts. These funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these funds, it is at least reasonably possible that changes in the values of these funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service may be recorded as a liability, with a corresponding reduction to contributions. At December 31, 2024 and 2023, excess contributions payable totaled \$51,302 and \$41,430, respectively.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Reclassification

Certain items in the 2023 financial statements may have been reclassified to conform to the presentation in the current year financial statements. Such reclassifications had no effect on the previously reported change in the net assets available for benefits.

Note 3 - Plan Termination -

Although they have not expressed any intent to do so, the Companies have the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of

Plan termination, participants become fully vested in their accounts.

Note 4 - Tax Status -

The Companies have adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the plan is no longer subject to income tax examinations for years prior to 2021.

Note 5 - Party-in-Interest Transactions -

Certain plan investments were held in and managed by John Hancock Life Insurance Company (U.S.A.) (John Hancock). Because John Hancock served as the Plan trustee; these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in investment income, as they are paid through revenue sharing, rather than a direct payment. The Companies also directly pay other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Fair Value Measurements -

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts: Sub-accounts available as investment options under the Plan. Sub-accounts pool contributions of more than one participant and invest them in securities or the underlying mutual fund. These sub accounts are always valued at marked value and reflect the current value of the sub account investment on the valuation date. Market value equals the current unit value multiplied by the

number of sub-accounts units owned.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 9 - Delinquent Participant Contributions -

During the year ended December 31, 2024, participant deferrals totaling \$10,614, were not timely remitted to the Plan in accordance with the requirements of the Department of Labor. The Plan Sponsor calculated lost earnings and remitted \$9,232 of contributions corrected outside of the VFCP. The Plan sponsor is in the process of calculating lost earnings and remitting contributions not corrected totaling \$1,382 as further detailed on the supplemental schedule of delinquent participant contributions.

Note 10 – Subsequent Events -

Subsequent events were evaluated through October 7, 2025, the date the financial statements were issued.
