Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of Pacific Biosciences of California, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 2005 by Pacific Biosciences of California, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**B. Administration and Expenses**

The Company appointed a 401(k) Oversight Committee (the “Committee”) to manage the operation and administration of the Plan. The Company contracted with Ascensus, LLC to serve as third-party administrator to process and maintain the records of participant data. An affiliate, Ascensus Trust Company, serves as custodian of Plan assets. The Company previously appointed Newport Group, Inc. and its affiliates as third-party administrator and custodian until, through a merger, Newport Group, Inc. is part of Ascensus, LLC.

Participants pay annual administrative fees that are charged on a quarterly basis. Such fees are used to pay Plan recordkeeping, administrative and investment advisory costs. Participant loan administration, distribution processing and certain other costs are charged directly to participants.

**C. Eligibility**

Substantially all employees of the Company of age 21 or older are eligible to enter the Plan on their date of hire. The Plan specifically excludes leased employees, and employees that are classified as Interns.

**D. Contributions**

Participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the maximum amount permitted under provisions of the Code. Participants of age 50 or older may elect to make additional catch-up contributions subject to Code limitations.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with participant directions and the Plan’s provisions.

The Company is allowed to make discretionary matching and non-elective contributions as defined in the Plan and as approved by the Board of Directors. No such contributions were made for the year ended December 31, 2024.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, Plan earnings or losses and expenses. Participants direct the investment of their accounts.

**F. Vesting**

Participants are immediately 100% vested in their accounts attributable to elective deferral and rollover contributions. Participants attain full vesting in their accounts attributable to discretionary Company contributions, if any, after six years of credited service.

**G. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability or attaining age 59½, a participant or beneficiary may maintain his or her account in the Plan or withdraw vested benefits in a lump sum. Under limited circumstances, the plan administrator may approve hardship withdrawals. The Plan allows for mandatory distribution of terminated participant accounts valued at \$5,000 or less.

**H. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account, bears interest at a fixed interest rate of prime rate plus 1% determined at loan inception and must be repaid to the Plan within a five-year period. If a loan is used for the purchase of a principal residence, the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan. Outstanding participant notes at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through January 2038.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the

measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**E. Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize Plan investments at December 31 based on inputs used to value them:

Mutual funds are valued at closing market prices of shares held by the Plan at year end. Mutual funds held by the Plan are actively traded open-end funds that are registered with the Securities and Exchange Commission and required to publish their daily net asset value and transact at that price.

**NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was

obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, the custodians.

**NOTE 5 - INCOME TAX STATUS**

The Company adopted a volume submitter plan that received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Payments of direct and indirect administrative fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan by resolution of its Board of Directors subject to provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the Plan's financial statements.
