Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cape Air/Nantucket Airlines KSOP Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cape Air/Nantucket Airlines KSOP Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Description of Plan

The following description of Cape Air/Nantucket Airlines KSOP Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan includes a tax-exempt employee stock ownership plan (ESOP component) and a tax exempt 401(k) plan (non-ESOP component) established to provide all eligible employees of Hyannis Air Service, Inc. d/b/a Cape Air/Nantucket Airlines (Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The assets of the non-ESOP component of the Plan (mutual funds and the common collective trust) are held by the Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal). Principal is the trustee and recordkeeper of the Plan. The assets of the ESOP portion of the Plan are held by Bankers Trust Company of South Dakota d/b/a Greatbanc Trust Company(Greatbanc).

Eligibility

Company employees who have attained the age of twenty-one are eligible to make voluntary contributions to the non-ESOP component of the Plan after completion of three months of service, as defined in the Plan document.

Employees who have attained the age of twenty-one and completed 1,000 hours of service are eligible to participate in the ESOP component of the Plan.

Employees whose employment is governed by the terms of a collective bargaining agreement, non-resident aliens who do not receive any earned income from the Company which constitutes United States source income, leased employees (as defined), and seasonal employees are ineligible to participate in the Plan.

Participant Contributions

Eligible participants may make voluntary contributions to the non-ESOP component through salary reductions from 1% to 75% of eligible annual pre-tax compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,500 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). Effective July 1, 2017, the plan was amended to add an automatic enrollment feature. Eligible participants in the plan prior to the amendment date who did not have an affirmative election in place or who have affirmatively elected not to contribute shall be deemed to have a deferral election of 4% of eligible compensation. Eligible participants post amendment date are automatically enrolled in the plan with a deferral election of 4%. Participants may cancel, modify or otherwise change any of the automatic elections. The non-ESOP component's investments are participant-directed, utilizing certain investment options offered by the Plan, including various mutual funds and a common collective trust.

Employer Contributions Non-ESOP Component

The Company may make matching contributions to the non-ESOP component of the Plan in such amounts as the Company designates. The matching contribution is calculated at 50% of the first 4% of the participant's eligible compensation, as defined in the Plan document.

Employer contributions related to the non-ESOP component of the Plan define eligibility to receive matching contributions as employees who have attained the age of twenty-one and completed 1,000 hours of service.

For the years ended December 31, 2024 and 2023, the Company made contributions of \$409,683 and \$404,645, respectively, to the non-ESOP component of the Plan.

Employer Contributions ESOP Component

The Company may make voluntary contributions to the ESOP component of the Plan at the discretion of the Board of Directors. These employer ESOP contributions may be paid in cash or shares of Company stock. For the year ended December 31, 2024, the Company made no contribution to the ESOP-component of the Plan. For the year ended December 31, 2023, the Company made a contribution of \$129,961 to the ESOP-component of the Plan, which was allocated to participants based on their proportionate share of eligible wages.

Voting Rights

Bankers Trust Company of South Dakota d/b/a Greatbanc Trust Company (ESOP Trustee) shall vote all shares of Company stock held as part of the Plan assets, in accordance with the terms of the Plan. If any agreement entered into by the Company in connection with an acquisition loan provides for voting pledged shares, the ESOP Trustee shall vote the pledged shares in accordance with the agreement, but only to the extent such voting complies with the requirements as defined in the Plan document.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) ESOP and non-ESOP employer contributions and (b) ESOP and non-ESOP Plan earnings or losses. Allocations of ESOP contributions are based on participant's eligible compensation relative to total eligible compensation.

Vesting – Non-ESOP Component

Participants' voluntary contributions and earnings thereon vest immediately. Vesting in the Company's matching contributions in the non-ESOP component plus actual earnings thereon is based on the number of years of continuous service. Vesting begins after two years of service, as defined, with full vesting after six years of credited service. In the event of death, disability, or attainment of age 65, participants' accounts become fully vested.

Vesting – ESOP Component

Vesting in the ESOP component of employer contributions plus actual earnings is based on the number of years of continuous service. For participants with at least one hour of service on or after January 1, 2015, vesting begins after two years of service, as defined, with full vesting after five years of credited service.

Payment of Benefits – Non-ESOP Component

Upon termination of employment, retirement, attainment of age 59½, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's non-ESOP component account in a single lump-sum or installment payments, in accordance with Internal Revenue Service (IRS) regulations and Plan provisions. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½. Distributions to participants are recorded when paid.

Payment of Benefits – ESOP Component

Upon termination of employment, retirement, attainment of age 59½, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's ESOP component account in a single lump-sum or installment payments, in accordance with IRS regulations and Plan provisions. Distributions of

the vested portion of the participant's ESOP component account balance shall begin when elected by the participant or beneficiary, but no later than the last day of the Plan year immediately following the Plan year in which the participant terminated employment. Distributions of Company stock shall be made in whole or fractional shares. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan.

Put Option

Under Federal income tax regulations, the employer stock that is held by the ESOP component of the Plan and its participants is not readily tradable on an established market and includes a put option. The put option, as defined in the Plan document, is a right to demand that the Company buy any shares of stock it has distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure liquidity for participants.

Diversification

At the discretion of the Company, any participant who is at least age 55, with ten or more years of Plan participation, may elect within 90 days after the close of each Plan year during the six-year Plan period beginning with the Plan year in which the participant has met both such requirements, to diversify a portion of their ESOP account to other options.

In each of the first five years thereafter, a participant may diversify up to 25% of their ESOP shares, less any shares previously diversified. In the sixth year and thereafter, the percentage increases to 50%. Any participant under the age of 55 may diversify the investment in Company stock in their ESOP account in an amount up to 20% of the aggregate ESOP account balance each year, determined as of the most recent valuation date. Such election is satisfied by converting the participant's shares to cash and transferring the balance to the non-ESOP component of the Plan.

Allocated and Unallocated Shares

All shares of Company stock contributed to the ESOP-component of the Plan have been allocated to participant accounts as of December 31, 2024 and 2023. The cost of the allocated shares are \$192,143 and \$211,173 as of December 31, 2024 and 2023, respectively.

Forfeitures

The Plan provides that forfeitures, the unvested portion attributable to ESOP and Company matching contributions for terminated participants, will be used at the discretion of the plan administrator to pay administration costs of the Plan, restore previously forfeited account balances, as defined in the Plan document, or reduce Company matching contributions. During the year ended December 31, 2024, forfeitures were used to reduce administrative expenses and Company matching contributions by \$86,651. There were forfeitures during the year ended December 31, 2024, totaling \$88,009. Other earnings and dividends totaled \$259 during the year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,955 and \$1,338, respectively.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Participants may borrow up to 50% of their vested account balance in their non-ESOP component of the Plan with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended.

Loans are secured by the balance in the participant's account in the non-ESOP component of the Plan. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year and held at year end.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

The Company may, at its discretion, pay the expenses incident to administering the Plan and are excluded from these financial statements. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan.

Subsequent Events

The Company has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) and GreatBanc Trust Company (Greatbanc), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule(s).

Note 4. Party-in-interest Transactions

The ESOP-component of the Plan holds Hyannis Air Service, Inc. common stock as an investment. Hyannis Air Service, Inc. is the employer and Plan sponsor. Any transactions in its common stock qualify as exempt party-in-interest transactions. At December 31, 2024, there were 221,998 shares outstanding of Company common stock valued at \$2,319,885. At December 31, 2023, there were 242,965 shares outstanding of Company common stock valued at \$2,171,265. During the year ended December 31, 2024, the Company recycled 9.35 shares of Company common stock from the ESOP-component of the Plan and 20.96 shares were redeemed to treasury.

Certain investments are a mutual fund and common collective trust managed by Principal. Principal is the trustee of the Plan and therefore these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA. Total fees paid to Principal during the year December 31, 2024 were \$81,951 which are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Note 5. Tax Status

On September 28, 2017, the Internal Revenue Service (IRS) stated that the individually designed plan adopted by the Plan, as then designed, qualified under Section 401(a) of the Internal Revenue Code (IRC). The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator does not believe that any years prior to 2021 are subject to examination.

Note 6. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities including privately held plan sponsor common stock. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time by resolution of the Board of Directors, subject to the provisions of ERISA. In the event that the Plan and the related trust fund terminate, participants will be 100% vested in their accounts. All accounts will be valued as of the termination date and account balances will be distributed in full to participants.

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quote prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

- Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Money Market Fund: Valued at the closing price reported by the fund sponsor from an actively traded exchange.
- Company common stock: Valued annually at estimated fair value based upon an independent appraisal. The appraisal is based upon a combination of market and income valuation techniques consistent with prior years. The independent appraiser used a combination of a debt free discounted cash flow approach and the guideline company method for market value of invested capital. Unobservable inputs included the weighted average cost of capital, the discount rate and projected cash flow.
- Common collective trust: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts, asset-backed securities, corporate bonds, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

The value of certain investments, classified as alternative investments, is determined using net asset value (or its equivalent) as a practical expedient. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 9. Investment Contract with Insurance Company

In 2024, the Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash

provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
