Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Great River Entertainment, LLC 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(c) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Plan Description

The following description of the Great River Entertainment, LLC (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. *General.* The Plan was established January 1, 1998 and is a defined contribution plan covering all employees of the Company who have one year of service with at least 1,000 hours of service, and who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. *Contributions.* Each year participants may contribute an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. Effective July 1, 2017, if an employee does not elect a deferral percentage or decline participation in the Plan, the employee is automatically enrolled with a deferral rate of 5%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows the employer to consider a discretionary matching contribution. The employer matched 100% of the first 5% of the participant’s elective deferral. The Plan also allows the employer to consider discretionary nonelective contributions. The employer elected not to make any discretionary nonelective contributions to the Plan for the years ended December 31, 2024 and 2023. The Company contribution is invested into various investment options offered by the Plan.
3. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, if any, and (b) plan earnings, and charged with a monthly administrative fee and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. *Vesting.* Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.
5. *Payment of Benefits.* Upon the date of normal retirement, early retirement, death, total and permanent disability or termination of service, a participant may receive a lump-sum amount equal to the value of the vested portion of their account. Under the default automatic rollover provisions, distributions greater than \$1,000 and less than \$5,000 will be made to an Individual Retirement Account (IRA) without participant consent, if a participant does not make a different distribution election after receiving the required notification. Distributions to participants with a vested balance of \$1,000 or less will receive a lump-sum payment.
6. *Participant Loans.* Participant loans are not permitted by the Plan.

7. *Forfeited Accounts.* The balance of forfeitures of terminated participants' non-vested accounts of \$17,741 and \$5,428 for the years ended December 31, 2024 and 2023, respectively, will be used to reduce future employer contributions or plan expenses. Forfeitures used during the years ended December 31, 2024 and 2023 were \$53,542 and \$15,680, respectively.
8. *Disposition of Forfeitures.* Participants who request a distribution before becoming fully vested in the Plan forfeit the non-vested portion of employer contributions to their account.

Forfeitures of matching contributions are used to reduce future employer contributions or plan expenses.
9. *Hardship Distributions.* Participants may elect to withdraw all or a portion of their fund accounts if they incur an immediate and heavy financial need. The amount is limited to all or part of elective deferral contributions for immediate and severe financial need. The participant may not make elective deferrals or employee contributions to the Plan for the six-month period following the date of the hardship distribution.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements are prepared under the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results could differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Investment Valuation and Income Recognition - The Plan's investments are administered by Fidelity Workplace Services LLC. The investment value of each fund represents contributions made, plus the proportionate share of the increase or decrease in the assets of the fund from investment earnings (interest and dividends) and realized and unrealized appreciation or depreciation in the carrying value of its investments, and less amounts used to pay investment and administrative expenses charged by the custodian. Investments are stated at fair value.

Expenses of the Plan - Substantially all administrative expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses.

Date of Management Review - Management has evaluated subsequent events through August 26, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurement

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 5 - Income Tax Status

The Plan adopted a volume submitter plan which had received an advisory letter dated June 30, 2020 from the IRS which stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 - Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Workplace Services LLC. Fidelity Workplace Services LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$51,896 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 8 - Administrative Fees

Substantially all administrative expenses associated with the Plan are paid directly by the Plan.

Note 9 - Information Prepared and Certified by Custodian

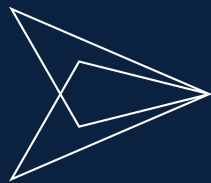

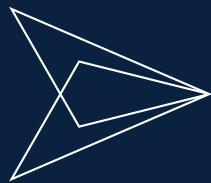
