**NOTE A -- Description of the plan and significant accounting policies**

The following description of Zilber Ltd. Employee Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The original effective date of the Plan was January 1, 1991. Zilber Ltd. (the "Company" or "Employer") adopted the Associated Trust Company, N.A. ("Associated") Non-standardized Profit Sharing/401(k) Plan effective January 1, 2022.

**General**

The Plan is a defined contribution plan covering all eligible employees of the Company, who are age 18 or older. The Plan has no minimum service requirement to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan's federal identification number is 39-1472959, and the Plan's number is 001.

**Contributions**

Each year, participants may contribute up to 90% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Plan has an automatic escalation feature in which the deferral percentage increases by 1% each year to a maximum of 10%. Through March 31, 2024, the Company contributed 100% of the first \$2,000 and 50% of the next \$3,000 that a participant contributed to the Plan as a discretionary matching contribution. Effective April 1, 2024, the Company contributes 100% of the first \$3,000 plus 50% of the next \$5,000 that a participant contributes to the Plan as a discretionary matching contribution. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

**Participant accounts and "rollovers"**

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's matching contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on continuous service. A participant is 100% vested ratably after five years of credited service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate. Effective October 1, 2023, the Plan amended the fixed rate on notes receivable from participants from 2% over the Prime Rate to 1% over the Prime Rate (7.50% at December 31, 2024) set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through monthly payroll deductions.

**Benefits**

On termination of service due to death, disability, retirement (age 65), or termination of service due to other reasons, the Plan may initiate distributions if the participant does not actively request a distribution or rollover from their account. Participant accounts valued at less than \$5,000 but more than \$1,000 may be transferred to an IRA; and participant accounts valued at less than \$1,000 may be closed through a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect a lump-sum distribution equal to the value of the participant's vested interest in his or her account, installments, partial lump-sum payments or may elect to defer such distribution to any valuation date subsequent to their termination; or the participant may elect to rollover the distribution to another qualified plan. The Plan permits in-service distributions at age 59½. The Plan permits hardship distributions if certain criteria are met.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$41,331 and \$25,379, respectively. These accounts will first be used to reduce future Company matching contributions. Any remaining forfeitures will be used to pay Plan expenditures. In 2024, employer contributions were reduced by \$38,012 from forfeited nonvested accounts..

A summary of significant accounting policies follows:

**Basis of accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

**Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note C for discussion of fair value measurements.

#### **Investment valuation and income recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

The Company pays some of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are recordkeeping and investment advisory fees.

#### **Notes receivable from participants**

Notes receivable from participants are reported at their unpaid principal balances. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

#### **Subsequent events**

These financial statements have not been updated for subsequent events occurring after October 7, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

### NOTE C -- Fair value measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investments companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust funds. Valued based on net asset values of the shares held by the Plan at year end. While the majority of the underlying asset values are based on quoted prices, the net asset value of the collective trust funds are not publicly quoted. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

**NOTE D -- Party-in-interest transactions**

Associated is the trustee, asset custodian and recordkeeper of the Plan as of and for the years ended December 31, 2024 and 2023, and is therefore designated as a fiduciary and party-in-interest. The Plan regularly invests in funds for which Associated (or its affiliates) are the issuing parties. These party-in-interest transactions and fees paid occurred in the course of ordinary business and are exempt transactions.

Fees were also paid by the Plan during the year for advisory services rendered by Francis Investment Counsel. These transactions also qualify as party-in-interest transactions.

Associated provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement "MSA" between the Company and Associated. Associated receives revenue from mutual fund service providers for its services.

If the revenue received by Associated from such mutual fund service providers exceeds the amount owed, Associated remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants.

**NOTE E -- Plan termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their allocated Employer contributions.

**NOTE F -- Tax status**

The Employer adopted the Associated Trust Company, N.A. Non-standardized Profit Sharing/401(k) Plan, referred to in Note A, which obtained its latest letter on June 30, 2020 in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable sections of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE G -- Concentration of market risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE H -- Plan amendments and restatement**

Effective October 1, 2023, the Plan reduced the interest rate on notes receivable from participants from the Prime Rate plus 2% to the Prime Rate plus 1%.

Effective December 31, 2023, the Plan was amended to change the participating eligibility requirement from 166 hours of service during the first 2 months of employment or 1,000 hours within 12 months to no minimum service requirement and age 20 or older to age 18 or older.

Effective November 21, 2024, the Plan was amended to change the allocation of forfeitures. Forfeitures will first be used to reduce employer contributions. Any remaining forfeitures will be used to pay Plan expenses.

**NOTE I-- Delinquent participant contributions**

The plan sponsor did not comply with Department of Labor Regulation 2510.3-102 requiring the deposit of employee deferrals into the Plan trust as soon as the contributions can reasonably be segregated from the employer's general assets, but no later than 15 business days following the month in which the deferrals were withheld from the employees, a nonexempt transaction with a party-in-interest (prohibited transaction). The plan sponsor made a contribution to the Plan in 2025 in order to correct for the lost earnings to the participants calculated as a result of the prohibited transaction related to the year ended December 31, 2024. A summary of the delinquent contributions is presented in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions.
