The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of Midtronics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Midtronics, Inc. (the Company) who are age 21 or older. Employees who meet the eligibility requirements become participants in the Plan for elective deferral and matching contributions immediately coinciding with or following the next date on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2025, the Plan was amended to add an automatic plan enrollment feature whereby all newly hired employees are automatically enrolled in the Plan immediately after meeting the eligibility requirements with a contribution of 3% of compensation unless they affirmatively decline to participate in the Plan.

Contributions: Each year, participants may contribute the maximum amount allowed by law of annual compensation to the Plan. Participants may also contribute Roth deferrals to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company will make a matching contribution equal to 50% of the first 6% of an employee's eligible compensation that a participant contributes to the Plan. Additional discretionary amounts may be contributed at the option of the Company. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant contributions and Company matching contribution, as well as allocations of the Company's discretionary contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in all participant and rollover accounts plus actual earnings thereon. Participants vest in their respective share of the Company's contributions based on years of continuous service. A participant is 100% vested after five years of credited service, with 25% vesting credited to the participant per year of service, as defined, commencing in the second year of employment. In the event of death, disability, or retirement at designated ages, participants become fully vested.

Notes receivable from participants: Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding loan balance in the preceding 12 months or 50% of their vested account balance. Notes receivable terms range from one to five years or longer if used to purchase a principal residence and each participant may not have more than one note receivable outstanding at any time. The notes receivable are secured by the balance in the participant's account balance and bear interest at a rate of 1% above the prime interest rate. Principal and interest are paid ratably through payroll deduction.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,652 and \$50,918, respectively. These accounts will be used to reduce future Company contributions. During 2024, \$53,900 of forfeitures were used to reduce Plan expenses.

Note 1. Plan Description (Continued)

Payment of benefits: Benefit payments are made to participants or their beneficiaries upon death, retirement, disability or termination of employment. On termination of service, a participant's vested accrued benefit shall be paid in the form of a lump sum if the vested accrued benefit is less than \$5,000. If the vested accrued benefit is \$5,000 or more, a participant may elect to receive a lump sum, installment or partial withdrawal subject to certain provisions of the Plan. Hardship withdrawals and in-service distributions are permitted as described in the Plan document.

Investment options: Upon enrollment in the Plan, a participant may direct contributions among a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment election daily.

Excess contributions: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Loans in default are treated as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Charles Schwab Bank (the Custodian)

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stock, exchange-traded funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Units of common/collective trust: Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party Transactions and Parties-in-Interest

The Plan's investments are managed by Charles Schwab Bank, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to its service providers were \$78,802 for the year ended December 31, 2024.

Charles Schwab Bank provides certain administrative services pursuant to the Servicing Agreement between the Plan and Charles Schwab Bank. Charles Schwab Bank receives revenue from mutual fund service providers for services Charles Schwab Bank provides to the funds. This revenue is used to offset certain amounts owed to the Plan's service providers. If the revenue received by Charles Schwab Bank from such mutual funds service providers exceeds the amount owed under the Servicing Agreement, Charles Schwab Bank remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, \$20,085, reflected as other income, was earned by the Plan under this agreement, all of which was allocated to participants.

Certain other administrative expenses are paid by the Company. Certain employees of the Company provide administrative and trustee services to the Plan. These employees are not compensated by the Plan for their services.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, participants become 100% vested in the Company matching portion of their accounts.

Note 7. Tax Status

Effective June 30, 2020, the Plan adopted a volume submitter plan sponsored by Epic Advisors Inc. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
