Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. General Information

Description Of The Plan

The following description of the I.B.E.W. Local Union No. 124 Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was formed in 1982 pursuant to an agreement between the Greater Kansas City Chapter, National Electrical Contractors Association (N.E.C.A.) and Local Union No. 124, International Brotherhood of Electrical Workers (I.B.E.W.). The Plan is a defined contribution plan covering all participants who work under the terms of the collective bargaining agreements within the jurisdiction of I.B.E.W. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employers of participants contribute to the Plan for each hour worked by participants in covered employment and at rates negotiated through collective bargaining agreements. The contribution rate for the period January 1, 2021 through December 31, 2024 ranged from \$1.50 to \$6.00 for each hour worked.

Participant Accounts

Each participant may self-direct contributions made on their behalf choosing from different investment options offered by the Plan. Each participant's account is credited with the employer's contributions and allocations of Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 100% vested on the date a contribution is made on their behalf.

I.B.E.W. LOCAL UNION NO. 124 ANNUITY PLAN

Notes To Financial Statements (*Continued*)

Benefits

Participants and/or their beneficiaries are entitled to annuity benefits upon retirement, death, disability or separation from service. Upon retirement, disability or separation of service, the amount of benefit will be paid as a single life or 50% joint annuity. A participant may elect to receive a single sum payment or a monthly annuity paid over a period of either 36, 60 or 120 months. Upon death, benefits will be paid to the participant's beneficiary either as a single sum payment or a monthly annuity paid over a period of either 36, 60 or 120 months. If the participant has a spouse, the accumulated share may, pursuant to an election of the participant and a valid waiver of the 50% husband and wife annuity, be paid as a 75% husband and wife annuity. A participant who has an account balance which is less than or equal to \$5,000 shall receive a lump sum payment.

Administrative Expenses

Administrative expenses are paid by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Cash

The Plan deposits its cash in financial institutions. At times, deposits may exceed federally insured limits. The Plan has not experienced losses in such accounts.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes To Financial Statements (*Continued*)

Investment Valuation And Income Recognition

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in shares or units that were bought and sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment Of Benefits

Benefit payments to participants are recorded when paid.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Subsequent Events

Management of the Plan evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability;

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement;

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023, respectively. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. There are no unfunded commitments related to these investments and the investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in the market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the registered investment companies, and consequently, the fair value of the Plan's investments. All of the pooled separate accounts held by the Plan file an annual report on Form 5500 as a direct filing entity.

Registered Investment Companies

Valued at the daily closing prices as reported by the funds. Registered investment companies held by the Plan are open-end investment vehicles that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

4. Related Party Transactions And Party In Interest Transactions

The Plan, along with other employee benefit plans of I.B.E.W., entered into an agreement with I.B.E.W. - N.E.C.A. Benefit Center, Inc. (BCI).

Under the agreement, BCI performs certain administrative services for the plans. The expenses incurred by BCI to provide the administrative services, including salaries and related benefits, rent, utilities and office supplies, are charged to the plans. The expenses allocated to the Plan for the years ended December 31, 2024 and 2023 were \$162,295 and \$159,920 respectively. Outstanding payables to BCI totaled \$9,194 and \$12,268 at December 31, 2024 and 2023, respectively, and are included in accounts payable in the statement of net assets available for benefits.

The Plan also has an agreement with Principal Life Insurance Company (Principal) whereby Principal provides several pooled separate accounts which participants can self-direct their own investment mix. Principal also maintains participants' account balances and performs various administrative duties. These transactions qualify as exempt party in interest transactions.

5. Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Administrator by a letter dated March 27, 2012 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although they have not expressed intent to do so, the Trustees have the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of termination, all monies of the Plan would be used to pay any and all obligations of the Plan with the excess to be distributed to the Plan participants. In no event would any of the assets of the Plan revert to the contributing employers or to I.B.E.W. Local Union No. 124.

7. Significant Contributing Employers

For the year ended December 31, 2024, contributions from two employers represented 28% of total employer contributions. For the year ended December 31, 2023, contributions from two employers represented 31% of total employer contributions.

8. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
