Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Amery Hospital & Clinic 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



NOTE 1 DESCRIPTION OF PLAN

The following description of Amery Hospital & Clinic 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under code section 403(b) covering all employees of Amery Regional Medical Center, Inc. d/b/a Amery Hospital & Clinic (the Company) who are in a covered employment classification. The Plan was originally effective July 1, 1989 and was last restated during 2018 with a retroactive effective date of January 1, 2010 as part of the remedial amendment period to adopt a volume submitter 403(b) plan document. The Plan was last amended effective January 1, 2023. There is no minimum age or service requirement to make salary reduction contributions or to receive Company matching or discretionary contributions. The Amery Plan Administrator's Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute annual compensation, as defined in the Plan, up to the maximum limitation permitted by the Internal Revenue Service (IRS) as pre-tax or Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees, who became participants on or after April 1, 2013, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Company may make discretionary matching contributions. For the years ended December 31, 2024 and 2023, the Company matching contribution was 100% of the first 4% of base compensation that a participant contributes to the Plan. The Company may, at its discretion, elect to contribute an additional discretionary contribution. There were no Company discretionary contributions authorized for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, Plan earnings or losses, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become 100% vested in all Company contributions and related earnings after one year of service.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, subject to Plan provisions. The notes are secured by the balance in the participant's account. Notes bear interest at the prime rate plus 1%. At December 31, 2024, these notes bear interest at rates that range from 4.25% to 9.50%. Principal and interest is paid ratably by the participant to Fidelity Management Trust Company and each payment reduces the amount secured by the participant's account balance. The amount of such outstanding notes receivable is \$309,002 and \$334,163 at December 31, 2024 and 2023, respectively.

Plan Loans

Participants have the option of obtaining loans that are not from Plan assets, but rather loaned directly from Lincoln National Life Insurance Company and, therefore, are not recorded as a receivable on the statements of net assets available for benefits. The loans are secured by the participant's Multi-Fund Group Variable Annuity fixed account balance. Principal and interest is paid ratably by the participant to Lincoln National Life Insurance Company and each payment reduces the amount secured by the Multi-Fund Group Variable Annuity fixed account balance. The amount of such outstanding loans is \$26,170 and \$25,037 at December 31, 2024 and 2023, respectively.

Benefit Payments

On termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in the form of a lump sum or installments. If the vested portion of the participant's account does not exceed \$5,000, the account balance may be paid out in a single lump sum, rolled into an IRA or another qualified Plan, or any combination of these when requested by the participant. However, when a request is not received, the participant's account will be automatically rolled over into an IRA designated by the Plan administrator. If the vested portion of the participant's account exceeds \$5,000, the distribution will be made after the participant or beneficiary gives consent. The Plan also allows for in-service distributions upon attaining age 59½ and hardship distributions, subject to Plan provisions.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,919 and \$1,294, respectively. These accounts will be used to reduce future Company contributions or pay Plan expenses. There were \$-0- and \$ 30,666 forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023. There were no forfeitures used to pay Plan expenses for the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded at December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements as provided in the Plan document. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Lincoln National Life Insurance Company, the insurance company, has supplied the Plan administrator with a certification as to the completeness and accuracy of certain investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Fidelity Management Trust Company, the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of certain investment information and notes receivable from participants and related interest income reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended, and the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Considerable judgment may be required in interpreting market data used to develop the estimates of fair value. The three levels of the fair value hierarchy under GAAP are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

Money Market Fund: Valued daily based on subscription and redemption activity at a stable \$1 NAV. Redemptions can occur daily at NAV and there are no restrictions to redemption or unfunded commitments.

Self-Directed Brokerage Accounts: Cash and cash equivalents are recorded at book value, which approximates fair value.

General Accounts: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains general accounts with Lincoln Financial Group (Lincoln). The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The general accounts are included in the financial statements at fair value because they are not fully benefit responsive. Upon termination of the investment contracts, the lump sum liquidation value of the general account portion of the participant's accumulation value shall be equal to the participant's general account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated August 7, 2017 received from the IRS indicating that the volume submitter plan is qualified under Section 403(b) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with applicable requirements of the IRC and therefore, believe the Plan is qualified.

The GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company and Lincoln National Life Insurance Company. Fidelity Management Trust Company and Lincoln National Life Insurance Company, are the custodian and insurance company, respectively, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services included in net appreciation (depreciation) in the fair value of the investments.
