NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of Nebraska Children and Families Foundation 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Plan Merger.** The Plan was amended effective April 15, 2025, to merge into the FlexPEP(b) Pooled Employer Plan. As of April 30, 2025, all participants' accounts were transferred to the pooled employer plan.

**General.** The Plan, which became effective June 1, 1999, was most recently amended on April 15, 2025, was a defined contribution plan covering all employees of Nebraska Children and Families Foundation (the Foundation) who worked at least 20 hours per week, with entry available immediately upon employment commencement. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

**Elective Contributions.** Each year eligible employees could make pre-tax and Roth salary reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who had attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

**Employer Contributions.** The Foundation could make a fixed matching contribution on behalf of each eligible participant. Fixed matching contributions were based on a uniform percentage of 156 of participant elective deferrals with a limit of 5% of participant compensation. Total fixed matching contributions are \$166,443 and \$730,090 for the period January 1 to April 30, 2025 and year ended December 31, 2024, respectively.

**Participant Accounts.** Each participant's account was credited with the participant's contribution and allocations of the Foundation's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants were vested immediately in their contributions plus actual earnings thereon and fixed matching contributions.

**Payment of Benefits.** On termination of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum or (b) substantially equal installments or (c) partial withdrawals with no minimum required. Distributions could be made to a participant who had not separated from service upon reaching age 59½. Distributions were to be made as soon as administratively feasible at the participant's election.

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$7,000. The participant could elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election was made, the benefit would be rolled over to an IRA. If the account balance was less than \$1,000, the distribution would be paid in cash. If the vested account balance was greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

**Payment of Benefits – Continued**

Hardship withdrawals were permitted for purposes specified by the Internal Revenue Code. Withdrawals could not exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that were fully vested.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments were reported at fair value (except for a fully benefit-responsive investment contract, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilized a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Transfers between levels shall occur at the actual date of the event or change in circumstances that caused the transfer. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Investment Valuation and Income Recognition – Continued**

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefits were recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan were paid directly by the Foundation and are excluded from these financial statements. Expenses incurred for the administration of the Plan were the responsibility of the Plan. If incurred directly by the Plan, these expenses were included in administrative expenses on the statements of changes in net assets available for benefits. Other investment related expenses were included in net appreciation (depreciation) in fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the period January 1, 2025 to April 30, 2025 and for the year ended December 31, 2024.

*Money market:* Money market funds are valued at cost plus accrued interest. The money market funds held by the Plan are deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D – INVESTMENT AT CONTRACT VALUE**

The Standard Stable Asset Fund II (Fund) is a group annuity contract that offers a full guarantee on principal and interest by the Standard Insurance Company (Issuer). The contract is fully benefit responsive.

With traditional investment contracts, the Plan owned only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The Fund qualified as a fully benefit-responsive investment contract because it meets all the following criteria:

1. The investment contract is affected directly between the Fund and the Issuer and prohibits the Fund from assigning or selling the contract or its proceeds to another party without the consent of the Issuer.
2. The contract Issuer is obligated to (i) repay principal and interest, or (ii) apply prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.
3. The terms of the investment contract require all permitted participant-initiated transactions with the Fund to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined-contribution plan, such as withdrawals for benefits, loans, or transfers to other funds within the Plan.

NOTES TO FINANCIAL STATEMENTS

**NOTE D – INVESTMENT AT CONTRACT VALUE – CONTINUED**

4. An event that limits the ability of the Fund to transact at contract value with the Issuer (for example, premature termination of the contracts by the Fund, plant closings, plan termination, bankruptcy, mergers, and early retirement incentives) and that also limits the ability of the Fund to transact at contract value with the participants in the Fund must be probable of not occurring.
5. The Fund itself must allow participants reasonable access to their funds.

Investment contracts held in the Fund were recorded at their contract value. As the Fund's interest rates were adjusted to market quarterly, contract value, which represent net contributions plus interest at the contract rate, approximates fair value. There were not any specific securities in the general account that back the liabilities of this annuity contract and it would be inappropriate to look to the market value of the securities within the issuer's general account to determine a fair value. The plan owed a promise to pay interest at crediting rates which were announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. This product was not a traditional guaranteed income contract and therefore there are not any known cash flows that could be discounted. As a result, the fair value amount shown was equal to the contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The interest crediting rate was determined quarterly and during 2024 resulted in an average annual yield earned and credited to participants of approximately .02%. The minimum crediting rate is 1.0%. The interest crediting rate was calculated based upon many factors, including projected earnings on investments held in the general account, projected cash flow, the interest rate at which new investments can be made, investment and interest rate risk, investment management expenses, liquidity needs and the competitive environment, as well as potential profit or loss.

**NOTE E - PLAN MERGER**

On April 15, 2025, the Plan merged with a pooled employer plan and transferred substantially all assets into the new plan.

**NOTE F - TAX STATUS**

The Plan is based on the Volume Submitter 403(b) Plan of Union Bank & Trust Company. The Internal Revenue Service notified Union Bank & Trust Company by a letter dated March 31, 2017 that this volume submitter plan is acceptable under Section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter of acceptance, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the period January 1, 2025 to April 30, 2025 and the year ended December 31, 2024, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal Returns for the period January 1, 2025 to April 30, 2025 and the years ended December 31, 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements, including investments held at April 30, 2025 and December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the period January 1, 2025 to April 30, 2025 and for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Invesco and Union Bank & Trust Company, the custodians of the Plan. Accordingly, Invesco and Union Bank & Trust Company have certified that the following data included in the accompanying financial statements is complete and accurate:

**NOTE I - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan received custodial services from Invesco and from Union Bank & Trust Company and its affiliates, and these transactions qualified as party-in-interest transactions. The Plan also paid for recordkeeping services and participant distribution fees. Fees paid by the Plan to Union Bank & Trust Company were \$4,662 and \$2,752 for the period January 1, 2025 to April 30, 2025 and for the year ended December 31, 2024, respectively. Fees paid by the Plan to Invesco were \$420 and \$450 for the period January 1, 2025 to April 30, 2025 and for the year ended December 31, 2024, respectively. Additional indirect compensation was paid to Invesco, Union Bank & Trust Company, and Matrix Clearance and Settlement, which was included in net appreciation (depreciation) in fair value of investments. As described in Note B, the Plan Sponsor paid directly any other fees related to the Plan's operations.

**NOTE J - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through the audit report date, the date the financial statements were available to be issued.
