### **Report on the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Las Vegas Athletic Clubs 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Las Vegas Athletic Clubs 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective July 1, 2001. The Plan has been amended and restated throughout the years to comply with tax legislation and last restated January 1, 2022. The Plan excludes nonresident aliens and union employees. The Plan is subject to ERISA. The Plan Trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

**Eligibility**

Employees of Las Vegas Athletic Clubs (the Company and Plan Sponsor) are eligible to participate in the Plan after completing one year of service, with a minimum of 1,000 hours of service, and attaining age 21. To receive an allocation of the Company matching or nonelective contribution, a participant must be actively employed by the Company on the last day of the Plan year and work at least 1,000 hours during the Plan year. The participant will also receive an allocation if they have retired, become disabled, or deceased during the Plan year. Participants can enter the Plan after completing the eligibility requirements on the first day of the first month of the Plan year and on the first day of the seventh month of the Plan year.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a flat dollar amount, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified matching contribution or nonelective contribution to the Plan. During the year ended December 31, 2024, the Company elected to contribute \$30,000 in Company matching contributions. The Company match is calculated based on the ratio of the eligible employee deferral contributions made by each participant in comparison to the total amount of participant deferral contributions for the year. There was no Company nonelective contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of the contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's matching and nonelective contribution, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, elective deferrals, or account balances, or participant transactions, as defined in the Plan agreement. Participants direct the investment of their own contributions and the employer contributions into various investment options offered by the Plan through American Funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company discretionary matching and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is fully vested after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate at the time of the note plus 1%. Principal and interest is paid ratably through semi-monthly payroll deductions.

**Benefit Payments**

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce Company contributions or to pay administrative expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$1,789 and \$-0-, respectively. There were no forfeitures used to reduce Company contributions or to pay administrative expenses for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Contributions**

Contributions from participants and associated Employer matching contributions are recorded in the year in which the employee's compensation is paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed the excess contributions to the applicable participants prior to March 15.

**Administrative Expenses**

Administrative expenses consist of fees related directly to individual participant accounts. Other significant administrative expenses of the Plan are paid by the Company, as provided in the Plan document. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-ended that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest, rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC and is therefore not subject to tax under current income tax law. The pre-approved Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by American Funds. American Funds is the record keeper as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Nexus Administrators, INC (Nexus) charges administrative fees, including benefit payment fees and loan fees, to the Plan. Nexus is the third-party administrator of the Plan; therefore, these transactions qualify as party-in-interest transactions. Investment and custodial expenses that are paid to American Funds are deducted from investment returns.
