## Independent Auditors' Report

To the Plan Participants and Plan Administrator  
Host Hotels & Resorts, L.P. Retirement and Savings Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Host Hotels & Resorts, L.P. Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1. PLAN DESCRIPTION**

The following description of the Host Hotels & Resorts, L.P. Retirement and Savings Plan (the “Plan”) is for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General*

Host Hotels & Resorts, L.P. (the “Plan Sponsor”) is a majority owned subsidiary of Host Hotels & Resorts, Inc. (the “Company”). The Plan is a defined contribution plan established by the Plan Sponsor under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Plan Sponsor. The Plan covers all employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Culture and Compensation Committee of the board of directors of the Company (“CCC”) is responsible for oversight of the Plan. The CCC appoints a committee, commonly known as the Investment Committee, to control and manage the operation and administration of the Plan. The Investment Committee reports to the CCC. The Plan document was amended and restated effective January 1, 2019. T. Rowe Price Trust Company (“TRP TC”) is the trustee for the Plan.

T. Rowe Price Retirement Plan Services, Inc. (“TRP RPS”) provides certain administrative and recordkeeping services to the Plan pursuant to a recordkeeping agreement between the Plan Sponsor and TRP RPS. TRP RPS receives revenue from registered investment company or common/collective trust service providers for services TRP RPS provides to the companies/trusts. This revenue is used to offset certain amounts owed to TRP RPS for its administrative and recordkeeping services to the Plan through a credit to the Plan’s Fee Credits Account. The Fee Credits Account is a plan level account established by TRP RPS in connection with its services for the allocation of fee credits. Any amounts credited to the Fee Credits Account shall be allocated to the Plan’s participants in accordance with procedures adopted by the Plan Sponsor.

*Contributions*

Participants may elect to defer from 1% to 100% of their compensation, as defined by the Plan, subject to certain limitations under the IRC, including the annual limit on pre-tax contributions. The Plan requires employer matching contributions of 50% of the participants’ contributions, as defined by the Plan, up to 8% of each participant’s compensation, as defined by the Plan. The employer matching contributions are made through payroll period matches or a make-whole true up match. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, in accordance with IRS limits. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan immediately following the employee’s hire date, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a default fund designated by the Investment Committee until changed by the participant. Automatically enrolled participants’ deferral rate increases at a rate of 1% per year, on or about the anniversary of the participant’s hire date, until the rate reaches 8% or until changed by the participant.

The Plan also allows for discretionary employer matching contributions for each eligible participant. The CCC, in its absolute and sole discretion, declares a discretionary employer matching contribution for any plan year.

The CCC generally meets in the first quarter of the year following the plan year to determine whether a discretionary employer matching contribution will be declared, and if declared, the amount. A discretionary employer matching contribution that is declared is only allocated to those participants who are active employees of the Plan Sponsor on the date the contribution is paid to the Plan. There is no guarantee the CCC will declare discretionary employer matching contributions in future years. The CCC declared a discretionary employer matching contribution on February 6, 2024, of 50% of the participants' contributions, as defined by the Plan, up to 8% of each participant's compensation, as defined by the Plan, for the plan year ended December 31, 2023. This discretionary employer matching contribution totaled approximately \$1,170,584 and was paid into the Plan on February 23, 2024.

*Participant Accounts*

Individual accounts are maintained for each of the Plan's participants and are valued on a daily basis. Each participant's account is credited with the participant's contributions, employer matching contributions, and discretionary employer matching contributions, if applicable, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately fully vested in their contributions and the earnings thereon. A participant vests in their employer matching contributions, discretionary employer matching contributions, and earnings thereon according to the following schedule of service:

One year .....	33 %
Two years .....	66
Three years .....	100

*Notes Receivable from Participants*

All participants may borrow from their vested account balance. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of (a) \$50,000, reduced by the excess of (1) the highest outstanding balance of any previous loan from the Plan during the one-year period ending on the day before the date on which the current loan is made over (2) the outstanding balance of any previous loan from the Plan on the date on which the current loan is made or (b) 50% of a participant's combined after-tax, pre-tax, Roth, rollover, and employer contribution vested account balance. However, investments in participant-directed brokerage accounts are not available to fund loans.

Participants are required to repay the loan by regular payroll deductions over a period of up to five years. The Plan also offers principal residence loans (with terms up to 15 years). Additionally, interest rates are fixed and are equal to the Federal prime rate plus one percent when the loan is made. There is a \$50 processing fee per loan. For loans issued on or after October 1, 2018, an annual loan maintenance fee of \$25 per loan is charged. Participants may have no more than two loans outstanding at any one time and loans are secured by the balance

in the participant's account. Notes receivable from participants as of December 31, 2024 and 2023, bear interest ranging from 4.25% to 9.50%. As of December 31, 2024, loan maturity dates range from February 2025 to March 2032.

*Payment of Benefits*

On termination of service due to death, disability, retirement, or other termination of employment a participant may elect to: (a) receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, (b) roll over the value of the participant's vested interest in his or her account into an IRA or another qualified plan (c) receive monthly, quarterly or annual installments until the value of the vested account has been paid or (d) the vested balance may be applied to purchase a contract from a commercial insurance company that provides the participant with an annuity. If a terminated participant's vested account balance does not exceed \$5,000, the balance will automatically be paid into an individual retirement account designated by the Plan administrator, unless the participant elects a lump sum distribution in a timely manner. Participants may also receive hardship withdrawals, as defined by the Plan, in a lump-sum payment in an amount up to 100% of the participants' balance under certain circumstances other than those previously discussed.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$168 and \$7, respectively. The forfeited nonvested accounts are held in the T. Rowe Price Stable Value Fund. Forfeitures may be applied to restore forfeitures of Terminated Participants readmitted to the Plan, pay reasonable Plan expenses, or to reduce employer contributions. During 2024, no forfeitures were used to offset employer contributions.

**NOTE 2. SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("US GAAP").

*Use of Estimates*

The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan has investments in registered investment companies ("mutual funds"), participant-directed brokerage accounts, and in common/collective trusts. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor or Company. Expenses that are paid by the Plan Sponsor or Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 3. TAX STATUS**

The Plan document was amended and restated effective January 1, 2012. The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated September 20, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe the Plan, as amended, is designed and is being currently operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, there is no provision for income taxes included in the accompanying financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable federal and state tax authorities. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4. FAIR VALUE MEASUREMENTS**

US GAAP establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to

unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (Level 1):* Valued at the daily closing price reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Participant-directed brokerage accounts (Level 1):* Accounts primarily consist of mutual funds and common stocks that are valued using quoted prices in active markets for identical assets.

*Common/Collective Trust funds (Level 2):* The common/collective trust funds include a stable value fund that is comprised primarily of fully benefit-responsive investment contracts and other trust funds that primarily invest in registered investment companies. The funds have a readily determinable fair value using the net asset value as provided by the trustee. Participant transactions (purchases and sales) may occur daily at net asset value, and there are no restrictions on redemptions. Were the Plan to initiate a full redemption of the common trust funds, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments totaling \$100,018,707 and \$91,222,804 as of December 31, 2024 and 2023, respectively, are shares of registered investment companies and common collective trusts managed by TRP TC. TRP TC is the trustee for the Plan and, therefore, these transactions, as well as fees paid to TRP TC by the Plan, qualify as party-in-interest transactions.

The notes receivable from participants of the Plan are considered party-in-interest transactions as they are loans to and receivables from Plan participants.

**NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at

least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8. TRUSTEE CERTIFIED INFORMATION**

The Plan administrator has elected the alternative method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information certified by the trustee as complete and accurate includes investments at fair value, non-interest bearing cash and notes receivable from participants as of December 31, 2024 and 2023 included in the statement of net assets available for benefits; dividends, net change in fair value of investments and interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024; investment information as indicated in note 4, exclusive of identification of investment levels presented, and investments, as indicated in the Schedule H, Line 4i - Schedule of Assets (Held At End of Year) at December 31, 2024.

**NOTE 9. SUBSEQUENT EVENTS**

*Discretionary match*

The CCC declared a discretionary employer matching contribution on February 4, 2025, of 50% of the participants' contributions, as defined by the Plan, up to 8% of each participant's compensation, as defined by the Plan, for the plan year ended December 31, 2024. This discretionary employer matching contribution totaled approximately \$1,271,963 and was paid into the Plan on February 21, 2025.

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
