The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Physician's Computer Company 401(k) PS Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Physician's Computer Company 401(k) PS Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of Assets Held for Investment Purposes at End of Year and Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and

reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### A. DESCRIPTION OF PLAN

The following description of Physician's Computer Company 401(k) PS Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### 1. General

The Plan, adopted January 1, 1995, is a defined contribution plan, covering employees of The People's Computer Company, d/b/a Physician's Computer Company (the Company) who are age twenty-one or older, and have completed three months of service. Employees are eligible to enter the plan on the first day of the next quarterly entry date following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1975 (ERISA). The Plan assets are invested with Ascensus Trust Company.

#### 2. 401(k) Contributions

Participants may contribute up to 100% of eligible compensation, limited to a maximum amount as periodically set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

Eligible compensation is defined as reportable earnings on Form W-2, including elective contributions and pre-tax contributions to a cafeteria plan. Compensation excludes leave cashouts paid after severance from employment, and deferred compensation paid after severance from employment. Participants are permitted to make special deferral elections on bonuses.

Any eligible participant that does not affirmatively elect otherwise is automatically enrolled into the Plan with a deferral percentage of 3%. The participant can opt out of the Plan or change the percentage at any time.

#### 3. Employer Safe Harbor Matching Contribution

The Plan is a safe harbor plan, with 100% match of the first 3%, and 50% of the next 2%, of eligible compensation contributed to the Plan through salary deferrals. The safe harbor matching contributions were \$370,412 and \$339,723 in December 31, 2024 and 2023, respectively. Safe harbor matching contributions are invested as participants direct within the funds selected.

#### 4. Discretionary Profit-Sharing Contributions

The Company may contribute an annual discretionary contribution for each eligible employee employed at the end of the Plan Year, without regard to current or accumulated net profits of the Company. The contribution will be a flat dollar formula. In 2024 and 2023 the discretionary profit-sharing contributions were \$0. Discretionary contributions are invested as participants direct, within the funds selected.

#### 5. Participant Accounts

Each participant's account is credited with the participant's and the employer's contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses and investment fees based on the ratio of the participant's account balance to the balance of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant accounts are available online through the secure website of The Vanguard Group, Inc., the third-party administrator of the Plan, which allows participants to choose among various investment alternatives. The assets in the Plan are invested in available investment options and a separate account is established for each participant who receives and/or makes a contribution. The value of each participant's account is updated each business day to reflect any contributions, exchanges between investment options, investment earnings or losses for each investment option, and withdrawals.

#### 6. Vesting

Participants are immediately vested in their voluntary contributions, safe harbor match, and discretionary profit-sharing contributions, plus actual earnings thereon. Upon early retirement age, defined as 55 years and 10 years of service, death, or disability, a participant becomes fully vested.

#### 7. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial withdrawal. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account.

If the value of the terminated participant's vested balance is \$1,000 or less, the Plan maintains the right to immediately distribute the entire account balance. Effective January 1, 2024, if the terminating employee's vested balance is greater than \$1,000, but less than \$7,000, the Plan may have the account automatically rolled over to an individual retirement account (IRA) for their benefit. Previously, the limit was less than \$5,000.

#### 7. Payment of Benefits (continued)

Other withdrawals are allowed by the Plan for current employees. Participants still employed will be entitled to receive a distribution of all or any portion of their vested account balance upon attainment of age 59 1/2. Additionally, participants of any age may request an in-service distribution from their rollover contributions. Hardship withdrawals are allowed from their pre-tax and after-tax employee contributions accounts.

#### 8. Forfeited Accounts

When termination of service occurs, any non-vested portion of a participant's account is considered forfeited. These forfeitures may be used to reduce employer contributions. The amount of forfeitures used to reduce employer contributions in 2024 and 2023 was \$0. The balance of forfeited unallocated accounts was \$2 as of December 31, 2024 and 2023.

#### 9. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of 50% of their vested account balance, limited to \$50,000. Participants are limited to two outstanding loans at any time. The loans are secured by the vested balance in the participant's account. Loan terms shall not exceed five years unless for the purchase of a principal residence. The loans bear interest at the prime rate, currently 7.5% at December 31, 2024. The interest rate on outstanding loans is 3.25% to 8.5% for 2024. Maturity dates on loans range from 2025 to 2039. Upon termination, outstanding loans generally become due and payable in full immediately. In the event it is not repaid, the amount due is deducted from the vested balance as a deemed distribution. Deemed distributions were \$4,025 and \$0 in 2024 and 2023, respectively.

### B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### 1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America (U.S. GAAP) as applied to employee benefit plans, and in accordance with the Plan agreement.

#### 2. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan follows a three-level fair value hierarchy that prioritizes the inputs to measure fair value with the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements).

#### 2. Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a mutual trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### 3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### 4. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### 5. Payment of Benefits

Benefits are recorded when paid.

#### 6. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date that the financials were available to be issued.

### C. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### D. BENEFIT OBLIGATION

As of December 31, 2024 and 2023, the Plan had benefit obligations of \$1,948,722 and \$1,887,099, respectively, for terminated participants with vested balances, who had not withdrawn their funds.

### E. TAX STATUS

The Plan Sponsor has adopted the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Trustee and prototype sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan also uses a more-likely-than-not measurement for all tax positions taken or expected to be taken on a tax return in order for those tax positions to be recognized in the financial statements. If the Plan were to incur interest and penalties related to income taxes, these would be included in the provision for income taxes. Generally, the three tax years previously filed remain subject to examination by federal and state tax authorities.

### F. PLAN EXPENSES/PARTY-IN INTEREST TRANSACTIONS

Plan audit expenses are paid by the plan sponsor.

Investment advisory fees are paid by the plan sponsor to Mesirow Financial Investment Management, Inc. and totaled \$8,189 and \$10,210 for the years ended December 31, 2024 and 2023, respectively.

Certain plan investments are offered by Ascensus Trust Company. Ascensus Trust Company is the trustee, and therefore, these transactions qualify as party-in-interest.

As third-party administrator, The Vanguard Group, Inc. charges quarterly administrative fees of \$150 per new loan, \$75 per normal distribution, \$25 per required minimum distribution, \$20 per corrective distribution, \$25 per first periodic distribution and required minimum distribution and \$15 for each additional periodic distribution. Loan and distribution fees paid from the Plan to The Vanguard Group, Inc. totaled \$1,425 and \$705 for 2024 and 2023, respectively. Fees paid by the plan sponsor for contract administrator fees to The Vanguard Group, Inc. totaled \$12,371 and \$11,835 for the years ended December 31, 2024 and 2023, respectively.

### H. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Registered investment companies (mutual funds):* Valued at the closing price reported on the active market on which the individual securities are traded.

### I. MISSED DEFERRALS AND EMPLOYER MATCH

In September 2024 it was discovered that the Plan was not operating in accordance with the Plan document by incorrectly excluding certain eligible pay codes from eligible compensation in the calculation of participant deferrals and related employer match.

In July 2025, the Company deposited employer match and related earnings totaling \$3,349 for two participants who missed deferrals from their CTO payouts. This is included in other employer contributions at December 31, 2024.

The Company is currently working with The Vanguard Group, Inc., to determine the full impact of the remaining excluded compensation and is evaluating their options for correction. The financial impact has not yet been determined, therefore, no accrual has been made for the year ended December 31, 2024.

### J. PROHIBITED TRANSACTIONS

During 2024, the Company failed to remit three deposits of employee contributions and loan repayments to the Plan within the time provided by DOL guidelines. In accordance with DOL regulations, the late transmitted deposits were reported on Form 5500 in 2024. The third-party service provider will calculate if there was lost earnings, interest, and will determine if excise taxes are due on the late deposit.

### K. SECURE 2.0 ACT OF 2022

In December 2022, the Securing a Strong Retirement Act (Secure 2.0) was signed into law. Certain provisions of Secure 2.0 were effective in 2023, whereas other provisions are effective for 2024 or later years. The provisions include both required and optional elements, the Plan Trustees will determine the optional provisions to elect. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended for Secure 2.0 by December 31, 2025.

### L. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
