## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
**Paramount Staffing Perm, LLC 401(k) Profit Sharing Plan & Trust**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of **Paramount Staffing Perm, LLC 401(k) Profit Sharing Plan & Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

## Note 1 – Description of the Plan

The following description of Paramount Staffing Perm, LLC. 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### *General and Amendments*

The Plan was originally established June 18, 2018 as a defined contribution plan covering employees of certain subsidiaries of Proman Group, Inc. (the Company) who have 3 months of service and are age 21 or older, with certain exceptions including highly compensated employees and temporary employees, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). In 2024, the Plan was amended to require 250 hours of service but eliminate the 3 months of service requirement.

### *Contributions*

Each year, participants may contribute in either dollars or whole percentages a percent of pretax compensation, as defined by the plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 50 percent of the first 6 percent of eligible compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. No profit-sharing contributions were made during the year ended December 31, 2024 or December 31, 2023. Contributions are subject to certain IRS limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's voluntary contribution and the Company's matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are vested immediately in their contributions, the Company's matching and profit-sharing contributions plus actual earnings thereon.

### *Notes Receivable from Participants*

Participant loans are permitted in accordance with the Plan's established loan procedures. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account. Loans shall bear an interest rate at the prime rate and will be fixed for the duration of the loan. The loan must provide at least quarterly payments under a level amortization schedule, generally, the administrator will require that principal and interest payments are paid ratably through payroll deductions.

### *Investment Options*

The assets of the Plan, both employee and employer, are allocated to the various funds at the direction of the participant. The Plan offers various investment options. A participant may maintain their entire account in one of the funds or may elect to split their account among the funds in accordance with the Plan.

Participants may change their investment direction of future contributions and may elect to transfer their existing account balances from one fund to another daily.

**Note 1 – Description of the Plan (continued)**

***Payment of Benefits***

On termination of services due to death, disability, or retirement a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, annual installments or partial withdrawals. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Additionally, under certain circumstances, participants may be eligible to receive a distribution from the Plan due to financial hardship.

***Forfeited and Non-allocated Accounts***

Under this Plan, participant accounts are 100% vested at all times. As of December 31, 2024 and 2023 there was \$542 and \$11,813, respectively, in non-allocated accounts due to excess earnings on Plan corrections and other adjustments. Any amounts that may otherwise be forfeited or corrected under the Plan shall be used to reduce the contribution of the employer or be used to pay any administrative expenses of the Plan, following applicable Department of Labor guidelines. There was \$11,826 used to reduce employer contributions in 2024. There were no amounts used to reduce employer contributions during 2023. There was \$8 and \$13 used to pay plan administrative expenses in 2024 and 2023, respectively.

***Plan Termination***

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will be entitled to a distribution equal to his or her contributions, his or her share of Company contributions, investment income and loss, and unrealized appreciation or depreciation in the fair value of investments.

**Note 2 – Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation in fair value as presented includes both realized and unrealized gains, as well as interest and dividends earned during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Accordingly, no allowance for credit losses is included in these financial statements.

***Payment of Benefits***

Benefit distributions are recorded when paid.

### Note 2 – Summary of Significant Accounting Policies (continued)

#### *Operating Expenses*

The Company pays a portion of the administrative expenses on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### Note 3 – Certified Investment Information

The Plan management has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the Plan's information as of December 31, 2024 and 2023 and for the years then ended, included in the Plan's financial statements and supplemental schedule, that was prepared by, or derived from, information prepared by Transamerica Life Insurance Company, the custodian of the Plan, and furnished to plan management. The Plan management has obtained certifications from the custodian that the information is complete and accurate.

### Note 4 – Investment Contract with Insurance Company (Stable Value Option)

The Plan has a fully benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). The Stable Value Option investment choice is a non-tradable obligation of Transamerica. Transamerica maintains its investments in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. This type of investment is considered fairly valued at contract value. The occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable. (If an event should ever occur such as a significant decline in creditworthiness of Transamerica, the Stable Value Option investment choice may no longer be considered fully benefit-responsive.) Prior to January 1<sup>st</sup> and July 1<sup>st</sup> the effective rate of interest is established for the corresponding six month period. Interest is credited, based upon the daily value, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the Stable Value Option investment choices. The average yield for the years ended December 31, 2024 and 2023 was 1.58% and 1.18%, respectively.

**Note 5 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

*Level 3* - Inputs are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled Separate Accounts (PSA)*: PSAs investing in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets and are considered Level 1. PSAs directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities are considered level 2.

*Stable Value Fund*: This is a depository liability with no formal underlying maturities, and it is considered fairly valued at contract value and considered a level 2 investment.

**Note 6 – Tax Status**

On August 1, 2023, the IRS stated that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan, as then designed, is acceptable for use by employers for the benefit of their employees under Internal Revenue code (IRC) 401. The Plan has not received a determination letter specific to the plan itself; however, the plan administrator believes that the plan and subsequent amendments are designed and the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing authorities, however, there are currently no audits for any tax period in progress.

As of December 31, 2024, the Plan’s Annual Return/Report of Employee Benefit Plan generally remains open for three years.

**Note 7 – Party in Interest Transactions**

Certain plan investments are shares of separate pooled accounts managed by Transamerica Life Insurance Company, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 – Subsequent Events**

Effective January 1, 2025 the Plan was restated and became known as Proman Staffing Group 401(k) Plan and another qualified Plan merged into the existing Plan

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.
