Note 1 - Plan Description

The following brief description of the Gordon Aluminum Industries, Inc. Hourly Supplemental Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution pension plan covering substantially all employees who are members of Local 811, The International Association of Bridges, Structural and Ornamental Ironworkers and have completed one hour of service with Gordon Aluminum Industries, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions

Participants may defer up to 100% of their compensation as a pre-tax or Roth contribution each year not to exceed the thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes to the Plan an amount per hour of pay per the union contract as supplemental nonelective contributions. Per the 2022 union contract, the Company was to contribute \$1.05 per hour to the Plan, which continues through October 31, 2025. The Company also contributes a matching contribution to the Plan per the union contract as an additional contribution. Per the 2022 union contract, the Company will also contribute 50% of the amount contributed by the participant on the first 3% of participant contributions. Additional amounts may be contributed at the option of the Company. There were no additional contributions in 2024 or 2023.

Participant Accounts and Rollovers

Each participant's account is credited with the participant's contributions, Company supplemental nonelective contributions, and Company match contributions as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions as defined in the Plan agreement. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are 100% vested upon entering the Plan in their employee contributions plus actual earnings thereon. Vesting in the Company supplemental nonelective contributions and match contributions and earnings thereon vest after one year of service in which more than 1,000 hours is worked.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans bear an interest rate of prime plus 1%. Loan repayment terms follow payroll with bi-weekly repayments not to exceed five years, except in the case of a home loan in which the maximum repayment period is fifteen years.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant (or beneficiary in the case of death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount or in installments paid over a period of years selected by the participant that is less than the life of the participant payable on an annual, quarterly, or monthly basis. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59½.

Forfeited Accounts

The Plan provides that upon a participant's termination, the participant's non-vested interest in their account is forfeited when the participant receives a distribution of the entire vested interest and that forfeitures will be used to reduce the Company's supplemental nonelective or matching contributions. Forfeitures utilized to reduce employer contributions were \$7,070 and \$28,856 for the years ended December 31, 2024 and 2023, respectively. There was a balance in the forfeited accounts of \$6,903 and \$7,937 as of December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follow.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or be paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3 - Tax Status

The Company adopted the Plan based on the American Funds Distributor, Inc. prototype non-standard 401(k) profit sharing plan, described in Note 1. The prototype has received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Pooled separate account contracts with an insurance company are valued at the net asset value (NAV) as a practical expedient. The NAV as a practical expedient, as provided by the custodian, is used to estimate fair value. The NAV as a practical expedient is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV as a practical expedient is an estimate of fair value and is therefore excluded from the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while that Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of funds managed by John Hancock Life Insurance Company (John Hancock). John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services to John Hancock amounted to \$33,211 and \$33,381 for the years ended December 31, 2024 and 2023, respectively. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the plan at no cost to the Plan. Additional investment fees paid to the trustee are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

John Hancock provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and John Hancock. John Hancock receives revenue from fund service providers for services John Hancock provide to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the Plan.

If the revenue received by John Hancock from such fund service providers exceeds the amount owed under the MSA, John Hancock remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Company may make a payment to John Hancock for administrative expenses not covered by revenue sharing.

Note 7 - Information Certified by Plan's Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution.

Note 8 - Transfer of Funds to and from Another Plan

Gordon Aluminum, Inc. has two plans for the Company. One plan is for the non-union members and one plan is for the union members, which is this plan being audited. At times during the year, participants will change job positions. As a result, the participants will transfer their funds to the plan that is applicable to them after the job change. For the years ended December 31, 2024 and 2023, there were no transfers into the Gordon Aluminum Industries, Inc. Hourly Supplemental Savings Plan.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
