**NOTE 1 - DESCRIPTION OF PLAN**

The following description of *Backyard Service, LLC 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General*

The Plan was formed effective January 1, 2007, by Backyard Services LLC (the "Plan Administrator"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

*Eligibility*

The Plan covers all employees, as defined in the Plan, who have completed the age and service requirements. Participation occurs after completing these age and service requirements.

*Contributions*

Each year, participants may contribute a discretionary amount of pretax annual compensation, as defined in the Plan, up to the annual limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll-over amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes an amount equal to a discretionary percentage of the participant's elective deferrals, only elective deferrals up to 4 percent of the participant's compensation will be matched to the Plan. The matching contributions are invested in the same investment options as the participants' contributions to the Plan. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the participants. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the Participant's Interest and the Company's contribution portion of the balances in his or her account based on total years of service with the Company. Participants are vested 100% in the Participant's deferrals and Company's contribution after three years of service on graded schedule of 34% after one year, 67% after two years, 100% after three years.

*Notes Receivable from Participants*

Participants may borrow from the Plan under a loan program administered by the Plan Administrator. The minimum loan amount is \$1,000, and the maximum loan is limited to the lesser of \$50,000 reduced by the excess or 50% of the participant's vested account balance. Only one loan may be outstanding at any time. Loans are secured by the participant's vested account balance and bear a fixed interest rate equal to 2% above the prime rate at the time

of issuance. Loan terms generally range from one to five years; however, a longer term may be permitted if the loan is used to purchase a primary residence. Principal and interest are repaid in level installments not less frequently than quarterly, generally through payroll deductions. If a participant defaults on a loan, the unpaid balance is treated as a distribution and subject to applicable taxes.

*Payment of Benefits*

Upon retirement or separation from service, the participant may elect to receive a single lump-sum cash payment. Also, upon reaching age 59 ½, participants may receive a lump-sum cash payment for any portion of their vested accounts on a yearly basis. Until a participant actually retires from the employment, the participant shall continue to be treated in all respects as a participant.

*Hardship Withdrawals*

Participants may take a hardship withdrawal from vested deferral accounts if they have an immediate and heavy financial need. Permitted reasons include medical expenses, purchase of a principal residence, tuition, prevention of eviction/foreclosure, funeral expenses, casualty repairs to a residence, and certain federally declared disaster expenses. Withdrawals are limited to the amount of the need (including taxes/penalties) and require participant certification of insufficient resources.

*Forfeitures*

Forfeitures attributable to matching contributions will be used to reduce Company contributions to the Plan. Forfeitures attributable to the discretionary profit-sharing contributions will be added to the discretionary profit-sharing contributions and allocated to participants eligible to share in such contribution. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,280 and \$20,075 respectively.

*Plan Termination*

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Method of Accounting*

The Plan follows the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investment Valuation and Income Recognition*

Investments in shares of registered investment companies are reflected in the financial statements at fair value, using quoted market prices. Unrealized gains or losses, as a result of changes in fair value, are recorded in income of the current period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on their ex-dividend date. Net

appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the Plan year to the end of the Plan year is included with realized gains/losses as net investment income/loss reported in the accompanying statement of changes in net assets available for plan benefits.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Certain administrative expenses are paid by the Plan Administrator. Management fees, asset fees, and account administrative expenses are paid by the participants.

*Use of Estimates*

The preparation of financial statements, in conformity with generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN (UNAUDITED)**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA 2024 and 2023. Accordingly, Voya Retirement Insurance and Annuity Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 to December 31, 2024.

**NOTE 5 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1 Fair Value Measurements*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements*

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities; See the independent auditors’ report.
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Guaranteed investment contract:* Valued at contract value by the Plan at year end.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year end.

*Guaranteed Investment Contract:* The Plan has an investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the 401(k) contributions, as directed by the participants in mutual funds and investment contract. The Fixed Account is a fixed interest contract with guaranteed interest rates. The Fixed Account is an obligation of the Company's General Account and is generally a required contract Investment Option. Voya guarantees that interest will be credited to the Fixed Account at an annual yield that is at least equal to the minimum guaranteed interest rate shown on the Contract Schedule. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As permitted by ASC 820-10-35-54A, investments measured at contract value as a practical expedient are not classified within the fair value

hierarchy (Level 1, Level 2, or Level 3). The contract is included in the financial statements at contract value of \$210,145 as reported to the Plan by Voya.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions could result in a different fair value measurement at the reporting date.

**NOTE 6 - TAX STATUS**

Although the Plan has not requested determination from the Internal Revenue Service as to the Plan’s tax-exempt status, the master prototype plan which the Plan adopted has received favorable determination from the IRS. Plan management believes that the Plan is designed to operate in accordance with all applicable provisions of the Internal Revenue Code. Therefore, management believes that the Plan is qualified and the related trust is exempt from taxation under the Internal Revenue Code. The Plan Administrator is not aware of any action or event that has occurred that might affect the Plan’s qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no

uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan Sponsor would be liable for interest and penalties, if any, related to unrecognized tax benefits. The Plan's Forms 5500 are subject to examination by the respective taxing authorities, generally for three years after they were filed.

**NOTE 7 – PARTIES IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Voya Retirement Insurance and Annuity Company ("Voya"). Voya serves as the Plan's custodian, and accordingly, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services totaled \$50,219 for the year ended December 31, 2024.

Morgan Stanley acts as the financial advisor to the Plan. Indirect compensation received in connection with these services amounted to \$22,157 for the year ended December 31, 2024.

Jason F. Clausen, P.C. is the auditing firm for the plan. Fees paid for the audit were paid by the Plan Administrator.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**NOTE 9 – FIDELITY BOND**

As of December 31, 2024, the plan was covered by a fidelity bond in the amount of \$1,000,000.

**NOTE 10 – RECONCILIATION OF FORM 5500 TO AUDITED FINANCIAL STATEMENTS**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), whereas Form 5500 is prepared on a modified cash basis of accounting as required by the Department of Labor. As a result, certain differences may arise between the financial information reported in the Form 5500, the Voya fund statements, and the Plan's audited financial statements.

As of December 31, 2024, the Employer contributions receivable reported on the Form 5500 was \$0, while the financial statements report \$19,358. This difference of \$19,358 is attributable to timing differences in the recording of transactions and minor adjustments related to accruals that are reflected in the financial statements and Form 5500 but not yet fully accounted for in the Voya fund statements.
