## **Basis for Opinion**

#### Note 1 - Plan Description

The following description of the 401(k) Tech Collective Plan (the Plan) provides only general information. Participants should refer to the Plan document and the applicable participation agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a pooled employer plan (PEP) established by HR Benefits Inc (the Sponsor), the pooled plan provider. Each participating employer elects their own provisions related to eligibility, contributions, and vesting. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - Charles Schwab Trust Bank (Schwab) is the Plan's asset custodian and trustee and NWPS provides recordkeeping and other administrative services.

**Eligibility** - Participating employers have various service requirements which range from one month to six months of service in order to participate in the Plan. There is no age requirement to be eligible for participate in the Plan.

**Contributions** - Participants may elect to defer up to 100% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). Certain participating employers have elected to include a provision whereby all newly eligible employees are automatically enrolled at deferral rates ranging from 3% to 6% unless they elect a different deferral rate or not to participate in the Plan. Effective January 1, 2025, new participating employers adopting the Plan will have a 10% automatic enrollment rate.

Participating employers may elect to make discretionary or fixed matching contributions. There were 22 participating employers that made matching contributions during 2024 with varying formulas, resulting in maximum matching contributions ranging from 1% to 4% of compensation. Participating employers may also elect to make discretionary nonelective contributions. One participating employer made discretionary nonelective contributions equal to 3.5% of compensation during 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, employer contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Full vesting for other employer contributions occurs after three to six years of credited service depending on participating employers' elections.

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$80,000 and \$31,000, respectively. During 2024, approximately \$37,000 in forfeitures were used in accordance with the provisions specified in the Plan document.

**Transfers** - During 2024, the accounts of all current and former employees of Freespira, Inc., a newly added participating employer, were spun-off from the Justworks Retirement Savings Plan and transferred into the Plan. In addition, certain employers have terminated their participation and transferred assets out of the Plan. Assets transferred into and out of the Plan during 2024 in connection with these actions are listed below:

**Payment of Benefits** - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Notes Receivable From Participants** - A participant may borrow the lesser of \$50,000 or 50% of his or her vested balance, with a minimum loan of \$1,000. Loan terms range from one to five years unless the loan qualifies as a home loan in which case the repayment term can be extended. The interest rate is set at 2.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The accompanying financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under that basis, certain additions are recognized when received and certain deductions are recognized when paid. The modified cash basis of accounting differs from GAAP primarily because the effects of contributions receivable and expenses payable are not included in the financial statements.

In the prior year, management prepared the financial statements in accordance with GAAP. Management evaluated the application of the modified cash basis of accounting to the 2023 presentation. The accruals recorded as of December 31, 2023, were not adjusted because the change in the basis of accounting does not yield materially different results.

**Use of Estimates** - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Note 2 - Continued

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Expenses for recordkeeping, advisory, and professional services are paid by the Plan, unless otherwise paid by participating employers. Expenses that are paid by participating employers are excluded from these financial statements. Transaction based fees for loans and distributions are charged directly to participant accounts.

**Subsequent Events** - During 2025, assets of approximately \$8,018,000 have been transferred out of the Plan in connection with certain employers terminating their participation in the Plan.

The Plan's management has evaluated subsequent events through October 8, 2025, the date on which the Plan's financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time and are valued based on this published price.

#### Note 4 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### **Note 5 - Party-in-Interest and Related Party Transactions**

The Plan holds a mutual fund managed by an affiliate of Schwab. Therefore, transactions with this investment and fees paid from the Plan to Schwab qualify as party-in-interest transactions. Fees paid by the Plan to its other service providers also qualify as part-in-interest transactions. The Plan also issues loans to participants which are party-in-interest transactions.

The Sponsor receives payments from participating employers and the Plan for administrative services provided by the Sponsor and to pay the Plan's service providers. During 2024, the Sponsor received approximately \$574,000 and paid out approximately \$237,000 to the Plan's service providers.

#### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### **Note 7 - Tax Status**

The Sponsor and participating employers adopted a Harlowe & Falk LLP pre-approved plan document. Harlowe & Falk LLP received an approval letter from the IRS dated September 21, 2022, which states that the form of the plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan provides for various investment options, which in turn invest in a combination of investment securities such as stocks, bonds, and others. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Delinquent Contributions**

The Sponsor determined there were pay dates during 2024 and 2023 in which participant deferral contributions and loan repayments were not deposited by participating employers as plan assets within the time limitation stipulated under the Department of Labor's regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and participating employers. For delinquent contributions occurring in the 2023 plan year, lost earnings were restored to the Plan during 2024. Lost earnings associated with \$134,820 of delinquent contributions for the 2024 plan year were restored to the Plan during 2024. Lost earnings for the remaining \$77,236 of delinquent deposits were restored to the Plan in 2025.
