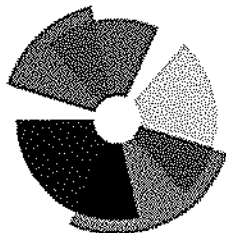

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Coast Citrus Distributors, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Coast Citrus Distributors, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4(i) – Schedule of Assets as of December 31, 2024 and Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following brief description of Coast Citrus Distributors, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all non-union employees of Coast Citrus Distributors, Inc. (the "Employer" or "Company") who have completed six months of service. The Plan was originally established July 1, 1981 as a profit sharing plan and was amended and restated in its entirety, effective July 1, 1998, in order to qualify under the provisions of the Internal Revenue Code of 1986 (the "Code"), and any amendments thereto, and under any rulings or regulations adopted by the Department of Labor ("DOL") and/or the Department of Treasury. The Company serves as administrator of the Plan. The Plan engages Fidelity Management Trust Company (the "Trustee") (see Note 8) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan is a savings plan that allows employees to defer a portion of their salaries for income tax purposes through contributions to the Plan and the investment of such contributions in the funds offered by the Plan. Participants may contribute up to 60% of their compensation each year up to the maximum amount permitted under the Code.

The Company is required to make matching contributions to the Plan equal to 25% of each participant's annual deferred contribution, provided that the total of such matching contributions does not exceed 6% of the employees' annual compensation and Internal Revenue Service ("IRS") deferral limitations.

The Company may also make a discretionary profit sharing contribution each year. Discretionary contributions are allocated to a participant's account based on the ratio of the participants' salary to the total of the annual salaries of all non-union qualified employees. For participants to qualify for an allocation from discretionary contributions, they must be employed by the Company on the last day of the Plan year and have completed 1,000 hours of service. A discretionary contribution of \$200,000 and \$300,000 is included in employer contributions receivable at December 31, 2024 and 2023, respectively.

A participant may, with the consent of the Plan Administrator, make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from a qualified savings plan in which an employee participated prior to employment with the Company.

The Plan provides that participants who will be age 50 or older by the end of the calendar year and who are making contributions to the Plan may also make a catch-up contribution of up to \$7,500.

Participation

An employee may join the Plan on the first day of each Plan year and the first day of the fourth, seventh and tenth month of each Plan year coinciding with or next following the date eligibility requirements are met.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, the Employer's matching contribution and an allocation of (a) the Employer's discretionary profit-sharing contribution (if any), (b) Plan earnings or losses, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled upon termination of service is equal to the vested benefit in the participant's account.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provisions implemented in 2024 include, among others, an increase in the required minimum distribution age from 72 to 73, reduced service requirements for long-term, part-time employees to participate in the Plan, and remove the pre-death required minimum distribution requirement for Roth accounts. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

Participants' Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. These investment options consist of mutual funds and a stable value fund. Participants may change their investment options at any time throughout the year.

Vesting

Participants are 100% vested in their voluntary contributions to the Plan plus actual earnings thereon at all times. All other contributions or credits to the participant's account vest at the rate of 20% per year of service.

Notes Receivable from Participants

Participants may obtain loans from the Plan which are secured by the vested balance in the participant's account. The maximum amount that may be borrowed from the participant's vested account balance is the lesser of \$50,000 or 50% of the vested account balance. These loans are pre-approved by the Company and the Trustee, except for loans to purchase a principal residence, and bear interest at prevailing market rates of 4.25% to 6.25% as of December 31, 2024 and 2023. Loan payments are made through payroll deductions over a period that may not exceed five years from the date the loan was made, unless the loan will be used to acquire a principal residence, in which case the repayment period may not extend beyond ten years from the date of the loan.

Distributions

Participants are entitled to a distribution of their vested benefits in the event of retirement, death, disability, termination of employment or termination of the Plan. The distribution may be taken through one of the following methods: lump sum payment, monthly or annual installment annuities

Distributions (continued)

or life annuities. The method depends on marital status, as well as elections made by the participant. All methods of distribution have equivalent values. At December 31, 2024 and 2023, net assets available for plan benefits included \$0 for distributions payable to participants who have withdrawn from the Plan prior to the end of the Plan year.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardship as defined in the Plan agreement.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$745 and \$27,003, respectively. Forfeitures are retained in the Plan and will be used to pay administrative expenses under the Plan or to reduce future Employer contributions as directed by the Employer. During the year ended December 31, 2024, \$50,763 of forfeitures were applied to reduce Employer contributions.

Subsequent Events

The Plan administrator has evaluated subsequent events, as defined by Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 855, Subsequent Events, through the date that the financial statements were available to be issued on August 25, 2025.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Substantially all costs associated with administering the Plan are paid by the Company.

Note 3 - Fair Value Measurements

The Plan's investments in mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, accounting rules for fair value measurements establish a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three broad levels, which are described below:

- Level 1: Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.
- Level 2: Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets; or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.
- Level 3: Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the valuation methodologies used for assets measured at fair value.

Mutual funds: Investments in mutual funds are valued using market prices on active markets (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Stable Value Fund

The Putnam Stable Value Fund invests in guaranteed investment contracts issued by insurance companies and other financial institutions, security-backed investment contracts, money market instruments and cash equivalents. There are no unfunded commitments, participant withdrawal restrictions or other redemption restrictions. The funds may be redeemed daily. The fund is benefit responsive, and thus, is reported at contract value.

Note 5 - Related Party Transactions

Certain Plan investments are managed by the Trustee, therefore, these transactions qualify as exempt party-in-interest transactions. All other transactions, which may be considered exempt parties-in-interest transactions, relate to normal Plan management and administrative services.

Note 6 - Income Tax Status

The Plan has adopted a prototype plan and relies on the prototype plan's opinion letter from the IRS. The Plan has been amended since receiving the determination letter. However, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Code and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Plan Termination

The Company intends to continue the Plan indefinitely but reserves the right to terminate it at any time. Upon termination of the Plan, all participants will become fully vested in their account balances under the Plan, subject to provisions of ERISA.

Note 8 - Information Certified by the Trustee

The Company has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the Company the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation or depreciation in fair value of investments, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the supplemental schedule of assets (held at end of year).

Note 9 - Risks and Uncertainties

The Plan invests in various mutual funds and a stable value fund. Mutual funds and the stable value fund are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds and the stable value fund, it is at least reasonably possible that changes in the values of mutual funds and the stable value fund will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

During the year ended December 31, 2023, the Company failed to timely deposit employee deferrals, totaling to approximately \$20,000 within the timeframe required by the Department of Labor guidance. During the year ended December 31, 2024, the Company failed to timely deposit employee deferrals, totaling to approximately \$53,000 within the timeframe required by the Department of Labor guidance. Late deposits are considered prohibited transactions and are included in the supplemental schedule, Schedule H, Line 4(a) – Schedule for Delinquent Participant Contributions for the year ended December 31, 2024. The 2023 and 2024 late deposits will be corrected in 2025.
