### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Harry Lawall & Son 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

The following description of the Harry Lawall & Son 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

Harry J. Lawall & Son, Inc. is affiliated with other entities, Lawall at Hershey, Inc. (Lawall Hershey), Lawall Prosthetics & Orthotics, Inc. (Lawall Delaware) and Lawall P&O of Florida (Lawall Florida), through common ownership. The Plan is a contributory, defined contribution 401(k) plan available to qualifying employees of Harry J. Lawall & Son, Inc., Lawall Hershey, Lawall Delaware and Lawall Florida (collectively the Companies). Management of the Companies (the Plan Sponsor) is the Plan administrator. The trustee of the Plan is Fidelity Management Trust Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Companies. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

To be eligible to participate in the Plan, an employee must have attained the age of 18, completed at least one year of service and worked at least 1,000 hours during such Plan year. An eligible participant may enter the Plan the first day of each month. Employees covered by a collective bargain agreement are not eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Contributions*

Participants can contribute up to the lesser of 60% of pre-tax annual compensation, as defined by the Plan document, or \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans (rollovers). The Plan permits participants to designate contributions as Roth 401(k) contributions and allows the Plan to accept rollovers of Roth 401(k) rollover contributions. Participants may direct the investment of their account balances into various investment options offered by the Plan.

The Companies make safe harbor matching contribution in the amount equal to 100% of the first 3% of the participant's elective deferral contributions, plus 50% of next 2% of the participant's elective deferral contributions. At year-end, the Companies perform a true-up calculation of the employer matching contribution for all participants and makes any necessary additional matching contribution in the subsequent year. The true-up contributions of \$45,931 and \$49,476 for 2024 and 2023, respectively, are recorded as employer contributions receivable in the accompanying statements of net assets available for benefits.

The Companies may also make discretionary profit-sharing contributions to the Plan as determined by the Plan Sponsor. The contribution is allocated to all participants in accordance with an allocation formula as defined in the Plan. Participants are eligible to receive an allocation of this contribution after one year of service. There was no discretionary profit-sharing contribution for 2024.

The annual additions under the Plan are limited to the lesser of 100% of eligible compensation or Internal Revenue Service (IRS) limitations, established to be \$69,000 for the year ended December 31, 2024. Annual additions are defined as employee contributions, employer matching contributions and discretionary profit-sharing contributions, if any.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the employer matching contribution, an allocation of the discretionary profit-sharing contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of transaction fees based on activity including loan and investment advisory fees, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately vested in their voluntary contributions and the Companies' matching contributions plus allocated earnings thereon. Participants become vested in the Companies' discretionary profit-sharing contributions as follows:

### ***Forfeitures***

Forfeitures of nonvested participant accounts are used to reduce future employer contributions and to pay administrative expenses of the Plan. No forfeitures were applied to reduce employer contributions or to pay administrative expenses during the year ended December 31, 2024. Forfeitures outstanding as of December 31, 2024 and 2023 amounted to \$1,536 and \$90, respectively.

### ***Notes Receivable from Participants***

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000. A participant may have two loans outstanding at any time. The loans are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local borrowing rates. The loans are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans to purchase a primary residence, which may have a longer term. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC).

### ***Payment of Benefits***

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an individual retirement account (IRA) unless otherwise elected. Additionally, if the participant reaches age 59½, or, under certain circumstances of financial hardship the participant is allowed to withdraw funds from the Plan.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the amounts reported of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Companies make the respective payroll deduction from the participant's compensation. Profit sharing contributions, if any, are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and are deemed distributions recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

The Plan's administrative expenses are paid by the Companies or the Plan as provided in the Plan recordkeeping service agreement. Administrative expenses paid by the Companies may include expenses for professional services. Any expenses that are paid by the Companies are excluded from these financial statements. There is no guarantee that the Companies will continue to pay the Plan's expenses. Fees related to the administration of notes receivable from participants and investment advisory fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution, Fidelity Management Trust Company (Fidelity).

### **4. Fair Value Measurement**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement* provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* - Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - Self-directed brokerage accounts include investments in mutual funds, which are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. No more than 50% of a participant's account balance can be in a self-directed brokerage account.

*Common/Collective Trust* - The Plan has a common collective trust investment, Fidelity Managed Income Portfolio, with Fidelity. The interest of each participating participant is represented by trust units. Trust units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. The NAV is used as the practical expedient to estimate fair value. The investment is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Companies contributions.

The Companies may reduce or suspend employer matching safe harbor contributions upon satisfaction of certain requirements provided under Internal Revenue Bulletin No. 2013-50, including a 30-day advanced notice to all eligible employees.

## 6. Related Party and Party-In-Interest Transactions

The Plan invests in various investments managed by Fidelity Investments, an affiliate of the trustee. The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan in the Companies. Therefore, these transactions qualify as party-in-interest transactions, as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Companies, who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

### **7. Risks and Uncertainties**

The Plan is invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **8. Tax Status**

The Plan uses a pre-approved plan document sponsored by Fidelity, which received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan document was designed in accordance with the provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
