### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Little Rock Christian Academy 401(k) Profit Sharing Plan and Trust (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Basis for Opinion**

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Little Rock Christian Academy 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was initially effective January 1, 2001 and restated as of September 1, 2016, is a defined contribution plan maintained for the benefit of all employees of Little Rock Christian Academy (the Employer, Plan Sponsor and Plan Administrator), who have met eligibility requirements as defined in the Plan. Generally, employees are eligible to participate in the Plan upon hire.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Employer utilizes the services of John Hancock Trust Company, LLC (John Hancock), a third-party administrator and custodian, to process investment transactions, maintain participant account balances and act as trustee of the Plan's assets. Also, the Employer has entered into an agreement with Merrill Lynch, Pierce, Fenner & Smith Incorporated (Merrill Lynch) to provide investment advisory services related to the Plan's investment portfolio. Total fees paid by the Plan to John Hancock and Merrill Lynch were approximately \$41,000 for the year ended December 31, 2024.

The Retirement Plan Committee for the Plan is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$27,000 for the year ended December 31, 2024.

### **Contributions**

Participants may contribute up to 100% of annual compensation, as defined in the Plan, in the form of pre-tax salary deferral, after tax (Roth) salary deferral, or a combination of these options not to exceed limitations imposed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer may make a discretionary matching contribution on behalf of eligible participants equal to 50% of each participant's contributions not to exceed 5% of eligible compensation. In addition, the Employer may also make a discretionary profit-sharing contribution based on a formula as defined in the Plan document for employees who are employed on the last day of the Plan year and completed 500 or more hours of service during the Plan year. Employer contributions are subject to limitations imposed by the IRS.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's matching contributions and allocations of Employer profit sharing contributions and Plan earnings, net of certain administrative expenses. Allocations are generally based on participant earnings or account balances, as specified in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching contribution, discretionary profit sharing contribution and earnings thereon is based on years of credited service as follows:

### **Investment Options**

Contributions to the Plan are invested as directed by participants. Participants may invest in one or more of the various mutual funds or a collective investment trust fund offered by the Plan. Participants may change their investment options at any time.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans may be extended for periods not to exceed five years except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended up to thirty years. Loans are secured by the participant's vested account balance. Interest will be charged at 2% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid through payroll deductions.

### **Forfeitures**

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. As allowed under the Plan agreement, forfeitures are used to pay administrative expenses or reduce discretionary matching contributions. At December 31, 2024 and 2023, there were approximately \$900 in forfeitures available for future allocation. Forfeitures used to pay plan expenses or reduce discretionary matching contributions during the year ended December 31, 2024, totaled approximately \$14,800.

#### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value accumulated in his or her account in either a lump-sum amount or in periodic installments over a period to be selected by the participant (or beneficiary) from several options under the Plan. For termination of service due to other reasons, a participant may receive the value accumulated in his or her account as a lump-sum distribution or, if the account balance exceeds \$5,000 on the date of termination, may leave the account under the Plan until the participant reaches normal retirement age or dies.

#### **Hardship Withdrawals**

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the participant's vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

#### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain revenues and related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

**Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan’s investments, notes receivable from participants and related activity reflected in the financial statements and supplemental schedules was certified by the Plan’s trustee, John Hancock, as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedules.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2      Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

#### Mutual Funds and Money Market Funds

Investments in mutual funds and money market funds are valued based on published market prices, which represent the net asset value (NAV) of shares held at year-end (Level 1).

#### Collective Trust Fund

The Plan invests in the Goldman Sachs Stable Value Institutional Series Class 1 (GSS I) which is a collective trust fund measured using the fair value reported by the fund manager. The GSS I's investment objective is to seek to earn current income while preserving capital and maintaining principal stability. GSS I's strategy to achieve its investment objective is to invest in fixed income instruments which underlie Stable Value Contracts. Under Stable Value Contracts, the issuer of the contract agrees, subject to contract conditions, to make payments representing redemptions from the Fund for participant-initiated benefit payments at "book value".

**NOTE 5: TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated March 31, 2014, in which the IRS stated the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and as then designed, the related trust is exempt from income taxes.

The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan must file Form 5500 annually with the IRS, which is subject to examination generally for three years after it has been filed.

Plan management regularly evaluates its tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken by the Plan.

## ***NOTE 6: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain of the investment options available to Plan participants may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

## ***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through September 16, 2025, the date that the financial statements were available to be issued.

Subsequent to year end, the Plan was amended to add an automatic enrollment provision to the Plan agreement.
