### ***Opinion***

We have audited the financial statements of Custom-Pak, Inc. Employees' 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Custom-Pak, Inc. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Custom-Pak, Inc. Employees' 401(k) Retirement Plan is provided for general information purposes only. Participants should refer to the Plan description or the Plan document for more complete information.

**General.** The Plan is a defined contribution plan covering substantially all employees of Custom-Pak, Inc. (Company). Employees are required to have ninety days of service and to have attained age 18 for plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year participants may voluntarily contribute, on a pre-tax or post-tax basis, a portion of their compensation, up to the annual limits, to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes matching contributions of 75% of employee deferrals, with a maximum of \$2,000. The participants allocate their accounts for investment purposes among options offered through Fidelity Investments including mutual funds and a collective trust fund.

**Participant Accounts.** Each participant's account is credited with (1) the participant's voluntary contributions, (2) the Company's matching and discretionary contributions, if any, (3) Plan earnings and losses, and (4) administrative expenses. Allocation of the Company's discretionary profit sharing contributions, if any, is made in the ratio that each participant's compensation for the plan year bears to the total compensation of all eligible participants for the plan year.

**Vesting.** Participants are immediately vested in their voluntary salary deferrals and rollover accounts and gains and losses thereon. Vesting in the remainder of their accounts is determined on the basis of years of service. A participant is 100 percent vested after being credited with six years of service. Forfeitures of nonvested accounts are used to offset future Company contributions or plan expenses.

**Payment of Benefits.** Upon death, disability or retirement, participants will be entitled to payment of their entire account balance. In the event of termination of service, participants will be entitled to receive only the vested percentage of their account balance. Benefit payments can be taken as a single lump-sum payment or in installments based on life expectancy. Participants receive lump-sum distributions if their vested account balance does not exceed \$5,000 at the time of their termination of service.

**Notes Receivable from Participants.** Participants are permitted to borrow from their account balance a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. The loans are secured by the balance in the participant's account and bear interest at a rate of one percent above the published prime rate at the time of the loan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Custom-Pak, Inc. Employees' 401(k) Retirement Plan was established on January 1, 1989. The Plan is sponsored by Custom-Pak, Inc. The Plan year ends on December 31. Significant accounting policies followed by the Plan are presented below.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

**Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. The fair value of investments is based upon quotations obtained from national securities exchanges or, in the case of regulated investment funds, based on the quoted net asset value of the fund. Participant loans are valued at cost, which approximates fair value. The net appreciation (depreciation) in fair value of investments includes investments purchased, sold and held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Subsequent Events**

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Valued at the NAV of units of the collective trust. NAV is a readily determinable fair value and is the basis for the current transactions. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INCOME TAXES**

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and the trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Continued qualification of the Plan will depend on the operation of the Plan in compliance with IRS regulations.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed an intent to do so, Custom-Pak, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts, the Plan assets will continue to be held to pay benefits to all covered participants, and no assets can be returned to the employer.

**NOTE 6 - ASSETS ALLOCATED TO WITHDRAWN PARTICIPANTS**

The Plan has assets allocated to withdrawn participants of \$5,474,014 and \$3,754,741 at December 31, 2024 and 2023, respectively. These amounts are distributable to participants as of the Plan's year end, but disbursement from the Plan has not occurred as of that date.

**NOTE 7 - FORFEITURES**

At December 31, 2024 and 2023, forfeited nonvested accounts aggregating \$100,166 and \$61,890, respectively, are included in the Plan's net assets available for benefits. These accounts will be used to reduce future employer contributions. Forfeitures of \$179 and \$17,457 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

Certain Plan investments were shares of mutual funds managed by Fidelity Investments. Fidelity Investments was the asset custodian, as defined by the Plan and, therefore, those transactions qualify as party-in-interest.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect balances and the amounts reported in the statements of net assets available for benefits.
