## **Independent Auditor's Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Mathias Savings Incentive Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## MATHIAS SAVINGS INCENTIVE PLAN

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) DESCRIPTION OF THE PLAN:

The following brief description of the Mathias Savings Incentive Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General -

The Plan is a safe harbor defined contribution plan maintained by a group of related employers including Today's Bank, Mathias Properties Inc., Mathias Shopping Centers Inc., MP Construction of Springdale Inc., BSS, LLC, and Mathias Farm of Arkansas, LLC (the combined group is referred to as the "Company"). Today's Bank serves as Plan administrator. The Plan provides retirement benefits for employees who have attained twenty-one years of age and completed at least one hour of service during the first three months of employment.

The Trustees of the Plan, which consists of management-level employees, are responsible for the operation and administration of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions -

The Plan permits participant elective deferral contributions up to 80% of Plan compensation, subject to IRS limitations. The Plan also permits participants to make catch-up contributions and Roth deferrals. The Company makes safe harbor contributions of 3% of Plan compensation for all eligible employees. At its discretion, the Company may also make discretionary contributions to the Plan.

The Plan provides that, at the discretion of participants, contributions to the Plan will be invested in designated investment options offered by the Plan custodian, Nationwide Trust Company, FSB (Nationwide), including mutual funds and a guaranteed investment contract offered by Nationwide Life Company.

Participant accounts -

Each participant's account is credited with the participant's elective deferral contribution, if any, the Company's safe harbor contribution, as well as allocations of Plan earnings and administrative expenses. Allocations are based on participant account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account balance.

Vesting -

Participants are fully vested at all times with regard to their elective deferral and rollover contributions and the Company's safe harbor contributions. Participants become fully vested with regard to Company discretionary contributions after four years of service or upon death or disability.

(1) DESCRIPTION OF THE PLAN (continued):

Benefits paid to participants -

Participants who have attained age 59½ may elect to withdraw part or all of their account balance. Payments of participant benefits upon retirement, disability, or death are in a lump sum or partial lump sum. All other participants may elect to withdraw a portion of their account balance in the event the participant furnishes satisfactory evidence to the Plan administrator that the withdrawal is to alleviate a financial hardship.

Plan termination -

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested with respect to their Company matching or additional contributions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting -

The accompanying financial statements and supplemental schedules have been prepared using the accrual basis of accounting. Under the accrual basis of accounting, additions to and deductions from net assets, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred. Benefit payments are recorded upon distribution.

Estimates -

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition -

The Plan's investments, other than the fully benefit-responsive guaranteed investment contract, are reported at fair value as provided by Nationwide. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan invests in mutual funds through a group annuity contract with Nationwide. These funds are valued using daily unit values, which are calculated using the net asset value (NAV) of the units held by the Plan as provided by the administrator of the fund. The NAV used in the calculation of each fund's unit value is a quoted price in an active market. The Plan's guaranteed investment contract is valued daily by Nationwide Life Insurance Company at contract value as described in Note 7.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Fees charged by Nationwide in connection with sales of investments are reflected as a reduction of investment return for such investments.

Administrative expenses -

The Company pays a portion of expenses related to administering the Plan and provides the Plan with office space, equipment, administrative personnel, and certain outside consulting services at no charge. The Plan is responsible for certain recordkeeping, investment advisory, consulting, and other administrative fees.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Subsequent events -

Effective March 1, 2025, the Plan was amended and restated for a trustee declaration. Under the terms of the Trust, the trustee may only invest Plan assets as directed by the Plan administrator, the employer, an investment manager or other named fiduciary, or, to the extent authorized under the Plan, a Plan participant.

The Plan has evaluated subsequent events through October 9, 2025, the date these financial statements were available to be issued.

(3) RISKS AND UNCERTAINTIES:

Participants in the Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that such changes in values of investment securities could occur in the near term and those changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

(4) DERIVATIVES:

The Plan has limited transactions that are governed by FASB ASC 815, *Derivatives and Hedging*. The Plan did not use derivatives for trading purposes. The Plan owns shares in various mutual funds and in a guaranteed investment contract and the investment managers of those funds or underlying investments may use derivatives for asset management and hedging purposes.

(5) INCOME TAX STATUS:

On June 30, 2020, the Internal Revenue Service (IRS) stated that, as then designed, the non-standardized pre-approved profit sharing plan adopted by the Company effective January 1, 2022 was in compliance with the applicable sections of the Internal Revenue Code (IRC), and therefore, exempt from taxation. Although the plan has been amended as necessary to comply with applicable laws since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan has not incurred or recognized any interest or penalties related to uncertain tax positions. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(6) INVESTMENTS:

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and ERISA-required supplemental schedule that was prepared by or derived from information prepared by Nationwide, the custodian of the Plan, and furnished to the Plan administrator. The custodian of the Plan has certified to the completeness and accuracy of this information in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(7) GUARANTEED INVESTMENT CONTRACT:

The Plan invests in the Short-Term Indexed Fund through a guaranteed investment contract with Nationwide Life Insurance Company. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because this is the amount received by participants for permitted transactions under the terms of the Plan. Nationwide Life Insurance Company is contractually obligated to repay the principal and guaranteed interest of the contract (contract value) to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Nationwide Life Insurance Company maintains the Plan's deposit in a guaranteed fund. The guaranteed fund is equal to the total of all deposits made, plus interest and any exchanges from the companion contract, less any withdrawals made for the payment of benefits, exchanges to companion contracts, or other charges in accordance with the contract terms. The contract crediting rate is reset quarterly based on the three-month Treasury Note yield and includes the guaranteed interest rate earned less any contract adjustments or charges assessed. The net crediting rate on the account at December 31, 2024 and 2023 was 4.42% and 4.82%, respectively.

(8) FAIR VALUE MEASUREMENTS:

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring and disclosing fair value under GAAP. The framework provides a fair value hierarchy based upon observable and non-observable inputs prioritized by the reliability of the assumptions used to measure fair value. The highest priority is given to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in inactive markets; other inputs that are observable for the assets or liabilities; or inputs derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to determining the fair value measurement and reflect the entity's own assumptions about the assumptions market participants would use in pricing assets or liabilities.

(8) FAIR VALUE MEASUREMENTS (continued):

Following is a description of the valuation methodologies used to value the Plan's assets measured at fair value:

Mutual funds are valued using daily unit values provided by Nationwide which are based on the daily closing price on the active market on which the funds are traded as reported by the funds.

The valuation methodologies described above may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets or liabilities could have resulted in a different fair value measurement at the reporting date.

The Plan recognizes transfers into and out of levels at the end of the reporting period. There were no transfers between levels during the year ended December 31, 2024.

Participants may initiate an unlimited number of redemptions or exchanges of mutual funds; however, these transactions may have been restricted by the fund provider if such restriction was deemed necessary to halt or mitigate the effect of any abusive trading practices that may have disrupted portfolio management strategies or harm fund performance.

(9) PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS:

During the year ended December 31, 2024 and 2023, the Plan had investments in a guaranteed investment contract with Nationwide Life Insurance Company and shares in various mutual funds offered by Nationwide. The Plan incurred fees to its third-party administrator totaling \$1,829 during 2024 for recordkeeping and contract administration services. The Plan also paid \$6,875 directly to Nationwide during 2024 for recordkeeping and custodial fees. These transactions are allowable party-in-interest transactions under ERISA.
