Opinion

We have audited the financial statements of TCI Holding Company, Inc. Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following brief description of TCI Holding Company, Inc. (the Company) Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Company established the plan effective January 1, 1988. The Plan was amended to qualify as an employee stock ownership plan (ESOP) as defined in Section 4975(e)(7) of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan sponsor engaged a corporate trustee (the Trustee) who engaged a valuation expert for the valuation of the employer stock and performed other fiduciary responsibilities in accordance with the Plan agreement and engagement letter between the Trustee and plan sponsor.

Effective January 1, 2017, Turesol, LLC, an affiliate, adopted the Plan.

Effective December 29, 2021, TCI Holding Company, Inc. assumed sponsorship of the Plan from Tunnell Consulting, Inc. in connection with a corporate reorganization. The Plan was then renamed to TCI Holding Company, Inc. Employee Stock Ownership Plan. In connection with the corporate reorganization, 23,963 shares that were held in treasury of the plan sponsor immediately prior to the reorganization were transferred to the Plan. The shares were allocated to participant accounts in proportion to the ownership immediately prior to the reorganization.

Eligibility

All non-bargaining unit employees of the Company and its participating subsidiaries are generally eligible to participate in the Plan immediately. Participants who are not employed on the last working day of the Plan year are generally not eligible for an allocation of the Company's contributions for such year. Prior to January 1, 2022, there were different eligibility requirements which included 1,000 hours of service or twelve months of employment along with an active employment status on both January 1 and December 31 of the plan year in order to be eligible for an allocation of the Company's contributions for the plan years between 2016 and 2021. Effective January 1, 2022, there is no longer a service requirement of 1,000 hours of service or twelve months of employment.

Employees who were initially hired by the Company and its participating subsidiaries to work on special projects shall not be eligible to participate in the Plan, unless they continue employment with the Company and its participating subsidiaries following the completion of the special project and complete the Plan eligibility requirements. Employees who are classified as "contingent workers" of Turesol, LLC are not eligible to participate in the Plan.

(1) Description of Plan, Continued

Employer Contributions

Amounts are contributed at the discretion of the Company's Board of Directors. Contributions may be paid in cash, or shares of the Company's stock as determined by the Board of Directors.

Payment of Benefits

Distributions on account of death, disability, termination of service or retirement are made in annual installments over a period not in excess of five years. Employees who terminate with an account balance less than \$1,000 will receive a lump sum distribution by the close of the plan year following their termination. The amount to be distributed is based upon the annual account valuation date immediately preceding the distribution. The Company's current practice is to make all distributions in cash due to the Company's election of the S corporation filing status.

Administrative Expenses

As provided in the plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses of the Plan. Expenses paid by the Company are excluded from these financial statements.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the vested shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to the Plan's provisions. Upon such termination of the Plan, the interest of each participant in the trust fund shall immediately become fully vested and shall not thereafter be subject to forfeiture. The total amount of an affected participant's account may be paid in a lump sum or may be retained in trust for disposition under the terms of the Plan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock, employer contributions, earnings and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning account balance to the beginning plan assets.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants begin vesting after two years of service and vest at the rate of 20% per year. They are 100% vested after six years of service.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company may pay for the purchase with interest over a period not in excess of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. A participant who has attained age 55 and completed 10 years of participation in the Plan may elect to diversify a portion of their account either through investments chosen by the Trustee within the Plan or through another qualified plan maintained by the Company. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested account balances are allocated to remaining participants.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 5 for fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

(3) Tax Status

The Plan adopted a non-standardized, non-mass submitter form of a plan document sponsored by Stevens & Lee, P.C. The non-standardized, non-mass submitter plan document has received a letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the submitter plan's qualified status. The non-standardized, non-mass submitter plan opinion letter has been relied upon by this Plan. The Plan has been amended since the date of the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust was tax exempt as of the financial statements date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits in progress other than the 2021 plan year which is currently being audited by the IRS.

(4) Administration of Plan Assets

The Plan's assets, which consist principally of the Company's common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officers or employees receive compensation from the Plan. Administrative expenses for the Trustee fees are paid directly by the Company.

(5) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in active markets
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liabilities have a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

TCI Holding Company, Inc. Common Stock: The stock of the Company is not actively traded and significant other observable inputs are not available. The fair value of the sponsor Company common stock held by the Plan is valued at fair value based upon an independent appraisal. The appraiser identified and analyzed publicly-traded companies or guideline companies that share similarities to the subject company, to derive indications of value. The appraiser took into account historical and forecasted cash flows, adjusted EBITDA, and adjusted net income, weighted average cost of capital, return on assets, return on equity and market comparisons. The Trustee has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves the selection of an independent appraiser approved by the Trustee. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan management and the Trustee review and approve the appraiser report before it is finalized.

Money market fund: Valued at the daily closing price as reported by the fund. The fund held by the Plan is an open end fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value and to transact at that price. The fund held by the Plan is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value of Level 3 Investments

During 2024 and 2023, there were no transfers into or out of the level 3 investments and no purchases of the investment included in level 3 of the fair value hierarchy. The unrealized loss on the Company's common stock is included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

(6) Related Party and Party-In-Interest Transactions

The Plan invests in Company common stock. During the year, the Company contributed \$4,900,000 to the Plan. The Plan has several service providers. Such providers are parties-in-interest under ERISA.

Certain expenses for the operation of the Plan are paid by the sponsor, such as the plan investment and appraisal fees, which are excluded from these financial statements.

(7) Risks and Uncertainties

The Plan invests in the Company's common stock and a money market fund. The investments are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
