Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of the Plan

The following description of the iLAB, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan was established January 1, 2018 and is a defined-contribution plan sponsored by iLAB, LLC (Company) for the benefit of its employees. Employees who are 21 years of age are immediately eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Members of Company management serve as the trustees of the Plan. Charles Schwab Trust Bank is the custodian and the Nyhart Company is the recordkeeper.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee Roth and rollover contributions are also permitted. The Company contributes a safe-harbor match of 100% of the participant's contribution that are not in excess of 5% of eligible compensation. The Company may also make discretionary non-elective contributions, as determined by the Board of Directors. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 1% in the percentage deferred up to a maximum of 10% of compensation.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. Participants may also participate in a self-directed brokerage arrangement under the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and Company contributions plus earnings thereon.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,888 and \$7,179, respectively. These accounts will be used to either reduce future Company contributions or to pay administrative expenses, at the discretion of the Company. The forfeitures relate to prior year excess contributions deposited to the forfeiture account and are not actual forfeitures.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The loan interest rate is set at 2% above the prime rate, as defined by the Wall Street Journal. Only one loan may be outstanding at a time. Principal and interest is paid ratably through semi-monthly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Upon termination of service, participants receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Money market funds are valued at cost, which approximates fair value. The investments included within the self-directed brokerage account consists primarily of common stock and cash equivalents, which are valued at the closing price reported on the active market on which the investments are traded.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Tax Status

The Plan operates under a non-standardized defined contribution pre-approved plan sponsored by Ascensus, LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the pre-approved document has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Administrative Expenses

Administrative expenses are paid by the Plan or Company, at the Company's discretion.

Note 3. Certification by Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and noninterest-bearing cash as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statement of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan has no liabilities measured at fair value on a recurring basis. Additionally, the Plan has no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 % or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain investments managed by the Plan custodians. The Plan paid \$14,990 and \$10,868 of administrative fees to Nyhart in 2024 and 2023, respectively. Additional fees of \$27 were paid to other parties during 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Effective June 1, 2025, the Plan transitioned to a new recordkeeping system with Ascensus, LLC. The conversion initiated a blackout period beginning May 28, 2025 and continued through June 2, 2025. During the blackout period, participants were unable to obtain a loan, a distribution or direct or diversify the assets held in their accounts until the conversion was completed. Participant contributions continued to be withheld through payroll and employer contributions continued to be calculated until the conversion was completed, and the contributions were invested in funds as requested by the participant.
