**NOTE 1 - DESCRIPTION OF PLAN**

The following description of The Franklin Academy 401(K) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - The Plan is a 401(K) defined contribution plan covering all employees of The Franklin Academy, Inc. (the Employer) who are age twenty-one or older and has no service requirement. All investments in the Plan are participant-directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Board of Trustees oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.
- B. Contributions - For each Plan Year, the amount of the Employer's contribution is at the discretion of the Board of Directors, however, if no resolve is made the amount contributed shall be 50% of each eligible participant's salary savings contributions. No match will be made for contributions in excess of 6% of compensation. Participants may contribute the lesser of up to 25% of their annual wages or \$23,000 if under age 50 and \$30,500 if age 50 and over as per IRS limits for the years ended December 31, 2024. Participants may also elect to make after-tax Roth deferrals of \$7,000 if under age 50 and \$8,000 if age 50 and over as per IRS limits for the years ended December 31, 2024. Participants direct the investments of their contributions into various mutual funds offered by the Plan. The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in the Target Date Funds until changed by the participant.
- C. Participant Accounts - Each participant's account is credited with the participant's contribution, the Employer's matching contribution, and the investment earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings is based upon years of continuous service. A participant is 100 percent vested after four years of credited service.
- E. Forfeitures - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,544 and \$5,169, respectively. These accounts will be used to reduce future Employer's contributions. In 2024 and 2023, employer contributions were reduced by \$658 and \$4,567 from forfeited nonvested accounts, respectively.

- F. Payment of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive their vested interest in their participant account as either a lump sum cash distribution, a rollover or annuity, or may choose to leave it in the fund.
- G. Expenses of the Plan - The Employer pays for all expenses of the Plan with the exception of those related to distributions. Participants are responsible for expenses related to distributions from the Plan. For the years ended December 31, 2024 and 2023, expenses incurred by the Employer were \$1,775 and \$500, respectively. For the years ended December 31, 2024 and 2023, expenses incurred by the Plan were \$1,308 and \$1,568, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

- A. Date of Management’s Review – Subsequent events were evaluated through October 10, 2025, which is the date the financials were available to be issued.
- B. Estimates - The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- C. Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.
- D. Investment Valuation and Income Recognition - The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation include the plan’s gains and losses on investments bought and sold as well as held during the year.

- E. Payment of Benefits - Benefits are recorded when paid.
- F. Operating Expenses - All expenses of maintaining the Plan are paid by the Company with the exception of fees related to distributions from the Plan, which are paid by the participant.

**NOTE 3 – PLAN TRUSTEE**

Matrix Trust Company serves as the trustee of the plan and Northwest Plan Services, Inc. serves as the plan's service provider for the years ended December 31, 2024 and 2023.

**NOTE 4 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) by letter dated March 31, 2008. As a result, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified.

Accounting principles generally accepted In the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize the tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statement of Net Assets Available for Benefits.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 – CERTIFICATION (UNAUDITED)**

At December 31, 2024 and 2023, the Plan’s investments were held by Matrix Trust Company. The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified as to complete and accurate in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As of December 31, 2024 and 2023 all funds were allocated.

**NOTE 8 – RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Northwest Plan Services, Inc. Northwest Plan Services, Inc. is the plan’s service provider as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan and on behalf of the plan for the investment management services amounted to \$3,083 and \$2,068 for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE 9 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan's Board of Trustees determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in methods used to measure fair value at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair values of common stocks, mutual funds, certain corporate bonds, and U.S. government securities are based on the closing price reported in the active market where the individual securities are traded, when available.
