INDEPENDENT AUDITORS' REPORT

To the Board of Directors of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oklahoma Farm Bureau and Affiliated Companies Voluntary Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oklahoma Farm Bureau and Affiliated Companies Voluntary Employee Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Oklahoma Farm Bureau and Affiliated Companies Voluntary Employee Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Oklahoma Farm Bureau Voluntary Employee Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.


Other Matter—Supplemental Schedule Required by ERISA

- the form and content of the supplemental schedule, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Summary of Significant Accounting Policies

General Description of the Plan

The following comments provide a brief description of the Oklahoma Farm Bureau and Affiliated Companies Voluntary Employee Savings Plan (the Plan). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is Oklahoma Farm Bureau Mutual Insurance Company (the Company or the Employer).

The Plan is a defined contribution plan which is participant-directed.

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan is administered by the Oklahoma Farm Bureau Retirement Plans Committee (the Committee).

Eligibility

Generally, any employee except persons paid solely on a commission basis, persons whose principal duties consist of selling insurance, or persons who are agency trainees or security guard personnel, may become a participant after completion of 90 days of service. Participation generally continues until:

- Termination of the Plan;
- Termination of participation in the Plan by the participant's employer;
- Death or total disability of the participant; or
- Termination of employment and distribution of the participant's entire account.

The Plan automatically enrolls eligible employees at a contribution rate of 3% unless they opt out or elect to defer at another rate or amount.

Generally, a participant may agree to reduce their annual compensation by contributing a discretionary amount (elective deferral) for each year they participate in the Plan. The maximum reductions by law for 2024 and 2023 were \$23,000 and \$22,500, respectively, with certain "catch-up" provisions allowed for participants who have attained age 50 before the end of the plan year.

In addition to any Roth deferrals, a participant may make other nondeductible contributions to the savings fund by means of payroll deductions, but such contributions are minimal.

Rollover Contributions

Rollovers from other qualified plans are permitted.

Employer Matching Contributions

The Employer, by action of its Board of Directors, may make a discretionary contribution to the Plan in addition to “matching contributions” (also discretionary). The Company may specify different levels of qualified matching, non-qualified matching contributions, or discretionary contributions for the following groups of participants:

Group A: Employees who (1) are active members in the Oklahoma Farm Bureau Pension Plan (which was spun off from the Western Farm Bureau Pension Plan) and have not opted out of participation in the Pension Plan, or (2) were hired on or before May 31, 2004, and are not excluded from eligibility to participate in the Pension Plan, regardless of whether they are actively participating in the Pension Plan.

Group B: Employees who are not in Group A.

For Group A participants, matching contributions equal \$2 per \$1 of participant contributions for the first \$20 per pay period, and dollar for dollar for the next \$20 of participant contributions.

Group B participants were provided with enhanced discretionary and matching company contributions under this Plan as follows:

- An enhanced discretionary contribution equal to 3% of compensation regardless of whether the participant makes any elective deferrals to this Plan.
- An enhanced discretionary matching contribution based on elective deferrals equal to \$1 for every \$1 in elective deferrals for the first 2% of compensation per pay period; and
- An enhanced discretionary matching contribution based on elective deferrals equal to \$.50 for every \$1 in elective deferrals for the next 4% of compensation per pay period.

In addition to these limitations, under Code Section 415, the annual additions to the account of any member attributable to all defined contribution plans of the employer cannot exceed the lesser of \$69,000 in 2024 and \$66,000 in 2023, (as indexed) or 100% of compensation. Annual additions to this plan currently include employer contributions and participant contributions (deferrals).

The Company intends to continue the Plan indefinitely, but its continuance is not a contractual obligation, and the Company may terminate the plan at any time, subject to the provisions of ERISA.

Vesting

Each Participant who was employed before June 1, 2004, is fully vested.

Per amendment to the Plan effective January 1, 2024, all participants shall be fully vested in employer matching contributions and non-elective contributions. A participant's accounts attributable to their own contributions, including rollover contributions, and to the earnings on those contributions will be fully vested and nonforfeitable at all times.

Forfeitures will be applied to pay plan expenses or to reduce Company contributions (\$2,264 and \$34,732 was used to reduce Company contributions in 2024 and 2023, respectively). Forfeiture balances at December 31, 2024 and 2023 amounted to \$16 and \$1,113, respectively.

Plan Distributions

The Company has paid for certain direct Plan administrative and other expenses (except for individually assessed charges such as loan fees), but this is discretionary, and such expenses are excluded from these financial statements. Company employees provide certain administrative duties at no charge to the Plan. Certain fees are also paid through revenue sharing from plan investments to the Custodian, which are included in investment appreciation. In 2024 and 2023, Plan expenses of \$45,636 and \$62,035, respectively, were paid to the third party administrator directly from the Plan.

Optional forms of benefit payments include lump-sum, installments, and Ad-Hoc distributions.

A participant may request withdrawal of all or any part of their account attributable to (non-Roth) voluntary after-tax contributions (which are minimal), including earnings and losses applicable thereto. Upon serious financial hardship, a participant may request withdrawal of all or any part of their account attributable to salary reductions, and the earnings thereon.

Investment of Contributions

Each participant designates how their contributions to the Plan and employer matching contributions shall be invested, allocating them between various investment alternatives.

Notes Receivable from Participants

Participants may borrow from their fund account but with a minimum loan of \$1,000. Aggregate loans to the participant from this and any other qualified Plan maintained by the Company generally may not exceed the lesser of:

- \$50,000, with a calculated reduction for any outstanding loans
- One-half of the value of the participant's vested account balance.

Any loan must be repaid in level payments of principal and interest at least quarterly within five years of the date on which it was made or on the occurrence of an event that renders the Participant's account distributable, whichever occurs first, except that any loan used to acquire any dwelling unit used or to be used within a reasonable time as the principal residence of the Participant may be repaid over a longer period. Generally, repayments are made through payroll deductions. Interest rates are based on prevailing rates as determined by the Trustee (currently prime plus 2%), and loans are secured by the balance in the participant's account.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. Investment transactions are recorded on the trade date. Benefits are recorded when paid. Dividends are recorded on the ex-dividend date. Interest, if any, is recorded on the accrual basis.

Amounts payable to participants for contributions in excess of amounts allowed by the IRS, if any, are recorded as a liability with corresponding reduction to contributions.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. At December 31, 2024 and 2023, the plan's investment in the Guaranteed Income Fund is considered fully benefit-responsive.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, are charged directly to the related participant, and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits and participants' account balances.

Tax Status

The Internal Revenue Service has issued a letter dated September 16, 2022 that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because plan management believes that the plan had no taxable income, no income tax returns have been filed for 2024 or prior years.

2. Investments

Investments are generally reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines fair values based upon input from the Trustee. See Note 4 for a discussion of fair value measurements.

Investments (generally in mutual funds), except for the Guaranteed Income Fund which is carried at contract value, are recorded in the financial statements at quoted market prices, which represent the net asset value of shares held.

The Guaranteed Income Fund is a product of Empower. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is directly between the plan sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Empower considers this contract to be fully benefit responsive.

Generally, there are not any events that could limit the ability of the plan to transact at contract value paid within 90 days or contract value paid over time. There are not any events that allow the issuer to terminate and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

3. Information Certified by the Trustee

The following information, which the Trustee has certified as complete and accurate, has not been subjected to audit procedures:

- Investments in mutual funds and the Guaranteed Income Fund, cash, notes receivable from participants, net appreciation (depreciation) in investments, and other investment income
- Interest income from notes receivable from participants
- Information presented in the accompanying supplemental schedule

4. Fair Value Measurements

The Plan adopted Financial Accounting Standards Board Codification Section 820 *Fair Value Measurements*, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

4. Fair Value Measurements (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Committee evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers in 2024 or 2023.

Following is a description of the valuation methodologies used for investments. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Income Fund: Valued at contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
