NOTE A – DESCRIPTION OF PLAN

The following description of the AR Services 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement and the amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by AR Services, Limited (“the Company”) under a bulk submitter prototype plan. The Plan generally covers all employees of the Company, effective May 1, 1986.

The Plan provides for employee contributions and participant-directed investments. The Plan qualifies under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective as of May 3, 2022, the Plan amended its service agreement with Fidelity Management Trust Company which assigns its rights, duties, and obligations under the Plan agreement to Fidelity Workplace Services LLC; see the Plan agreement for full details.

Contributions

Each year, participants may contribute up to 100 percent of eligible salary on a pretax basis, with a maximum contribution of \$23,000 for 2024. However, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the year ended December 31, 2024.

Additional profit-sharing amounts may be contributed at the discretion of management. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan currently offers various mutual funds as investment options for participants.

The Plan Sponsor makes a Safe Harbor matching contribution and contributes 100% of the first 4% of the compensation that each participant contributes to the Plan. Matching contributions in 2024 totaled \$620,799.

Discretionary employer non-elective contributions are allocable to those participants who were employed during the Plan year and are employed on the last day of the Plan year. There were no discretionary non-elective contributions for the year ended December 31, 2024.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, employer matching contributions and employer non-elective contributions, as well as actual earnings thereon.

Investment Options

Contributions to the Plan are invested by the Trustee in various investment funds, according to participant instructions. The Plan Administrator provides participants with current copies of the prospectus describing each investment option.

Notes Receivable from Participants

Participants may borrow from their fund accounts from a minimum of \$500 up to maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate available for similar loans as determined by the Plan Administrator (prime plus 1% at December 31, 2024). Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of Benefits

After a participant leaves the Company due to any reason (death, disability, termination, or retirement), the participant may elect to receive his or her vested benefit in a single lump sum or have the payment paid as a "direct rollover" to an individual retirement account (IRA) or to another employer's tax qualified plan.

Participants may elect to withdraw from their vested account balance in the event of proven financial hardships.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits (continued)

Generally, on termination of service and at any point in time thereafter, an employee may elect to receive a lump sum equal to his or her vested account balance. However, if the employee's vested balance is less than \$1,000, he or she must receive a lump-sum distribution.

Forfeitures

Forfeitures resulting from terminated non-vested participants are used by the employer to pay plan administrative expenses or to reduce contributions made by the Company. During 2024, there were no forfeitures.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, additions to net assets, and deductions from net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents represent monies deposited with the Plan custodian which, at year end, were unallocated to investments accounts.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024, no allowance for credit losses have been recorded. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

As of December 31, 2024 and 2023, notes receivable from participants was \$98,021 and \$102,321, respectively. Management believes the notes receivable from participants are fully collectible.

Party-in-interest transactions

Transactions with Reliance Trust Company, the trustee and custodian of the Plan, qualify as party-in-interest transactions under ERISA. See Note I – Related Parties for further disclosure.

ERISA Section 103(a)(3)(C) Audit Election

As permitted by ERISA Section 103(a)(3)(C), the Plan's financial statements are presented in conformity with an audit performed pursuant to this section. Accordingly, investments held and certified by Fidelity Management Trust Company, a qualified bank and custodian, have not been audited by the Plan's independent auditor. The auditor's procedures were limited to information that is not so certified.

Risk and uncertainties

Investment securities are exposed to various risks, including market, interest rate, and credit risk. Further information about investment risks and concentrations is presented in Note F – Risks and Uncertainties.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Investment Management Services

Certain expenses of maintaining the Plan are paid by the Plan sponsor and are therefore excluded from these financial statements. Investment management services are paid for by the Plan participants. The Plan sponsor, at its discretion, may pay such expenses.

NOTE D – TAX STATUS

The Plan is part of a prototype plan provided by Fidelity Management and Trust Company. No determination letter is provided to the Company, but the Internal Revenue Service has determined and informed Fidelity Management and Trust Company, by a letter dated May 1, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

The Plan's information return filings are subject to examination by the Internal Revenue Service and the Department of Labor for a period of three years after the date of filing. Returns filed for plan years prior to 2022 are no longer subject to examination.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their entire account.

NOTE H – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

This fair value measurement is inputs other than quoted price included in Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. These inputs may also include insignificant adjustments to market observable inputs.

Level 3 Fair Value Measurements

The fair value of general insurance contracts is based on unobservable inputs used for valuing the assets. Unobservable inputs are those that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.

ASC 820 establishes a principle-based framework for measuring the fair value of both assets and liabilities. ASC 820 gives priority to market observable data (Level 1), when available. For investments that do not have readily available pricing measurements, ASC 820 allows valuation to be measured on an investment-by-investment basis, consistently applied to a specific investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All funds are managed by Fidelity Management and Trust Company. Therefore, Fidelity Management and Trust Company qualify as a party-in-interest to the Plan with respect to transactions related to these funds. The fair value of the funds managed by Fidelity Management and Trust Company totaled \$15,039,440 for the year ended December 31, 2024.

Fees paid by the Plan for the investment management services amounted to \$65,251 for the year ended December 31, 2024.

NOTE J – SUBSEQUENT EVENTS
