Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hebeler Holdings 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following brief description of Hebeler Holdings 401(k) Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan document for more detailed information.

General Information – The Hebeler Holdings 401(k) Plan is a defined contribution plan covering substantially all employees of Hebeler LLC (“Hebeler”) and Hebeler Process Solutions LLC (“HPS”). The Plan was established on January 1, 1984, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On November 19, 2024, CPEG Buffalo LLC and certain affiliated entities (collectively “CPEG”) acquired the majority of the business assets of Hebeler Holdings LLC and its subsidiaries, including Hebeler and HPS. Immediately following the sale of the business assets, all former associates of Hebeler and HPS continued to be employed and paid by Hebeler and HPS through December 31, 2024, pursuant to a Transition Services Agreement dated November 19, 2024 between CPEG Buffalo LLC and certain affiliated entities, Hebeler, HPS, and certain affiliated entities, and as such, remained participants of the Hebeler Holdings 401(k) Plan through December 31, 2024. CPEG Buffalo LLC subsequently became the new sponsor of the Hebeler Holdings 401(k) Plan in early 2025. Formal documentation of the plan sponsor change was completed during January 2025, with the name change to 'CPEG Buffalo 401(k) Plan' becoming effective February 3, 2025. The CPEG Buffalo 401(k) Plan is expected to merge with the Carrier Process Equipment Group Inc. 401(k) Plan in November 2025. Subsequent to merging the CPEG Buffalo 401(k) Plan (formerly Hebeler Holdings 401(k) Plan) into the Carrier Process Equipment Group Inc. 401(k) Plan, management expects to terminate the CPEG Buffalo 401(k) Plan.

Contributions – Participants may elect to make salary contributions each year, up to the Internal Revenue Service’s (“IRS”) statutory limitations. The Plan Sponsor will match 30% of the first 4% of compensation contributed to the Plan by the employee. In addition, the Plan Sponsor may make a discretionary contribution on behalf of the participants. There were no discretionary contributions made during the years ended December 31, 2024, or 2023. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Contributions received from participants are net of \$2,096 and \$3,260 for the years ended December 31, 2024, and 2023, respectively, for payments made in January 2025 and January 2024, respectively, to active participants to return excess deferred contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are also included in the statement of net assets available for benefits as excess contributions payable as of December 31, 2024, and 2023.

Participant Accounts – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant’s share of Plan earnings (allocated daily). Participant accounts are decreased by participant’s distributions and the participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. Upon retirement or termination, a participant is entitled to the vested balance in his or her account.

1. PLAN DESCRIPTION (continued)

Vesting – Participants are immediately vested in their own salary deferral contributions and earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after one year of credited service and vests an additional 20% for each additional year of credited service. A participant is 100% vested after five years of credited service.

Payment of Benefits – A participant will be eligible for payment of benefits upon attaining normal retirement age, age 59 ½, financial hardship, or death, prior to termination or severance date. Upon termination of service, a participant may receive a lump sum amount equal to the vested value of his or her account.

Plan Termination – The Plan Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions and associated interest and earnings.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years, unless the loan is for the purchase of a principal residence, in which case the term can extend to ten years. The loans are secured by the balance in the participant’s account, bear interest at rates from 8.25% to 9.25% and mature through November 2030. Principal and interest are paid ratably through regular payroll deductions.

Forfeited Accounts – Forfeited non-vested accounts shall first be used to reduce Plan administrative expenses. Any remaining forfeitures are used to reduce future employer contributions. Forfeitures available amounted to \$1,689 at December 31, 2024 and \$1,066 at December 31, 2023. No forfeitures were utilized were used to reduce Plan expenses during the years ended December 31, 2024 and 2023.

Administrative Expenses – Costs of administering the Plan are paid by both the Plan Sponsor and the participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2 and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Following is a description of the valuation methodologies used for investments measured at fair value:

Mutual funds: Valued based on quoted market prices available on an active market, which represent the net asset values (“NAV”) of the shares held by the Plan at year-end.

Stable value fund: The fund primarily holds guaranteed and other similar investment contracts, which are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan at year-end using NAV contract value, and generally has no redemption restrictions or unfunded capital commitments.

Cash management fund: Valued based on the quoted market price available on an active market, which represents NAV of the shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis.

Payment of Benefits – Benefits represented by vested participant account balances are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures that are included in these financial statements. Actual results could differ from management’s estimates and assumptions.

Subsequent Events – Management has evaluated the effects of all subsequent events through October 9, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2).
