1. DESCRIPTION OF PLAN

The following description of the Rhode Island Sheet Metal Workers' Local #17 Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1982, by the Sheet Metal Workers' Local Union #17 and the Master Sheet Metal Workers' and Composition Roofers' Association of Rhode Island to provide benefits upon retirement, total and permanent disability, death, or termination of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Plan provided formal notice to the Massachusetts Sheet Metal Workers' Local 17 Annuity Income Fund (the "Massachusetts Fund") on November 29, 2023, of their approval to initiate the process of merging into the Massachusetts Fund.

Contributions

Contributions are made by employer members in accordance with the working agreement and are at a fixed rate per hour worked.

In December 2023, the Massachusetts Fund Trustees voted to accept RI union members and RI Plan participants as participants under the Massachusetts Fund effective February 1, 2024. On February 1, 2024, individual accounts were established for RI Plan participants as new participants in the Massachusetts Fund. In January 2024, the Rhode Island Collective Bargaining Agreement was amended to require contributions be made only to the Massachusetts Fund.

Participants' Accounts

Each participant's account is credited with the employer's contribution and an allocation of the Plan's earnings and expenses.

Vesting

Participants are 100% vested in their accounts immediately upon completing 100 hours of service in a plan year.

Payment of Benefits

On termination of service due to retirement or disability, a married participant and spouse may elect to receive either a lump-sum amount or a joint and survivor annuity. An unmarried participant may elect to receive either a lump-sum amount or a life annuity.

Forfeited Accounts

Forfeited accounts are reallocated to participants in the same manner as Plan earnings.

Reciprocal Agreement

The Plan participates in a regional agreement where contributions for members of participating funds who work outside their local jurisdiction are reciprocated to their local jurisdiction at the rate in effect at the time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies utilize information provided by the investment advisers and custodian. See Note 9 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Contributions Receivable

Contributions receivable represent employer contributions related to employees' hours worked on or prior to the end of the period, received up to three months after the end of the period. Prior year contributions received after three months are recorded as revenue when received. No allowance for doubtful accounts is required.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Subsequent Events

The Plan has evaluated subsequent events through March 6, 2025 which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the six months ended June 30, 2024.

3. PLAN TERMINATION

The Board of Trustees has the right under the Plan to amend or terminate the Plan at any time. In the event of plan termination, the net balance of each participant's account will be paid in a lump sum or through the purchase of annuities from an insurer to the participant or his beneficiary.

4. INVESTMENTS

At June 30, 2024 and December 31, 2023, Comerica Bank held substantially all of the Plan's investment assets as custodian. All Plan investments are professionally managed under the direction of the Board of Trustees.

During the six months ended June 30, 2024, the Plan's investments (including gains and losses on investments bought and sold, (as well as held during the year) appreciated in value as follows:

5. TAX STATUS

The Internal Revenue Service determined and informed the Plan by letter dated April 13, 2010, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. At June 30, 2024, management believes no such provisions for uncertain tax positions are necessary.

5. TAX STATUS (continued)

A routine audit was initiated by the United States Department of Labor (DOL) in June 2020 regarding various financial, administrative, and procedural aspects of the Plan and of the duties of the Plan's trustees as fiduciaries. The DOL made numerous document requests in conjunction with the audit that were complied with by the Plan through its fund administrator and fund counsel. Plan management and fund counsel expect the audit to be resolved without significant impact on the Plan.

6. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, Comerica Bank, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

8. RELATED-PARTY TRANSACTIONS

As commented in Note 1, the Plan is maintained pursuant to collective bargaining agreements which include other employee benefit plans. The Plan is related to these other benefit plans through common membership and a common depository bank account from which contributions are distributed and deposited.

Segal Marco Advisors serves as discretionary investment manager to the Plan and is also the sponsor of the Segal Marco Group Trusts. Comerica Bank and Trust serves as custodian to the Plan and utilizes the Comerica Short-Term Fund.

9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and December 31, 2023.

Group trusts – valued at the NAV of units of a commingled trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Pooled investment fund: Valued at the net asset value as reported by the investee entity. The valuation is based on the nature of investment assets, local market conditions, and current and projected operating performance of underlying real estate property.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value as of June 30, 2024 and December 31, 2023. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

The fund invests primarily in domestic and international fixed-income investments and fixed-income private investment funds.

Equity group trust – The fund is designed to permit qualified employee benefit plans and certain governmental plans and collective trusts to commingle their assets for investment purposes on a tax-exempt basis. The fund invests primarily in domestic and international equities and equity-based private investment funds.
