INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed an audit of the accompanying financial statements of Brevard Achievement Center Health and Welfare Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audits of the Financial Statements section:

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF PLAN

The following description of Brevard Achievement Center Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the associated plan documents for a complete description of the Plan's provisions.

General: The Plan was established on May 1, 1992 to provide health and other benefits to eligible participants. Substantially all employees of Brevard Achievement Center, Inc. (the Plan Sponsor) employed under a federal service contract are eligible to participate in the Plan. Certain commercial employees are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits: The Plan provides medical, hospital, life, dental, vision, death, short-term disability, and prescription drug benefits for eligible participants and their dependents. The third-party administrator pays insurance premiums to various insurance companies for benefits for eligible participants and their dependents. Insurance companies are responsible for paying benefits under these agreements.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Investment Valuation and Income Recognition (continued): The Plan invests in an investment security. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

Initial Funding (Deposits): In 2014, \$23,774 was contributed to the Benny Central account administrator for participant benefits and is reflected as deposits at December 31, 2024 and 2023. This account is replenished weekly through transfers from the trust account.

Benefit Obligations: Benefit obligations include those claims for which services have been performed but which have not been paid as of December 31, 2024 and 2023. Based on the inherent uncertainties involved, it is reasonably possible that the estimate will change in the near term.

Administrative Expenses: The Plan's administrative fees are paid by the Plan.

Trust Fees: The Plan's trust fees, for processing and payment of insurance premiums and other administrative services, are paid by the Plan.

Accounts Payable: This amount represents certain fees pertaining to the current year, but not yet paid at year end.

Subsequent Events: Plan management has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events requiring disclosure.

NOTE 3: CONTRIBUTIONS

The Plan is funded by contributions from the Plan Sponsor and participants. Benefit or insurance premium payments are made from these contributions. Contributions are allocated to Plan benefits and expenses in accordance with an administrative services agreement between the Plan Sponsor and the third-party administrator. The Plan Sponsor is ultimately responsible for the allocation and administration of funds. However, the third-party administrator pays insurance premiums to various insurance companies.

NOTE 4: RESERVES AND BENEFIT OBLIGATIONS

Health Reimbursement Arrangement Reserve (HRA): The HRA component of the plan will reimburse covered persons for qualified health expenses incurred after the effective date of this HRA component, provided the covered employee was enrolled at the time the expense was incurred. Qualified health expenses are amounts paid for the diagnosis, cure, mitigation, treatment or prevention of disease, or for the purpose of affecting any structure or function of the body. Benefits are provided for those employees and their covered dependents who have a remaining HRA balance.

Individual Premium Reserve (“Hour Bank Reserve” – Accumulated Eligibility Credits): The Plan Sponsor contributes a required amount for employees based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the “hour bank reserve.” The hour bank reserve balances are used to fund employee premium shortfalls during months when the employee does not work sufficient hours to maintain full-time coverage. These funds may also be used after employee termination to fund continuation of coverage until exhausted.

Claims Funding Reserve (Accumulated Eligibility Credits): The Plan Sponsor contributes a required amount for employees based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the “claims funding reserve.” The claims funding reserve balances are used to pay employee preventive care claims. After termination, participants have 180 days to file claims for payment.

Asset Balance Reserve: The Plan Sponsor contributes a required amount for employees of Puerto Rico based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the “asset balance reserve.”

Other Benefit Reserve: The Plan Sponsor contributes a required amount for employees based on a predetermined hourly fringe rate for certain benefits for employees of Puerto Rico and vision benefits. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the “other benefit reserve.”

NOTE 5: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of benefit obligations and net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

NOTE 7: INCOME TAX STATUS

The Plan has not applied for exemption from state or federal income taxes. Plan management believes that the Plan qualifies for exemption from income tax under the Internal Revenue Code and, therefore, no provision for income taxes is reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9: TRANSACTIONS WITH PARTIES-IN-INTEREST

Trust fees charged to the Plan's third-party administrator were \$83,460 and \$220,196 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, amounts payable to the Plan's third-party administrator for trust fees were \$45,633 and \$96,084, respectively.

Certain employees of the Plan's sponsor provide administrative and accounting services to the Plan at no additional cost to the Plan. These employees are also participants of the Plan.
