## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Westbrook Service Corporation Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Westbrook Service Corporation Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **NOTE 1            DESCRIPTION OF PLAN**

The following description of the Westbrook Service Corporation Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all employees of the Westbrook Service Corporation (the "Company") who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Plan Administration**

The Company is the plan sponsor and plan administrator of the Plan, and contracts the services of a third-party administrator from Carpenter Morse Group, (the "TPA") for the years ended December 31, 2024 and 2023. The Plan's assets are maintained by John Hancock Life Insurance Company, (the "Custodian"). Contributions are held by the Custodian, who invests cash received, interest and dividend income, and make distributions to participants (at the direction of the Company and the participants).

### **Contributions**

Each year, participants in the Plan may voluntarily contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

The Company provides matching contributions of 25% of the first 6% of participant contributions to the Plan. Additional discretionary contributions may be contributed at the discretion of the Company. Matching and discretionary contributions are invested in the same manner as participant contributions, as directed by the participant. For the plan year ended December 31, 2024, the Company provided discretionary matching contributions of 50% of the first 6% of participant contributions to the Plan.

Participant and Company contributions are subject to the limitations specified by the Plan and the Internal Revenue Service (the "IRS").

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions, as well as allocations of earnings and losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting of Benefits**

Participants are immediately fully vested in their voluntary contributions, plus actual earnings or losses thereon. Vesting in the Company's matching and discretionary contributions, including actual earnings or losses thereon, is based upon the number of years of service. Participants vest in the Company's contributions at a rate of 20% per year of service after two years of service and become fully vested after six years of credited service. Participants become fully vested in Company contributions and earnings upon death, disability (as defined by the Plan), attainment of normal retirement age (as defined by the Plan), or upon termination of the Plan.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of issuance, is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Loans are treated as an investment of the borrowing participant's account and only the borrowing participant's account receives interest paid on the participant loan.

**NOTE 1            DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

On termination of service with the Company due to death, disability, retirement, or other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment distributions. The period of installment distributions may not extend beyond the life expectancy of the participant. Automatic lump-sum distributions will be made on a participant's accounts with a value of less than \$5,000. In addition, the Plan allows hardship withdrawals as allowed by the Internal Revenue Code.

Participants still employed who have reached the age of 59 ½ are eligible to withdraw all or a portion of their vested accounts.

**Forfeitures**

The non-vested portion of a participant's account balance upon termination of service with the Company is forfeited. Forfeitures may be used by the Plan for administrative expenses of the Plan or by the Company to reduce future contributions to the Plan. During the year ended December 31, 2024, the Company used approximately \$6,900 of the forfeitures account to pay administrative expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,300 and \$4,400 respectively.

**NOTE 2            SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses is recorded as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' accounts.

Notes receivable from participants outstanding at December 31, 2024 had interest rates ranging from 3.25% to 8.50% and maturities through February 2037.

**Deemed Loan Distributions**

Deemed loan distributions are recorded when the participant defaults on the loan. For the year ended December 31, 2024, deemed loan distributions of approximately \$3,600 are included with benefits paid to participants.

**Contributions**

Participant contributions are recorded when withheld from compensation. Employer contributions are recorded in the period in which they become obligations of the Company.

## **NOTE 2           SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

### **Corrective Distributions**

Contributions in excess of amounts allowed by the IRS or ERISA requirements are returned to the participant. Contributions are presented net of corrective distributions.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

### **New Accounting Pronouncements**

The Plan has considered new pronouncements that alter accounting principles generally accepted in the United States of America and does not believe that any new or modified principles will have a material impact on the Plan's reported financial position or operations in the near term.

### **Subsequent Events**

Plan management has evaluated subsequent events through the date of the independent auditor's report, the date which the accompanying financial statements were available to be issued. Based on such evaluation, no events have occurred that in the opinion of management warrant adjustments to or disclosure in the financial statements.

## **NOTE 3           FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy established by the Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820): *Fair Value Measurements and Disclosures*, are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive market, inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

### *Pooled Separate Accounts*

The net asset value (NAV) of units of a financial institution pooled separate accounts, which are not publicly quoted prices in an active market, is based on the fair value of the underlying investments, less any liabilities. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the Plan's investments reported at fair value consisted of pooled separate accounts, valued using the NAV practical expedient and are not required to be categorized in the fair value hierarchy.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or a Company whose employees are covered by the Plan.

In addition to notes receivable from participants, the Plan had the following party-in-interest transactions for the year ended December 31, 2024, which related to direct fees paid by the Plan for the services noted:

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Additionally, certain administrative expenses such as audit and legal fees are paid by the Company at its discretion.

**NOTE 6 PLAN TERMINATION AND AMENDMENTS**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company also has the right to amend any or all provisions of the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and the net assets of the Plan would be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

**NOTE 7 INCOME TAX STATUS**

The Plan has adopted a prototype defined contribution plan which the IRS has determined and affirmed, in a letter dated June 30, 2020, to be designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. Plan management have analyzed the tax positions taken by the Plan and concluded no uncertain positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10            PROHIBITED TRANSACTIONS**

During the plan year, the Plan Sponsor failed to remit participant contributions and loan repayments totaling \$7,611 for the pay period ended October 4, 2024 in a timely manner. The contributions were deposited into the Plan on November 18, 2024, a delay of 31 days.

This late remittance was a prohibited transaction under ERISA. The Plan Sponsor fully corrected this issue by remitting the original late contributions and an additional \$90 for lost earnings to the Plan in the subsequent plan year. The correction was made on September 15, 2025 in accordance with the DOL's Voluntary Fiduciary Correction Program (VFCP).
