Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United States Drug Testing 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1: Description of Plan

The following description of the United States Drug Testing 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on June 1, 2004 covering all eligible employees of United States Drug Testing Laboratories Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees of the Company (other than employees covered by a collective bargaining agreement and nonresident aliens who receive no U.S. source income) are eligible to participate in the Plan immediately following the completion of one year of service, as defined by the Plan. Effective January 1, 2024, long-term part-time employees who have not previously entered the Plan, but have attained at least 500 hours of service in at least three consecutive years beginning after December 31, 2020, are eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 96% of eligible compensation, as defined in the Plan document, as either pre-tax or after tax Roth contributions up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Newly eligible employees who either do not elect to contribute or do not elect to decline to contribute are automatically enrolled in the Plan at a 3% pre-tax contribution rate with Vanguard targeted age-directed date funds as the qualified default investment alternative. Automatically enrolled participants whose before-tax salary deferral contribution rate is less than 6% have their salary deferral contribution rate automatically increased by 1% annually up to a maximum of 6%.

The Plan provides for the Company to make safe-harbor matching contributions to eligible participants each pay period in an amount equal to 100% of the first 1% and 50% of the next 5% of participant salary deferral contributions for the year ended December 31, 2024. Company safe-harbor matching contributions to the Plan for the year ended December 31, 2024, were \$318,371.

In addition, the Company may contribute annually an additional discretionary amount to the Plan allocated to eligible participants who have completed at least 501 hours of service in the Plan year or are employed on the last day of the Plan year in the ratio that the participant's compensation bears to the compensation of all participants. No such contribution was made for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Participant accounts are credited with the participant's contributions, Company safe-harbor matching contributions, and allocations of (a) the Company's additional discretionary contribution, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

All participant deferral contributions, rollover contributions and Company safe-harbor matching contributions and earnings thereon are immediately fully vested. Participants vest in additional Company discretionary contributions at a rate of 20% per year of service, as defined by the Plan, after the second year of service and reach full vesting after six years of service. In the event of death, total disability, or reaching normal retirement age (age 65), participants' accounts become 100% vested.

Any amounts forfeited by Plan participants are used to reduce the Company matching and/or additional discretionary contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$2,632, respectively. During the year ended December 31, 2024, \$2,632 of the nonvested forfeited amounts were used to pay administrative expenses.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Plan participants may borrow up to the lesser of 50% of the vested portion of the participant's account balance or \$50,000, but no less than \$1,000. The loans bear interest at a fixed rate of 2% above the prime rate established by Associated Bank, N.A and are comparable to commercial lending standards. Interest rates on loans outstanding at December 31, 2024, ranged from 4.25% to 10.50%. Loans are funded by a withdrawal from the participant's own account and are payable in equal installments by payroll deductions over a period not to exceed five years, unless the participant's loan is for the purchase of the participant's principal residence which can be paid back over a period not to exceed fifteen years. The Plan allows participants to have only one loan outstanding.

Payment of Benefits

A participant is entitled to the vested value of his/her account balances at the normal retirement age (65), upon termination of employment, death, or total disability. Benefits are paid to a participant or his/her beneficiary in the form of a lump sum, installment payments or partial withdrawals.

In-service Withdrawals

The Plan allows for in-service withdrawals by participants who have attained the age of 59 1/2 from the vested portion of their account balances or withdrawal of rollover contributions by any participant at any time. In addition, the Plan allows for hardship withdrawals if certain criteria are met, subject to the terms of the Plan document.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA, although it has expressed no intention to do so. In the event of termination of the Plan, participants become fully vested in their Company contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investment's are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Administrative Expenses

Management fees for investments in mutual funds are deducted from income earned on a daily basis and, therefore, are reflected as a reduction of investment return for those mutual funds. Fees charged to the Plan for distributions and/or loans are charged directly to the account of the individual participant and are included in administrative expenses. Expenses, if any, paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Summary of Information Prepared and Certified by Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Associated Trust Company, N.A., the Trustee of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Money market funds: Fair values are based on cost of \$1 per share at year-end, which approximates fair value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 5: Tax Status

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Associated Trust Company, N.A. with an IRS opinion letter dated June 30, 2020, which stated the plan document is in compliance with applicable sections of the IRC. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

Certain expenses are charged to the Plan by service providers for record-keeping and investment advisory services. These transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for these services were \$35,265 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
