**Note 1 - Plan Description**

The following brief description of the New Tech Engineering LP 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of New Tech Engineering, LP (Plan Sponsor), and adopting employers including; New Auburn Energy Management, LLC, New Tech Global Environmental, LLC, New Tech Global Rig Personnel, LLC, New Tech Global Staffing, LLC, New Tech Global Ventures, LLC, and NTGSH JV, LLC (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was initially adopted by the Employer on December 15, 2005 and has since been amended and restated.

New Tech Engineering, LP is named as the plan administrator. Empower Annuity Insurance Company of America (EAICA) serves as the asset custodian of the Plan's group annuity contract. Empower Trust Company, LLC (ETC) serves as the asset custodian of the Plan's mutual funds, common/collective trust funds, and notes receivable from participants. An officer of the Plan Sponsor serves as the trustee of the Plan.

**Eligibility**

Participation in the Plan is available for eligible employees who are 21 years or older and who have been employed for 90 days. Eligible employees may participate in the Plan on the first day of each plan quarter coinciding with or next following the date on which the employee meets the eligibility requirements. The Plan includes a savings feature designed to permit the employees and the Employer to contribute to the Plan, at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC). Employees become eligible to receive safe harbor matching contributions, discretionary profit-sharing contributions and discretionary employer matching contributions from the Employer after attaining the age of 21 and completing one year of service.

Subsequent to year end, the plan was amended to allow eligible employees to participate in the Plan on the first day of each plan month coinciding with or next following the date on which the employee meets the eligibility requirements.

**Contributions**

An eligible employee may participate in the Plan by electing to defer a percentage of their compensation, on a pre-tax or Roth basis, of up to 90% of their eligible compensation subject to limitations of the IRC. Eligible participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions subject to the limitations of the IRC. The Plan also accepts participant rollover contributions from other qualified plans or individual retirement accounts.

The Employer made safe harbor matching contributions for the year ended December 31, 2024, to all eligible participants in an amount equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan and 50% of the next 2% of the participant's eligible compensation contributed to the Plan. Additionally, the Employer may elect to make discretionary profit-sharing contributions and discretionary employer matching contributions. The Employer did not make discretionary profit-sharing contributions or discretionary employer matching contributions for the year ended December 31, 2024.

**Vesting**

Participants are always 100% vested in their voluntary contributions, safe harbor employer matching contributions, and accumulated earnings thereon. A participant's interest in all other contributions made by the Employer begins vesting at 20% after one year of service, increasing 20% each year thereafter, with the participant 100% vested after five years.

**Forfeitures**

There were \$974 and \$961 of forfeited non-vested amounts available at December 31, 2024 and 2023, respectively. Forfeitures may be used to reduce future employer contributions or to offset plan expenses. For the year ended December 31, 2024, \$964 in forfeitures were utilized to reduce employer matching contributions or to offset plan expenses.

**Participant Accounts**

Upon enrollment in the Plan, participants may direct the asset custodians with regard to the investment of their account balances into the various investment options offered by the Plan. Participants may change their investment elections at any time.

Each participant's account is credited with the participant's contributions, allocations of the employer contributions, and plan investment earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Notes receivable from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months, or 50% of the vested portion of their account balances. A participant may not have more than one loan outstanding at any time. Interest rates are based on the prime rate plus 2%. Principal and interest are generally repaid through payroll deductions. Loan terms are limited to five years unless for the purchase of a primary residence, in which case the term may be extended beyond five years.

**Benefit Payments**

Distributions may be made to participants or their beneficiaries upon termination of employment, retirement, disability or death, as applicable. Under certain circumstances, plan participants may make withdrawals from their account while still employed for reasons of financial hardship, upon the attainment of age 59½, and for other such reasons. Upon termination, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants who terminate with an account balance of more than \$1,000 but less than \$7,000, the plan administrator shall make a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income taxes on contributions and income earned.

**Note 2 - Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments of the Plan, except for the fully benefit-responsive group annuity contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for the benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair value of investments includes realized gains or losses on investments bought and sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are collateralized by the participant's account balance. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made, and such defaults are recognized as distributions based upon the terms of the plan document when a distributable event has occurred.

**Benefit Payments**

Benefits paid to participants or beneficiaries are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

**Administrative Expenses**

Fees related to the administration of notes receivable from participants and certain other administrative and transactional fees are charged directly to the participant's account. Certain costs and expenses incurred in connection with the operation of the Plan are paid by the Plan, unless paid by the Employer, at its discretion. Investment-related expenses are included in net appreciation or depreciation in the fair value of investments.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with the Plan's investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and may impact participants' account balances, and the amounts reported in the financial statements.

**Subsequent Events**

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued. See Note 10.

**Note 3 - Information Certified by the Plan's Asset Custodians**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from EAICA and ETC as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to financial statements as to investments, notes receivable from participants, investment income and interest income on notes receivable from participants, and all information in the supplemental schedule of assets (held at end of year), is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* These funds are valued daily based upon their quoted market prices.

*Common/Collective Trust Funds:* These funds are valued at their net asset value (NAV) as determined by the issuer based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

**Note 5 - Group Annuity Contract with Empower Annuity Insurance Company of America**

The Plan has a fully benefit-responsive group annuity contract with EAICA, the Key Guaranteed Portfolio Fund. EAICA maintains the contributions in an unallocated contract account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. For the year ended December 31, 2024, the rate was 1.41%.

As described in Note 2, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Amounts allocated to the Key Guaranteed Portfolio Fund earn interest at the higher of the rate guaranteed under the contract or the current rates established and declared by EAICA prior to each calendar quarter. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable of occurring.

The group annuity contract does not permit EAICA to terminate the agreement prior to the scheduled maturity date.

**Note 6 - Federal Income Tax**

Effective May 16, 2022, the Plan was amended and restated via its adoption of a pre-approved plan. The pre-approved plan received an opinion letter from the IRS dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

The group annuity contract is issued by EAICA, a party-in-interest with respect to the Plan. The Plan also engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the “prohibited transactions” provisions of ERISA and the IRC.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the plan document to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their account balances.

**Note 9 - Reconciliation of the Financial Statements to the Form 5500**

**Note 10 - Subsequent Events**

Subsequent to December 31, 2024, the Plan Sponsor identified an operational failure dating back to 2018, involving the inclusion of New Tech Global Rig Personnel LLC as a participating employer prior to a formal plan amendment. In accordance with IRS Notice 2023-43 and Section 305 of the SECURE 2.0 Act, the Plan Sponsor determined the failure qualified as an Eligible Inadvertent Failure under the Employee Plans Compliance Resolution System (EPCRS).

The failure was corrected via a retroactive plan amendment executed on September 24, 2025 formally recognizing New Tech Global Rig Personnel LLC as a participating employer effective January 1, 2018. The correction was completed within 18 months of identification and did not reduce participant benefits.

The Plan Sponsor has updated its compliance procedures to prevent recurrence and will reflect the amendment in future filings and disclosures.
