Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The following brief description of Barnes Crossing Auto Group 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

- A. *General.* The Plan is a defined contribution plan covering substantially all employees of Barnes Crossing Auto, LLC; BCAF, LLC; BCASS, LLC; BCCBG, LLC; BCK, LLC; BCM, LLC; BCVW, LLC; BCH, LLC; EHV, LLC; FLOC, LLC; HOFC, LLC; HOFO, LLC; HOFS, LLC; HOFTS, LLC; JMIT, LLC; KOFTS, LLC; MOJ, LLC; T OF NCRR, LLC; TOFS, LLC; and VOFLC, LLC (collectively, the “Participating Employers”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. *Contributions.* Each year, participants may contribute an amount up to 100 percent of compensation, as defined in the Plan, in the form of elective deferrals subject to limitations defined in the Internal Revenue Code. Participants may also elect to roll over any amounts from other qualified retirement plans. The Company may make matching contributions equal to a discretionary percentage or amount, to be determined annually by the Company, of the participants’ 401(k) elective deferrals. The Company provides fully vested qualified matching contributions (QMAC) for all eligible employees. The formula for recalculating the QMAC is 100% of salary deferral contributions up to 4% of pay.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants’ nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately 100% vested in their voluntary contributions, Company safe harbor matching contributions, plus actual earnings thereon. Vesting of Company non-elective contributions is based on years of service. Company non-elective contributions are subject to a graded vesting schedule as follows: two years of service: 20%, three years of service: 40%, four years of service: 60%, five years of service: 80%, and six years of service: 100%.
- E. *Investment Options.* Upon enrollment in the Plan, a participant directs the investment of their contributions into various investment options offered by the Plan.
- F. *Payment of Benefits.* Upon termination of service with the employer, a participant will receive a lump-sum distribution in the amount equal to the vested portion of his or her account.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. *Basis of Accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.
- B. *Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for further discussions on fair value.
- C. *Payment of Benefits.* Benefits are recorded when paid.
- D. *Expenses.* The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Most Administrative expenses are paid directly by the Plan Sponsor and include audit, accounting, and legal fees. Administrative expenses directly allocable to individual participant-directed accounts are paid from the participant's account.
- E. *Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- F. *Subsequent Events.* In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 and the methodologies used for assets measured at fair value are described as follows:

Level 1. Fair value inputs include unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. The fair value of mutual funds and money market funds is based on quoted net asset values of the shares held by the Plan at year-end. Self-directed brokerage accounts are valued based on the fair values of the investments in the accounts. These accounts are comprised of investments in common stocks and mutual funds. Common stocks are valued at the closing price on the active market on which the individual securities are traded. See above for the valuation of mutual funds.

Level 2. Fair value inputs include significant other observable inputs other than Level 1 inputs such as quoted prices for similar assets, quoted prices in markets that are not active or other observable inputs that can be corroborated by observable market data. There were no Plan investments valued using Level 2 inputs.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 3. FAIR VALUE MEASUREMENTS - (Continued)

Level 3. Fair value inputs include unobservable inputs that are supported by little or no market activity such as pricing models, discounted cash flow methodologies or similar techniques. Level 3 inputs have the lowest priority. There were no Plan investments valued using Level 3 inputs.

NOTE 4. CERTIFIED INFORMATION

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, the schedule of assets held for investment purposes at December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

NOTE 5. FEDERAL INCOME TAX STATUS

The Ascensus LLC prototype non-standardized profit sharing plan with cash or deferred arranged (CODA) was adopted by the Company and obtained in its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype non-standardized profit sharing plan with CODA, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Plan Management adopted a Safe Harbor design for the Plan, which means that the Plan automatically complies with nondiscrimination requirements of Internal Revenue Code Section 401. Plan Management believes that Plan is qualified, and the related trust is tax exempt as of the financial statement date.

The Plan's Form 5500 information returns are subject to examination by the Department of Labor generally for three years after they are filed. Management has evaluated the tax positions taken, and has not identified any positions that are not more likely than not to be sustained upon examination.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7. RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by First Horizon Advisor, the Plan's investment advisors. The Vanguard Group, Inc serves as the Plan's recordkeeper. Fees paid by the Plan for recordkeeping and investment advisor services amount to \$39,339 for the year ended December 31, 2024. These transactions qualify as party in interest transactions.

NOTE 9. RECLASSIFICATIONS

Certain amounts in the prior year financial statements have been reclassified in order to conform with the current year presentation.
