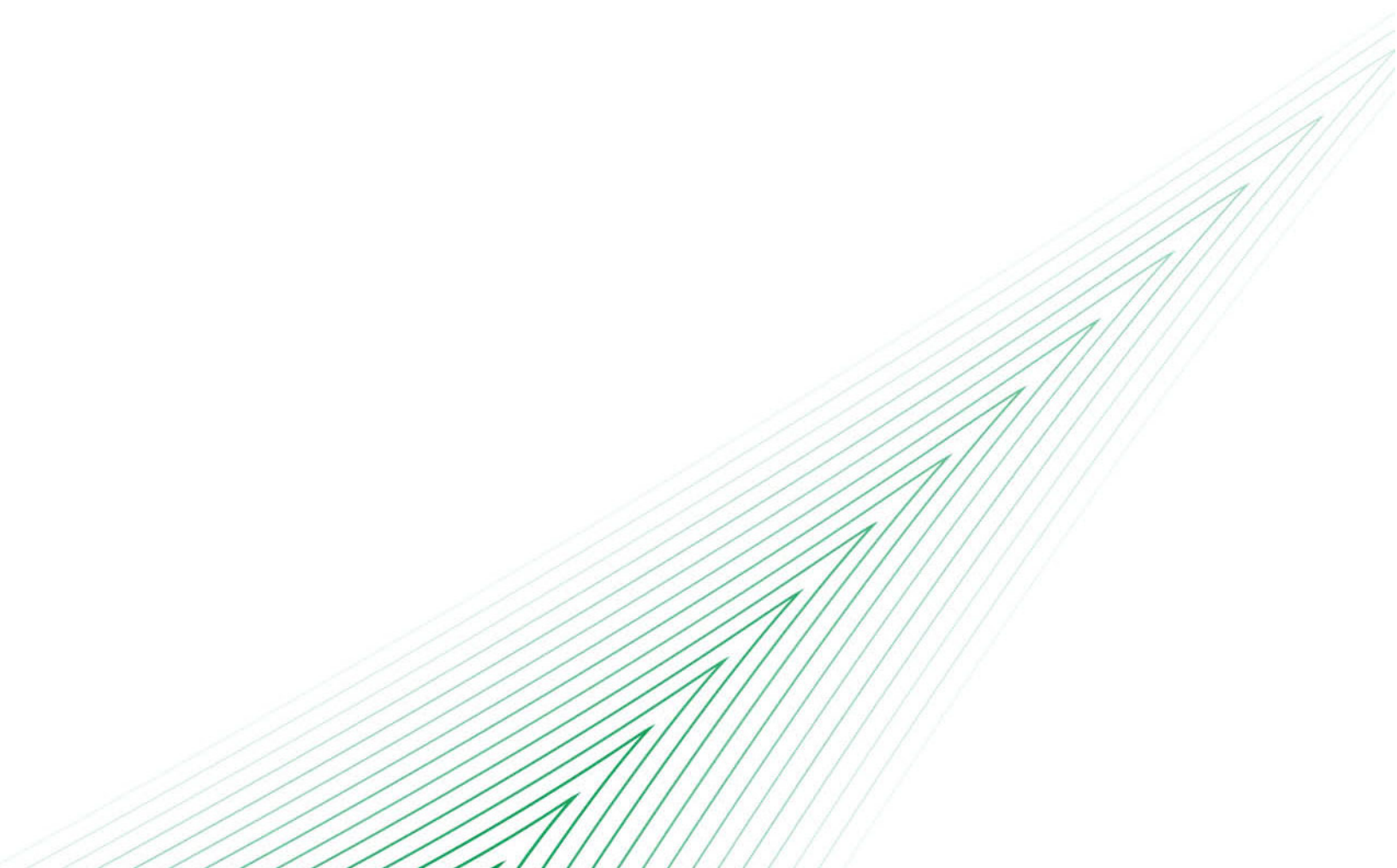

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### **Fres-co System USA, Inc. Retirement Savings Plan**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Fres-co System USA, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (a "qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### NOTES TO FINANCIAL STATEMENTS

#### (1) **Description of plan**

The following brief description of Fres-co System USA, Inc. Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and adoption agreement or Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan sponsored by Fres-co System USA, Inc. (the "Company" or "plan sponsor") for the benefit of substantially all employees, as defined in the Plan, who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Each year, participants may contribute a percentage of eligible compensation, as defined in the Plan, subject to certain limitations established by the Internal Revenue Code ("IRC"). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan. Highly-compensated employees, as defined, are permitted to contribute up to 6% of their eligible compensation to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation until changed by the participant.

The Company makes discretionary matching contributions of 75% of participants' contributions up to 5% of eligible compensation, as defined. All contributions are participant-directed. The Company's contribution may be increased, decreased, or eliminated at the Company's discretion.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trusts.

**Participants' accounts** - Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contribution; (b) Plan earnings; and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of certain administrative and investment expenses. Allocations are based on the participant's earnings, account balances, or contributions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service as defined in the Plan document and adoption agreement. A participant is 25% vested after one year of service, 50% vested after two years of service, and 100% vested after three years of service.

**Notes receivable from participants** - Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loans range from 1-5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balances in the participants' accounts and bear interest at the prevailing local rates at the inception of the loans. Interest rates range from 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through biweekly payroll deductions.

#### (1) Description of plan (continued)

**Payment of benefits** - On termination of service due to retirement, a participant with a balance in excess of \$7,000 can choose to: 1) receive a lump sum amount equal to the value of his or her account or 2) leave his or her balance in the Plan until minimum payments are required as specified in the Plan. Balances under \$7,000 are distributed in a lump sum. On termination of service due to death, a participant's beneficiary(ies) are paid the value of the participant's account in a single lump sum payment with certain limited exceptions as specified in the Plan. On termination of service due to resignation or discharge or in instances of hardship, the participant may retain balances over \$7,000 in the Plan or receive a lump sum distribution up to the value of his or her vested account balance.

**Forfeited accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$140,287 and \$54,546, respectively. Forfeitures are to be used first to restore participants' balances, and then the remainder is allocated annually to participants in the same proportion that their allocation of Company contributions bears to the total Company contributions for the year. Total forfeitures allocated to participant accounts during the years ended December 31, 2024 and 2023 were \$55,665 and \$74,793, respectively.

#### (2) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as those held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the plan sponsor are recorded in the year in which the participant contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the note receivable from the participant to be in default, the note receivable balance is reduced, and a benefit payment is recorded.

#### (2) Summary of significant accounting policies (continued)

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses and costs of administering the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in the fair value of investments.

#### (3) Information prepared and certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC ("Newport"), the trustee of the Plan.

#### (4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**(4) Fair value measurements (continued)**

The following are descriptions of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the NAV/unit value of units of the common/collective trust fund. The NAV/unit value, as provided by the funds’ trustees, is used as a practical expedient for estimating fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust funds, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities’ liquidations will be carried out in an orderly business manner.

**(5) Related-party transactions and party-in-interest transactions**

Certain expenses are paid by the Plan to its trustee for investment management services. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in the fair value of investments.

Fees paid by the Plan to the third-party administrator for administrative functions amounted to \$98,820 and \$85,039 for the years ended December 31, 2024 and 2023, respectively.

### NOTES TO FINANCIAL STATEMENTS

**(6) Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**(7) Tax status**

The Internal Revenue Service ("IRS") has determined that the volume submitter basic plan document adopted by the Plan is designed in accordance with applicable sections of the IRC and informed Newport of such in a letter dated June 30, 2020. The plan administrator has adopted the volume submitter basic plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(9) Delinquent participant contributions**

For the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2024, untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$95,955, of which \$95,891 have been corrected by funding the lost earnings. As of the date these financial statements were available to be issued, the Company is in the process of correcting and funding the employee contributions and lost earnings related to the remaining \$64 untimely employee contributions. For the year ended December 31, 2023, untimely remittances identified on the Schedule of Contributions totaled \$589,582, which have been corrected by funding the lost earnings.

**(10) Subsequent events**

Management has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.
