NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 (Audited) AND 2023 (Compiled)

1. DESCRIPTION OF PLAN

The following brief description of the New York Structural Biology Center 403(b) Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan that covers substantially all employees of the of New York Structural Biology Center, Inc. (the Company) who meet certain eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is sponsored and administered by the Company. Empower Retirement, LLC (Empower), Teachers Insurance and Annuity Association (TIAA), and College Retirement Equities Fund (CREF) are the Plan's recordkeepers and custodians. As of November 2016, participants may not make or receive any new contributions to their TIAA accounts, but are able to maintain existing accounts with this company.

Eligibility

All full-time employees are eligible to participate in the plan on their first day of employment with Employer.

Contributions

The Plan allows participants to contribute up to 100% of their pretax annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants may also rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500. Participants may direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

The Plan allows for employer non-elective discretionary contributions for eligible participants upon reaching six (6) months of service. The non-elective contributions are set to 10% of the employee annual compensation, with the exception of certain key employees whose non-elective contribution is set at 15% maximum annual compensation allowed by the IRS.

Participant Accounts

The Plan Administrator maintains separate accounts in the name of each participant. Participants direct the investment of all contributions into various investment options offered by the Plan. All employee contributions and any earnings/losses thereon are credited to the participants' accounts. Participants are also charged with an allocation of administrative expenses. Allocations are based on participant earnings/losses or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions and the Company non-elective discretionary contributions plus actual earnings/losses thereon.

Payment of Plan Benefits

Upon termination of service due to death, disability, retirement, or other reasons, the normal form of payment is a lump-sum distribution. A participant may elect to receive his or her benefit payment in regular annual installments over a period not to exceed the participant life expectancy or partial payments. Benefits are recorded when paid.

In-service withdrawals are permitted for participants that have reached normal retirement age or they have incurred in a financial hardship.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from participant accounts. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

The Plan provides that participants may borrow the lesser of \$50,000 or 50% of their vested account balance, but not less than \$1,000. The loan shall be repaid by the participant on at least a quarterly basis, but not over a period greater than five years, unless the loan is taken for the purpose of purchasing a primary residence, in which case the loan may be repaid over a period not greater than 30 years. The loans are collateralized by the balance in the participant's account. The loans bear interest at a rate commensurate with local prevailing rates as determined by the investment provider in conjunction with federal regulations.

Forfeited Accounts

Forfeitures of non-vested account balances are used to reduce the employer contributions and/or to pay for administrative expenses. Unallocated forfeitures totaled \$79 and \$35 as of December 31, 2024 and 2023, respectively. No forfeitures in the amount were applied to reduce employer contributions for the years ended December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments are reported at fair value, except for fully-benefit responsive fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement- Definition and Hierarchy

GAAP establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued using closing quoted prices in active markets.

Pooled separate accounts: Separate accounts of TIAA invested in real estate properties and real estate investments and are valued based on external property appraisals and values obtained from independent pricing sources. Unit values are calculated daily.

Non-benefit responsive fixed annuity contracts: Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Annuity Contracts

The Plan also has fully benefit responsive fixed annuity contracts. TIAA maintains Plan contributions in separate accounts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit responsive investment contracts as contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate of interest of 3%.

Traditional Annuity Contracts

The Plan utilizes Group Retirement Annuity (GRA) GRA contracts allow lump-sum withdrawals within the 120 days of termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from GRA contracts must be spread over a period of 10 annual installments (or after termination over five to thirty years).

The Plan also utilizes an Empower General Account, which is a non-benefit responsive fixed annuity contract. The contract uses a discounted cash flow valuation methodology where the interest rate for the contract is reset at least as frequently as annually. There is a provision in the contract that prevents the immediate and full payout of the contract value sponsor-initiated transactions. Therefore, this investment will be classified as level 2 in Note 3.

Risks and Uncertainties

The Plan provides for various investment options in any combination of selected investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan documents.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

5. PARTY-IN-INTEREST TRANSACTIONS

TIAA, CREF and Empower were the insurance companies of the Plan. Empower held certain of the Plan's investments and served as custodian of the Plan. TIAA and Empower were the Plan's recordkeepers. As such, transactions between TIAA, CREF, Empower and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants qualifies as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a volume submitter plan offered by FIS Business Systems LLC stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the Internal Revenue Code. The volume submitter plan received an IRS Opinion Letter dated March 31, 2017, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
