INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Casa Colina, Inc. 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Casa Colina, Inc. 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of plan

The following description of the Casa Colina, Inc. 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Human Resources Department.

General

The Plan was established effective January 1, 2002 for employees of Casa Colina, Inc., Casa Colina Hospital and Centers for Healthcare, Casa Colina Centers for Rehabilitation Foundation, Casa Colina Comprehensive Outpatient Rehabilitation Services, Inc., Casa Colina Center for Rehabilitation, Inc., and Padua Village, Inc. (the “Company” or “Plan Administrator”). The Plan provides for benefits in the event of retirement, death, disability, and financial hardship. The Plan was amended and restated as of January 1, 2020.

Eligibility

Entry requirements for elective rollover and deferral contributions are not permitted for this Plan. For contributions other than rollover and deferral, the participant must complete 30 days of service and must be at least 21 years of age.

Contributions

The participant may make voluntary contributions up to the limit pursuant by law. Such limit is subject to change each year for cost of living adjustments. The Plan further provides that participants can make “catch-up contributions” under certain criteria, subject to Internal Revenue Service (“IRS”) limits. The Company approved contributions of \$662,893 and \$607,259 less forfeitures of \$87,893 and \$0 for the years ended December 31, 2024 and 2023, respectively for a net company contribution of \$575,000 and \$607,259, for the years ended December 31, 2024 and 2023, respectively.

Participant accounts

Each participant’s account is: (a) credited with their elective deferral contributions, an allocation of the Company’s matching contribution, investment income and gains/losses, and (b) charged with an allocation of administrative expenses as provided in the Plan document. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is fully entitled is the participant’s own contributions, rollover contributions, and transfers from other appropriate plans. For “all other contributions” a participant is entitled to the participant’s vested portions.

Vesting

Vesting under the Plan for “all other contributions” is based on a six-year graded vesting schedule. Full vesting occurs at the time of retirement, death, disability, or after completion of six years of qualified service. Each participant is credited with one year of service for each service period in which the participant has 1,000 or more hours of service.

1. Description of plan (continued)

Notes receivable from participants

Participants may borrow from their respective accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants' promissory notes are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50%. Participants' notes are for fixed terms, requiring bi-weekly repayments by payroll deductions and are valued at their amortized cost, which approximates fair value.

Termination provisions

While Casa Colina, Inc. has not expressed any intent to discontinue the Plan, this right has been reserved should future conditions warrant such action. If the Plan should be discontinued in accordance with the provisions of ERISA, participants will be fully vested in their accounts and will continue to receive increases or decreases as determined by the value of the investments under the trust agreement until participants receive a full distribution of their account balance.

Administration of the plan

A Plan Administrator, who is appointed by Casa Colina, Inc.'s Board of Directors, administers the Plan.

Effective January 1, 2017, the Company entered into a Retirement Plan Investment Advisory Services Agreement with a third party to act as a fiduciary and discretionary investment manager of the Plan as provided for in Sections 3(21)(A)(i) and 3(38) of ERISA and as a registered investment adviser under the Investment Adviser Act of 1940. The third party is not the custodian of the Plan assets.

Benefit payments and forfeitures

The Plan's policy is to make benefit payments under one of the following methods: (a) a single lump-sum cash distribution, or (b) purchase of an annuity. Participants forfeit the non-vested portion of their account balance if their termination of participation in the Plan is for reasons other than death, disability or retirement. Forfeitures not used to reinstate previously forfeited account balances of former participants that have been rehired can be used to reduce future employer contributions or pay for Plan expenses. At December 31, 2024 and 2023, the forfeited non-vested account was approximately \$5,797 and \$34,941, respectively, net of forfeitures used to reduce the employer contributions for the respective years.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

2. Significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Withdrawals

Participants may request hardship withdrawals from their account balance for certain financial needs, as defined in the Plan documents.

Investment valuation and income recognition

The investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 8 for a description of the fair value measurement and valuation methodologies used in determining the fair value of the Plan’s investments. Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred.

4. Tax status

The Plan adopted the Transamerica Retirement Solutions, LLC Volume Submitter 403(b) Tax Deferred Annuity Plan document. The Plan has obtained an IRS opinion letter dated March 31, 2017. There have been amendments to the Plan subsequent to the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable tax exempt requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants shall become fully vested in their account balances and the net assets of the Plan will be allocated to the participants in accordance with the terms of the Plan.

7. Guaranteed investment contracts

The Plan has a benefit-responsive guaranteed investment contract with New York Life Insurance Company (“NYL”). NYL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The interest crediting rate is based on the contract value, the fair value, duration, and yield to maturity of the underlying portfolio. The contract issuer determines the declared interest rate (portfolio rate) which will be credited to all monies invested in the Contract during the relevant period until the interest rate is reset. The crediting interest rate is reset semi-annually by NYL.

The contract does not contain any type of market value formula or provision, and the account does not have a maturity date. Participant distributions are paid at contract value. However, distributions due to employer initiated events, as defined in the contract, which exceed a certain percentage, may be subject to a 5% withdrawal charge.

The crediting interest rate for the years ended December 31, 2024 and 2023 for the contracts is as follows:

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the issuer’s ability to meet financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Company, (4) the failure of the trusts to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

8. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Cash*: Valued in US currency.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Transamerica Retirement Solutions Corporation is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services to related third parties amounted to \$90,255 and \$75,503 for the years ended December 31, 2024 and 2023, respectively.
