INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
American Louver Company Profit Sharing / 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of American Louver Company Profit Sharing / 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - American Louver Company Profit Sharing / 401(k) Plan, ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through July 16, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - American Louver Company, LLC ("American Louver") is the plan sponsor, employer and plan administrator. Scientific Developments, Inc. ("Scientific Developments") is a participating employer. Ascensus Trust Company is the directed trustee that holds custody of plan assets. Ascensus LLC, acting as the agent for Ascensus Trust Company, is the third party administrator, tax counsel that performs various compliance tests and investment agent that maintains investment and participant records. The Ascensus entities are collectively referred to as "Ascensus". Creative Planning LLC is the plan's investment advisor. An officer of the plan sponsor acts as a limited plan trustee.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Money market fund and mutual funds - Valued at the daily quoted market prices as reported by the fund. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective July 20, 1962 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan and receive employer matching contributions once they have completed one month of service and have reached age eighteen. An employee will be deemed a participant and allowed to enter the plan on the first day of each calendar month immediately following the date the plan's eligibility requirements are met. At that time, American Louver hourly production employees also become eligible to receive fixed hourly formula profit sharing contributions and American Louver salaried and non-production hourly employees become eligible to receive any discretionary formula profit sharing contributions. Scientific Developments employees, which are employees employed in the state of Indiana and Oregon, are not eligible to participate in either of the profit sharing programs.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 3% of compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Matching contributions may be made equal to a discretionary percentage, determined by the plan sponsor, of the employee's elective deferral contribution. The discretionary matching percentage was 100% of the first 1% followed by 50% of the next 2% in 2024 and 2023. The discretionary matching contribution on participant elective deferrals is made in conjunction with each pay period.
- d. Fixed hourly formula profit sharing contributions are made to American Louver hourly production employees on an annual basis equal to twenty cents multiplied by the participant's hours of service worked during the plan year. Fixed hourly formula profit sharing contributions were \$26,000 in 2024 and \$21,000 in 2023.

- e. Discretionary formula profit sharing contributions, determined by the plan sponsor, may be made to American Louver salaried and non-production hourly employees. To qualify for any such contributions, eligible employees also need to have completed 1,000 hours of service and be employed on the last day of the year to which the contributions relate. There were no such discretionary formula profit sharing contributions made in 2024 or 2023.
- f. Additional qualified nonelective contributions may be made at the plan sponsor's discretion. There were no such additional qualified nonelective contributions made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants terminated prior to January 1, 2023, began vesting in their employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vested at a rate of 20% for each year thereafter. All other participants begin vesting in their employer contributions and related earnings upon two full years of service, at which time they are 50% vested. The participant then becomes 100% vested after their third full year. Upon death or disability participants become 100% vested. Participants are always 100% vested in their elective deferral and rollover contributions and related earnings.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death or disability. Distributions are made in the form of a single lump sum, partial payments or installment payments. In-service withdrawals can commence upon attaining the age of 59 ½. Hardship withdrawals are not permitted.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid directly from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and non-participant directed charges for investment advisory and contract administrator fees. Certain non-participant directed charges are paid using forfeitures while other non-participant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts are first used to pay plan administrative expenses and then any remaining forfeitures would be reallocated amongst the participants as more fully described in the plan document. Forfeitures used to pay certain plan administrative expenses were \$38,000 in 2024 and \$19,000 in 2023. There were no forfeiture reallocations in 2024 or 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Notes receivable from participants - Participants can take out loans against their accounts with approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may have only two loans outstanding at any given time. As of December 31, 2024, the notes receivable from participants have various repayment schedules through June 2029 with interest from 5.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

4. INCOME TAX STATUS

The plan adopted an Ascensus LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor and Ascensus qualify as party-in-interest transactions. Direct fees paid by the plan to Ascensus were \$30,000 in 2024 and \$33,000 in 2023. In addition, Ascensus receives certain indirect compensation from mutual fund service providers that is used to reduce administrative and service fees that may otherwise have been charged to the plan by Ascensus.

Transactions involving notes receivable from participants also qualify as party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transactions of ERISA.

6. INFORMATION CERTIFIED BY ASCENSUS TRUST COMPANY

Management has obtained certifications from Ascensus Trust Company, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held for the plan and the fair values of such and notes receivable from participants as of December 31, 2024 and 2023;
- b. Interest and dividends from investments and net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2024 and 2023;
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023; and
- d. The reports of individual participant accounts as of and for the years ended December 31, 2024 and 2023.
