Note A – Description of Plan

The following description of Qualawash Holdings, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution safe harbor plan covering all employees of Qualawash Holdings, LLC and its participating employers (collectively, the “Company” or the “Employer”). The Plan was formed and adopted on December 15, 2009, and last restated January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees may participate in the Plan if they have completed 60 days of service and are age 21 or older. All employees are eligible to participate unless they are employed as a leased employee, a part-time employee, or a nonresident alien. Employees become participants on the first day of the month following the date they satisfy the eligibility requirements.

Effective January 8, 2024, everyone employed by Central CT Tank Fabrication and Truck Repair, LLC as of January 8, 2024 shall be 100% vested.

Administration

The Plan is administered by the Company. The Plan's assets for the year were maintained and administered by Empower Trust Company, LLC (the “Trustee”). The Plan's recordkeeping services, and maintenance of participant account records are managed by Empower Trust Company, LLC.

Transfers to the Plan

Effective January 1, 2024, the Plan was amended to authorize the merger of Polar Service Center 401(k), Boasso Global 401(k), and Linden Bulk and LBT Services, division of Odyssey Logistics & Technology Corp. 401(k) into the Plan. All the plan assets of Polar Service Center 401(k), Boasso Global 401(k), and Linden Bulk and LBT Services, division of Odyssey Logistics & Technology Corp. 401(k) were transferred into the Plan on December 31, 2023 amounting to approximately \$25,329,000; \$19,376,000 and \$10,971,000, respectively. In addition, participant loans totaling approximately \$912,000 related to the merger were reported as transfer to the Plan during 2024.

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

The Employer will make a safe harbor matching contribution equal to 100% of salary deferrals up to 2% of compensation, plus 50% of salary deferrals that exceed 2% but do not exceed 6% of compensation. Each Plan year, the Company may also elect to make a discretionary profit sharing contribution to the Plan for participants employed on the last day of the Plan year that have completed at least 1,000 hours of service. During the Plan year ended December 31, 2024, the Company did not make a discretionary profit sharing contribution.

Note A – Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contribution. Each participant's account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant's account. Allocations of Plan earnings or losses are based on each participant's investment fund balance in proportion to the total investment fund balance.

Vesting

Participants are vested immediately in their contributions, rollovers, and actual earnings or losses thereon. Participants are also immediately vested in Employer safe harbor matching contributions. Employees are 100% vested in safe harbor matching contributions after 2 years of service. Vesting in non-elective Employer contributions and Employer matching contributions is based on years of continuous service. A participant is 100% vested upon reaching normal retirement age, death, disability, or after four years of credited service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Loan terms can be up to five years. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Principal and interest are paid by payroll deduction in substantially equal payments over the life of the loan, with payments not less frequently than weekly.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution based upon terms of the Plan document.

Distribution of Benefits

Participants may be eligible to withdraw a portion of their vested account balances while employed by the Company if they are age 59 ½, disabled, requesting a Qualified Reservist Distribution or due to a qualifying financial hardship. Only participant elective deferral contributions may be distributed to a participant requesting a Qualified Reservist Distribution or to meet a qualifying financial hardship. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum cash payment, in equal monthly, quarterly, semiannual, or annual cash installments, or, upon retirement, in installments based upon the participant's life expectancy at the time of retirement.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to first reduce future Plan administrative expenses and then Employer contributions. During the year ended December 31, 2024, the Company used approximately \$0 to reduce Plan expenses and Employer contributions. The Plan had a forfeiture balance of approximately \$450,000 and \$129,000 as of December 31, 2024 and 2023, respectively.

Note B – Summary of Significant Accounting Policies

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan agreement, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as described in Note G. Quoted market prices are used to value investments. Shares of pooled separate accounts are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Pooled separate accounts: Valued at the net asset value ("NAV") provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at NAV provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, qualified institutions. As of December 31, 2024 and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Empower Trust Company, LLC, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The underlying standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the written form of the underlying prototype document is qualified under Section 401(a) of IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note F – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments were managed by the Trustee. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$358,000 during the year ended December 31, 2024.

As of December 31, 2024 and 2023, the Plan invests in guaranteed interest accounts (“the Funds”). The Funds are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As described in Note B, because the Funds are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the Funds. The investments are included in the financial statements at contract value as reported to the Plan by the Funds. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Funds' issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.
