INDEPENDENT AUDITOR'S REPORT

Participants and the Administrative Committee
Casa Colina, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Casa Colina, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Casa Colina, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of plan

The following description of the Casa Colina, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Human Resources Department.

General

Effective January 1, 2007, the Plan was restated from a money purchase plan to a profit sharing contribution plan for employees of Casa Colina, Inc., Casa Colina Hospital and Centers for Healthcare, Casa Colina Centers for Rehabilitation Foundation, Casa Colina Comprehensive Outpatient Rehabilitation Services, Inc., Casa Colina Center for Rehabilitation, Inc., and Padua Village, Inc. (the “Company” or “Plan Administrator”). The Plan provides for benefits in the event of retirement, death and disability. The Plan has been amended and restated as of August 1, 2021.

Eligibility

To become a participant in the Plan, an employee must be at least 18 years of age, complete a twelve-month period of service prior to a plan entry date of January 1 or July 1, and have worked at least 1,000 hours in such period.

Contributions

The Company’s contribution amount is discretionary and is recognized in the period for which it is declared. The Company approved contributions of \$650,000 and \$625,000 for years ended December 31, 2024 and December 31, 2023, respectively, less forfeitures of \$65,000 and \$30,000 for a net Company contribution of \$585,000 and \$595,000 for the years ended December 31, 2024 and 2023, respectively. Each participant’s account was credited based on the participant’s annual compensation. The participant must be employed on the last day of the year to be eligible for the discretionary contribution unless they satisfy certain normal or early retirement rules. The Plan does not allow voluntary contributions to be made by the Plan participants.

Participant accounts

Each participant’s account is: (a) credited with an allocation of the Company’s contribution, investment income and gains/losses, and (b) charged with an allocation of administrative expenses as provided in the Plan document. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested portion.

Vesting

Vesting under the Plan is based on a six-year graded vesting schedule. Full vesting occurs at the time of death, disability, after completion of six years of qualified service, after one attains the Plan’s early retirement age of 55 with completion of six years of qualified service or after one attains the Plan’s normal retirement age of 65.

Termination provisions

While Casa Colina, Inc. has not expressed any intent to discontinue the Plan, this right has been reserved should future conditions warrant such action. If the Plan should be discontinued in accordance with the provisions of ERISA, participants will be fully vested in their accounts and will continue to receive increases or decreases as determined by the value of the investments under the trust agreement until participants receive a full distribution of their account balance.

Administration of the plan

A Plan Administrator, who is appointed by Casa Colina, Inc.'s Board of Directors, administers the Plan.

Effective January 1, 2017, the Company entered into a Retirement Plan Investment Advisory Services Agreement with a third party to act as a fiduciary and discretionary investment manager of the Plan as provided for in Sections 3(21)(A)(i) and 3(38) of ERISA and as a registered investment adviser under the Investment Adviser Act of 1940. The third party is not the custodian of the Plan assets.

Benefit payments

The Plan's policy is to make benefit payments under one of the following methods: (a) lump-sum cash distribution, (b) purchase of an annuity, or (c) equal installments over a specified period of time. Participants forfeit the non-vested portion of their account balance if their termination of participation in the Plan is for reasons other than death, disability or retirement.

Forfeited accounts

Forfeitures not used to reinstate previously forfeited account balances of former participants that have been rehired can be used to reduce future employer contributions. At December 31, 2024 and 2023, the forfeited non-vested account was approximately \$69,501 and \$32,697, respectively.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Plan administrative expenses paid by the Plan totaled \$37,792 and \$36,127 for the years ended December 31, 2024 and 2023, respectively. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

2. Significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits

Benefits are paid directly by the trustee and are recorded when paid.

Withdrawals

Participants may request hardship withdrawals from their account balance for certain financial needs, as defined in the Plan documents.

Investment valuation and income recognition

The investments are reported at fair value and contract value. The Plan's custodians, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, Inc., certify the contract value of the guaranteed investment contract and the fair market value of all other investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 7 for a description of the fair value measurement and valuation methodologies used in determining the fair value of the Plan's investments. Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Information certified by the custodians

At December 31, 2024 and 2023, the Plan's investments were held by State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, Inc. (the "custodians"). 4. Tax status

The Plan obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

6. Guaranteed investment contracts

The Plan has a benefit-responsive guaranteed investment contract with New York Life Insurance Company (“NYL”). NYL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The interest crediting rate is based on the contract value, the fair value, duration, and yield to maturity of the underlying portfolio. The contract issuer determines the declared interest rate (portfolio rate) which will be credited to all monies invested in the Contract during the relevant period until the interest rate is reset. The crediting interest rate is reset semi-annually by NYL.

The contract does not contain any type of market value formula or provision, and the account does not have a maturity date. Participant distributions are paid at contract value. However, distributions due to employer initiated events, as defined in the contract, which exceed a certain percentage, may be subject to a 5% withdrawal charge.

The crediting interest rate for the years ended December 31, 2024 and 2023 for the contract is as follows:

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the issuer’s ability to meet financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Company, (4) the failure of the trusts to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

7. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- *Cash*: Valued in US currency.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Related party and party in interest transactions

Certain Plan investments are shares of mutual funds managed by Transamerica Retirement Solutions. Transamerica Retirement Solutions is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services to related third parties amounted to \$18,975 and \$17,378 for the years ended December 31, 2024 and 2023, respectively.

10. Subsequent events

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued. No subsequent events occurred which required disclosure.
