Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Management Services Network 401(K) Profit Sharing Plan and Trust (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Plan’s Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Plan’s Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Plan’s Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the financial statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Requested by ERISA

The supplemental schedules, Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1: Description of Plan

The following brief description of the Management Services Network 401(K) Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a prototype defined contribution plan sponsored by Management Services Network, LLC (the “Plan Sponsor”) for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was adopted on January 1, 2006, and was most recently restated effective July 1, 2024 to reflect provisions of the Plan in accordance with the CARES and SECURE Acts as well as other law changes. This restatement also reflects the new trustee, custodian, and recordkeeper for the plan.

The Administrative Committee, appointed by the Plan Sponsor, has responsibility for the administration of the Plan. For the period January 1, 2024 to July 11, 2024, Counsel Trust d/b/a Mid Atlantic Trust Company (“MATC”), as a qualified institution, served as the Plan’s trustee/custodian, Paychex Retirement Services served as the Plan’s recordkeeper, and 401k Generation provided certain plan advisory services. Beginning July 12, 2024 and forward, Lincoln Financial Group Trust Company, as a qualified institution, serves as the Plan’s trustee/custodian, and Lincoln Retirement Services Company serves as the Plan’s recordkeeper. Merrill Lynch provides investment services and Professional Pension Services, Inc. serves as the Plan’s third party administrator. Fees are charged for trustee, custodial, investment, recordkeeping and administrative services rendered.

Eligibility – Employees must be at least 21 years of age and have completed six months of service. Upon satisfying these requirements, participants will become eligible to participate on January 1 or July 1. These eligibility requirements are inclusive of long term part time employees as hours of service are not used in determining eligibility.

Contributions – Participants may elect to contribute, on a before tax basis, up to 92% of their eligible compensation not to exceed applicable Internal Revenue Code (“IRC”) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributory plans. The Plan Sponsor will make a safe harbor matching contribution equal to 100% of the participants’ salary deferrals that do not exceed 3% of compensation plus 50% of the participants’ salary deferrals between 3% and 5% of compensation.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the (a) employer’s contribution, (b) Plan earnings and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and in the employer’s safe harbor contributions and any earnings or losses thereon. Any forfeitures as a result of Plan error corrections are allocated to participant accounts in accordance with the Plan Agreement.

Investment Options – Upon enrollment in the Plan, a participant may direct employee and employer contributions in one percent increments in any of the investment options offered by the Plan, as chosen by the Administrative Committee. Participants may change their investment options daily.

Notes Receivable From Participants – Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 47.5 percent of their vested account balance. Loan terms range from 1 – 4.5 years. However, loans may exceed 4.5 years if used to acquire the principal residence of the participant. The loans are secured by the balance in the participant’s account and bear interest at a fixed rate equal to Prime plus 1.00%, (7.5% at December 31, 2024). Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – Participants will be entitled to receive a lump-sum, installment, or annuity distribution of their vested balances in the following instances: (1) upon termination of employment due to death, disability, retirement; (2) upon reaching age 59.5; or (3) upon incurring an approved financial hardship.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the trustee shall dispose of the Plan assets by distribution to participants and their beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments – With the exception of the Guaranteed Investment Contract (Note 4), the Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at a measurement date. For those investments stated at fair value, see Note 3 for a description of the valuation methodologies used to determine each investment’s respective fair value.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Tax Status – The prototype Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the prototype Plan was in compliance with the applicable requirements of the IRC. The Plan has been restated since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believed the Plan was designed and operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely would not be sustained upon examination by the IRS or state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Significant costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. These costs include legal, administrative, accounting and custodial fees. Certain investment management fees and administrative expenses are incurred and paid by the Plan. Other investment related expenses are included in net appreciation of fair value of investments.

Reclassifications – Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events – The Administrative Committee has evaluated all subsequent events that may qualify for disclosure through October 10, 2025, which is the date the financial statements were available to be issued. There are no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurement

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 2 Inputs to the valuation methodology include:

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed actively traded.

Collective investment trust ("CCT"): The unit value of the CCT is based on the published net asset value per share of the underlying investments held by the CCT. A detailed description of the valuation methodologies of the CCT can be found in the footnotes to the Putnam Stable Value Fund audited financial statements for the year ended December 31, 2023.

Guaranteed Investment Contract ("GIC") - The Plan holds an investment in the Lincoln Stable Value Fund ("Lincoln GIC"). The Lincoln GIC is a guaranteed general account provided under a group annuity contract and is deemed to be fully benefit-responsive. As such, contract value is the relevant measurement attribute for benefits attributable to the Lincoln GIC because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made to the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative fees. Lincoln Financial Group bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rate during each guarantee period.

Certain events might limit the ability of the Plan to transact at contract value with the Lincoln GIC. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.
