### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Exacta Land Surveyors 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the Exacta Land Surveyors 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all eligible employees of Exacta Land Surveyors, LLC (Plan Sponsor) and the following participating employers: Windrose Surveying & Land Services, LLC, Trueline Technologies, LLC, and Great Lakes Field Services, LLC (collectively referred to as the Company). Employees of the Company who are not leased employees who have completed 90 days of service are eligible and may enter the Plan as soon as administratively feasible after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Investment Committee (Committee) oversees governance of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective May 1, 2024, Empower Trust Company, LLC (Empower Trust) is the Plan's trustee, Empower Annuity Insurance Company of America (Empower Insurance) is the Plan's custodian, and Empower Retirement, LLC (Empower Retirement) is the Plan's recordkeeper.

#### *Contributions*

Each year, participants may elect to defer pre-tax from 1% to 100% of annual compensation up to the maximum contribution amount allowed by the law. The Plan allows for voluntary after-tax (Roth) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Prior to May 1, 2023, the initial deferral rate was 2% of eligible compensation.

The Plan allows for discretionary Company matching contributions and discretionary Company profit sharing contributions. For 2024 and 2023, the Company authorized a match of 50% of the first 4% of eligible compensation that a participant contributes to the Plan. There were no profit-sharing contributions authorized in 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. The discretionary Company matching and profit sharing contributions vest based on years of credited service. Participants are 50% vested after one year of credited service and fully vested after two years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes receivable terms range from 1 to 5 years. The maximum loan term for a primary residence loan is 15 years. The loans are secured by the balance in the participant's account. The loan interest rate is 2% over the prime rate, as defined. No participant may have more than one outstanding loan. Principal and interest is paid ratably through payroll deductions.

### ***Payment of Benefits***

Upon death, disability, retirement, or any other type of termination a participant may elect to receive a partial withdrawal or a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan provides for automatic rollover provisions. If the participant's account is between \$1,000 and \$5,000, the Plan may make an automatic rollover of the participant's vested interest in his or her account to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan may make an automatic lump sum distribution to the participant equal to the participant's vested interest in his or her account. Upon reaching age 59 ½, participants still in service may elect to receive distributions of their fully vested account balances. The Plan also permits distributions to participants who have a qualifying financial hardship.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,313 and \$719, respectively. These accounts will be used to pay Plan expenses or reduce future employer contributions. Forfeited non-vested accounts totaling \$6,329 and \$5,203 were used to pay Plan expenses during 2024 and 2023, respectively.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

### 3. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments, cash and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by BOK Financial, N.A., Empower Trust and Empower Insurance, qualified institutions.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and

Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

*Collective investment trusts:* Valued at the net asset value (NAV) of the units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. There are no unfunded commitments or significant restrictions on redemptions relating to these investments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The fund seeks to preserve the value of the investment at \$1.00 per share. The money market fund is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\*Certain investments are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient and have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliations of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

### 5. Fully Benefit-Responsive Investment Contract

On May 1, 2024, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Insurance totaling \$69,336 at December 31, 2024. Empower Insurance maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula established by Empower Insurance but may not be less than zero percent. The interest crediting rate is reset quarterly.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on Empower Insurance's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower Insurance. Such events include (1) a spin-off, (2) sale, (3) merger, or (4) termination of the contract. Upon occurrence of such events a market value adjustment or other withdrawal restriction may apply.

Either Empower Insurance or the Company may terminate the contract for any reason subject to a notice period of 75 days. Upon termination of the contract a market value adjustment or other withdrawal restriction may apply. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or Empower Insurance are probable of occurring.

### 6. Tax Status

On May 1, 2024, the Company adopted a non-standardized pre-approved profit sharing/money purchase plan with a cash or deferred arrangement sponsored by Empower Retirement. Empower Retirement received an opinion letter dated November 14, 2022, from the IRS stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the

Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Prior to May 1, 2024, the Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement sponsored by BOKF, N.A. (BOKF). BOKF received an opinion letter dated June 30, 2020, from the IRS stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan was amended since adopting the pre-approved plan document, the Plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### **8. Related Party and Party in Interest Transactions**

For the period May 1, 2024 to December 31, 2024, certain Plan investments were managed by Empower Insurance, the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions.

For the period January 1, 2023 to April 30, 2024 certain Plan investments were managed by BOK Financial, N.A. BOK Financial, N.A. was the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Empower Retirement provided certain administrative services to the Plan pursuant to a service agreement between the Company and Empower Retirement. Empower Retirement received revenue from mutual fund service providers for services Empower Retirement provided to the funds. This revenue was used to offset certain amounts owed to Empower Retirement for its administrative services to the Plan.
