Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Firelands Technology Ventures 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A - DESCRIPTION OF PLAN

The following description of the Firelands Technology Ventures 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Firelands Technology Ventures, LLC DBA Firelands Scientific (the Company, Plan Administrator, and Plan Sponsor) and all related employers, which includes Deaver Ohio LLC and Aron OH LLC for the years ended December 31, 2024 and 2023, and Tariff Labs LLC for the year ended December 31, 2023, who have completed three consecutive months of service. Participants can enter the Plan on the first day of the month following the completion of the service requirement. Employees who are nonresident aliens, leased, or covered by a collective bargaining agreement are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, Tariff Labs LLC established its own plan, Tariff Labs LLC 401(k), and is therefore no longer a participating employer of the Plan. As a result of this change, Plan assets totaling \$114,579 transferred out of the Plan to Tariff Labs LLC 401(k).

Contributions

Participants may elect to defer up to 100% of their compensation as defined by the Plan either on a pre-tax or Roth after-basis. Employees who have not declined participation or completed a salary deferral agreement as of the date of their eligibility to participate in the Plan will be automatically enrolled in the Plan with a pre-tax deferral rate of 1% invested in a fund designated by the Plan Administrator until changed by the participant. The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code).

The Plan provides for a safe harbor matching contribution of 100% of the first 4% of a participant's elective deferrals. The Plan also provides for a discretionary employer profit sharing contribution for participants employed on the last day of the Plan year who have completed three months of consecutive service during the Plan year. No discretionary employer profit sharing contributions were made for the year ended December 31, 2024. Furthermore, the Plan provides for other discretionary contributions. No other discretionary contributions were made for the year ended December 31, 2024. Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, as well as an allocation of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant account earnings, compensation, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions, rollover contributions, and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions and other discretionary matching contributions plus actual earnings thereon vest based on years of credited service after one year at a rate of 33% per year. Participants are fully vested in the Company's discretionary profit sharing contributions and other discretionary matching contributions after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances excluding after-tax deferrals, subject to certain Department of Labor (DOL) and IRS requirements. Notes receivable terms range from 1 - 5 years, or longer for the purchase of a primary residence. Notes receivable are secured by the vested balance in the participants' accounts and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon attaining age 59½ or upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account, or partial payments based upon the terms of the Plan document. If the value of the vested benefits credited to the participant's account is \$5,000 or less at the time of termination, the entire amount will be automatically distributed to the participant without the participant's consent. In the event of a mandatory distribution of amounts greater than \$1,000 but not exceeding \$5,000, the entire amount will be distributed in the form of a direct rollover to an individual retirement account as designated by the Plan Administrator.

Active participants may make hardship withdrawals from any fully vested participant accounts, subject to Plan provisions.

Forfeited Accounts

Forfeitures may be used to pay Plan administrative expenses and reduce the Company's employer contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023 were \$688 and \$464, respectively. Forfeitures in the amount of \$48 were used to pay Plan expenses during the year ended December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from Plan participants and related Company matching contributions are recorded in the year in which the employee's participant contributions are withheld from compensation. Any contributions attributable to the Plan year but not received by the trust by the last day of the Plan year are recorded as a receivable.

Contributions and Contributions Receivable (Continued)

The carrying amount of contributions receivable are assessed for the need to record a valuation allowance. The valuation allowance is an estimate derived from the Plan's historical losses of contributions receivable, adjusted for the Plan Administrator's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on the Plan Administrator's assessment as of December 31, 2024 and 2023, no allowances for contributions receivable were recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Income Taxes

The Company adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement which received an opinion letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.

NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

As of December 31, 2024 and 2023 the fair value of mutual funds (Level 1) was \$2,934,001 and \$2,305,280, respectively. Following is a description of the valuation methodology used for mutual funds at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds are valued at the net asset values of shares held by the Plan at year end as reported on the active markets in which the investments are traded.

The method described above may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements as of the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (The Standard) with a balance of \$7,355 and \$5,241 at December 31, 2024 and 2023, respectively. Contributions from the Plan are maintained in The Standard's general account. Under the contract, the Plan owns a promise by the issuer to repay the principal and to pay interest at crediting rates which are announced in advance and declared on an annual basis. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balances at contract value.

The repayment of principal and interest credited to participants in the Plan is a financial obligation of The Standard. The Plan's ability to receive amounts due is dependent on The Standard's ability to meet its financial obligations. The Standard's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of The Standard or otherwise.

NOTE E - GUARANTEED INVESTMENT CONTRACT (CONTINUED)

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and liberalization of Plan withdrawal or transfer rules. Upon the occurrence of these events, a market value adjustment or other withdrawal restriction may apply.

The Standard may terminate the contract with 30 days advance written notice for reasonable cause, which includes a failure of the Plan to abide by state or federal law, to render performance necessary to comply with the terms of the contract, to maintain total assets of at least \$25,000, or Plan disqualification. Upon termination of the contract by The Standard, a market value adjustment or other withdrawal restrictions, may apply. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their total participant account balances.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the investment in the funds of The Vanguard Group (Vanguard), an affiliate of Ascensus Trust Company, and related interest, and the payment of administrative expenses by the Plan. Such transactions are exempt from being prohibited transactions.

NOTE H - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS (CONTINUED)

Vanguard provides certain administrative services to the Plan. Vanguard received revenue for these services at crediting rates per investment ranging from 0.02% to 0.75% of the funds' balances as of December 31, 2024. These fees reduce the rate of return credited to the Plan for these investments and are netted within net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

NOTE I - DELINQUENT PARTICIPANT CONTRIBUTIONS

As required by ERISA Section 2510.3-102, the Company is required to segregate participant contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages.

During 2022, the Company did not remit timely participant contributions of \$148. The delinquent contributions for this late remittance, including lost earnings, were remitted to the Plan in September 2023.
