Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 PLAN DESCRIPTION

The following description of Cap America's ("Company") 401(K) Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was adopted January 1, 1995 with amendments to the Plan in January 2018, October 2019 and January 2022.

General

The Plan is a 401(k) salary-reduction plan covering all full-time employees of the Company, 18 years of age or older, who have one year of service as defined in the Plan's articles, provided they have worked at least 1,000 hours during the Plan year. Employees who qualify to become participants enter the Plan on January 1 or July 1. The Plan is subject to the provisions of ERISA.

Contributions

Each year, participants may defer a percentage of their eligible compensation (as defined by the Plan) on a pretax basis (i.e., salary reduction) up to a maximum allowed by law and limitations established by the IRS. Effective 1/1/22, the Company amended the Plan to allow Roth contributions. The Company makes matching contributions for eligible employees as follows: 100% of eligible employee contributions not to exceed 3% of participant compensation plus 50% of the amount matched employee contributions that exceed 3% but not to exceed 5%. The amounts may be a percentage of the participant's compensation or a discretionary dollar amount. The percentage or dollar amount must be on a uniform basis for all employees.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) plan earnings, and (c) charged with an allocation of any administrative expense. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant's contributed funds arising from salary reductions are fully vested. Vesting in the Company's contribution portion of each of their accounts is based on a graduated schedule beginning at 25% vesting after 1 year of continuous service and becoming fully vested after 4 years of service. The matching contributions made to satisfy the actual deferral percentage test safe harbor contribution requirements shall be fully (100%) vested. Additionally, employees are fully vested upon death, or total and permanent disability.

NOTE 1 PLAN DESCRIPTION (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in the investment options available through John Hancock Life Insurance Company. Participants may change their options at any time.

Loans Receivable from Participants

Participants may borrow from their fund accounts up to their respective vested interest in the Plan, with a minimum loan balance of \$1,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Loan Receivable from Participant fund. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits

Upon termination of service, due to death, disability, retirement, or termination of service for other reasons, and if the participant's vested account has never been more than \$5,000, it is paid in a single sum. The participant can also receive a partial withdrawal, provided the amount is at least \$1,000. If the participant's vested account is in excess of \$5,000, participants may elect to receive either a lump-sum amount equal to the value of their vested account balance, elect equal installments paid over a fixed period of time, or a series of flexible income payments based on life expectancy.

At December 31, 2024 and December 31, 2023, there were participants who withdrew from the Plan, either through termination or retirement with account balances that totaled \$368,205 and \$229,021, respectively.

Forfeited Accounts

At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$-0- and \$-0- respectively. These amounts were used to reduce employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, as certified by John Hancock Life Insurance. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The change in market value from year-to-year and the gain (loss) on sale of investments are reported as net appreciation (depreciation) for the pooled separate account.

Notes Receivable from Participants

Notes receivable are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses were \$66,360 for 2024 and \$53,859 for 2023.

NOTE 3 **CERTIFIED INVESTMENTS**

Plan management may elect to have an audit as permitted by ERISA Section 103(a)(3)(C). When management elects an ERISA Section 103(a)(3)(C) audit, the audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or an insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Title 29 U.S. *Code of Federal Regulations* (CFR) Part 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (*qualified institution*).

Certain information (as summarized below) related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds and U.S government securities: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund/Pooled separate accounts: Valued at the Net Asset Value per share of the underlying investment provided by such mutual fund, trust or portfolio as of the valuation date.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

In October 2017, the plan entered into a Group Annuity Contract with John Hancock Life Insurance Company. The investment options available under this contract will increase or decrease to reflect the investment experience of the sub-accounts. The Company does not guarantee these values. The Company may terminate this contract at any time by requesting a withdrawal of the balance of all accounts, subject to the provisions outlined in the contract and to the applicable riders in force at the time of termination of the contract, and there are no charges associated with termination of the contract.

NOTE 6 PARTIES IN INTEREST TRANSACTIONS

Cap America, Inc. pays certain administration and professional fees on behalf of the Plan, which are considered exempt transactions.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax exempt. The Plan has open tax years that remain subject to examination by major tax jurisdictions for periods after December 31, 2020.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
