### Scope and Nature of ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – PLAN SUMMARY AND DESCRIPTION:

The following description of the Pembina U.S. Corporation Wealth Accumulation Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Pembina U.S. Corporation, Pembina Prairie Pipeline USA Ltd., and Pembina Pipeline Corporation (collectively, the Company) who have at least three months of service. Once eligibility is attained, employees may enroll on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2025, the Plan was amended to remove the three month eligibility requirement.

Contributions

Each year, participants may contribute a percentage or flat dollar amount of up to 60% of eligible compensation, as defined in the Plan. Some or all of the participant's deferral contribution may be designated as a Roth deferral contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Participants direct the investment of their contributions, as well as the matching Company contributions and additional profit sharing contributions that may be contributed at the option of the Company's Board of Directors into various investment options offered by the Plan. The Plan currently offers several families of mutual funds and a self-directed brokerage account as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate.

The Company contributes 100% of the first 3% of eligible compensation contributed to the Plan and 50% of the second 3% of eligible compensation contributed to the Plan for qualified employees. Contributions are subject to certain IRS limitations. The Company made a safe harbor contribution in the amount of \$1,660,085 and other qualified nonelective contributions of \$2,363 for the Plan year ended December 31, 2024. The Company did not make a profit sharing contribution for the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the fair value of the participant's vested interest in his or her account, installment distribution in equal amounts over a period of time, or purchase of an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, or partial withdrawal of any portion of the vested balance. In-service distributions are also permitted prior to termination if certain age requirements are met. Hardship distributions are also permitted by the Plan, subject to a \$500 minimum distribution. Mandatory distributions for participants with vested balances of less than \$5,000 may be paid in a direct rollover to an individual retirement plan designated by the Plan Administrator.

Forfeited Accounts

Forfeited nonvested accounts totaled \$991 and \$37 at December 31, 2024 and 2023, respectively. These accounts may be used to reduce future employer contributions as directed by the Plan Sponsor. Forfeitures of \$26,587 were used to reduce employer matching contributions during the year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is reported on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan Administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the Plan's financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level inputs for the periods presented.

The following is a description of the valuation methodologies used for investments measured at fair value.

*Mutual Funds*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Self-Directed Brokerage Accounts*

The investments in these accounts consist of mutual funds, certificates of deposit, corporate stocks, and rights and warrants. The mutual funds held in these accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held in these accounts are deemed to be actively traded. The corporate stocks held in these accounts are based on the closing price reported on the active market where the individual securities are traded. The fair value of rights and warrants held within these accounts, are traded in active markets, and their fair values are determined based on quoted prices readily available on the open market. Mutual funds, corporate stocks and rights and warrants are classified as Level 1 investments.

The fair value of certain fixed income securities, including certificates of deposit, are based on observable market information and yields available on comparable securities of issuers with similar credit ratings and may include benchmarking, sector grouping, and matrix pricing and are classified as Level 2 investments.

NOTE 5 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (Fidelity) and its affiliates. Fidelity is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Some of these fees are included in net appreciation (depreciation) in fair value of assets as they relate to transaction fees.

At December 31, 2024, the self-directed brokerage account had shares of Pembina Corporation corporate stock valued at \$52,525. Investments in these securities represent party-in-interest transactions as defined by ERISA.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – TAX STATUS:

The Internal Revenue Service issued an opinion letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.
